**Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.**

This bill adopts the Athletic Trainer Compact for a licensing pathway to create reciprocity among participant states. Applicants under the Compact, licensed athletic trainers from other states, would be subject to criminal background check by Nebraska State Patrol. Additional work would be required by the Department of Health and Human Services (DHHS) within Program 178 – Professional Licensure if the compact is enacted (at least 7 states enact the compact into State law). Currently 7 states including Nebraska have pending legislation filed to enact the compact and no states have enacted legislation. Should the compact be enacted, DHHS would be required to share data that would necessitate a \$38,000 annual fee for data interfacing. There is no basis to disagree with this estimate however the timing of the expenditures depends on when a sufficient number of states enact the compact which is indeterminable at this time.

**Explanation of Estimate:**

LB736 Proposes the adoption of the Athletic Trainer Compact in Nebraska should at least seven (7) other states pass the model for the compact through legislation. Should the compact be enacted, the State will be required to share licensure data with the compact. This will be managed via the Evoke Licensure system hosted by SystemAutomation, which will be in production prior to the time when this data will need to be shared (scheduled to go live 8/11/2027). This will be an additional interface cost to the current three (3) interfaces provided per year as part of SystemAutomation's contract with the State. SystemAutomation charges \$38,000 per each additional standard interface, which the requested data will fall under.
