This bill permits, but does not require, law enforcement agencies to obtain, maintain, and possess epinephrine autoinjectors and requires the Department of Health and Human Services to approve one or more educational training programs for using such injectors. The estimated cost of developing and recording a training program and setting up a website to issue certification is approximately \$6,320 which can be absorbed within agency appropriations. There is no basis to disagree with this estimate. Because the provisions are permissive there is no fiscal impact to law enforcement agencies.

Explanation of Estimate:

The bill would allow law enforcement officers to carry an 'epi pen' and administer during anaphylaxis events as needed upon completion of DHHS approved training. There is no mention of the length of the training. The cost of the 'epi pens' would be at the expense of the individual law enforcement agency. The bill does not require all law enforcement officers to carry such devices therefore I'm unable to accurately predict what the cost to our agency would be as I do not know how many officers would participate in the program. A quick internet search listed such devices between \$100-\$700. The ongoing cost is unknown as 'epi pens' have glass components, are temperature sensitive and would need to be replaced every 12-18 months. It is unknown how often such devices would need to be replaced therefore difficult to calculate ongoing cost.

Explanation of Estimate:

LB 727 would authorize sheriffs and other law enforcement officers to obtain, maintain, and possess epinephrine autoinjectors for use by a law enforcement officer for use while in the performance of official duties and require training prior to administering an epinephrine autoinjector.

Since the legislation is permissive, the number of county sheriffs that would implement this legislation and require training is unknown; therefore, the fiscal impact cannot be determined.

Explanation of Estimate:

LB727 allows law enforcement agencies to obtain, maintain, and possess epinephrine autoinjectors and to administer the autoinjectors in an emergency situation.

LB727 directs the Department of Health and Human Services to research and approve educational training programs for these law enforcement agencies and to issue certificates of completion. The cost for a contract to develop and record a training program for online use is estimated to be \$5,000. In addition, DHHS IS&T web applications team costs are estimated to be \$1,320 to set up the site and issue certificates. The department will absorb these costs within existing appropriations.
