LB 755 would adopt the Emergency Service Peer Support Act and define covered emergency service agencies, employees, peers, and peer support sessions. The bill makes peer support session communications confidential and privileged, generally prohibiting disclosure and limiting their use in court or administrative proceedings. It includes specified exceptions, such as threats of future harm, mandatory reporting circumstances, and certain admissions of criminal conduct. The bill provides civil liability protection for peers acting in good faith, requires confidentiality policies for agencies that establish a program, exempts these records from public disclosure, and clarifies that participation is voluntary.
