LB 1080 allows unsworn declarations signed under penalty of perjury to be used in Nebraska civil cases instead of notarized affidavits, except for certain no-notice requests or where otherwise prohibited. It updates the civil affidavit statutes by defining affidavit and unsworn declaration requirements and repeals a separate affidavit section by moving those provisions into the revised definitions. The bill also expands perjury and false-statement laws to cover materially false statements made in these unsworn declarations, including specified attorney declarations.

There is no fiscal impact.
