This bill appropriates \$500,000 from the Health Care Cash Fund in FY27 to the Department of Health and Human Services (DHHS) Program 514, Public Health Aid, for state aid to Federally Qualified Health Centers to be distributed proportionally based on uninsured clients to expand access.

Note that the specified cash fund would not be able to sustain the appropriations without provision of additional funds.

Explanation of Estimate:

LB858 provides an additional \$500,000 per year for Federally Qualified Health Centers (FQHC) starting in Financial Year 2026-27. The additional funds from the Nebraska Health Care Cash Fund are to be used for expanded health care access in existing lines of service, adding new lines of service, adding new service locations, purchasing equipment, or completing capital projects. The Department of Health and Human Services' Division of Public Health will recalculate the amount of funding to be distributed to each FQHC in order to include the additional funds.

The legislature would need to increase the annual transfer to the health care cash fund or eliminate a separate earmark to accommodate this \$500K earmark.
