LB960 provides for student members on school boards.

Each school board will include student school board members on the school board in a number equal to the number of elected school board members on that school board.

Each school board will adopt procedures to select student school board members from the high schools. The selection procedures can include, but are not limited to, student elections, principal nominations, or applications & interviews. Any student selected to serve as a student school board member will, at the beginning of the student's term as a student school board member, be enrolled in good standing in grades ten, eleven, or twelve at the high school from where the student was selected.

On or before January 1, 2027, each school board will adopt the policies & procedures for student school board members to serve on the school board. Each student school board member will serve a one-year term. Each school board will determine if, & in what circumstances, a student can serve more than one term & will determine the beginning date of the term for the initial student school board members except that that date will be no later than the first day of the 2027-28 school year.
