LB 1020 creates new offenses and updates related statutes. The bill makes it a Class IIIA felony to install or use a mobile tracking device to track a person or their property without consent, including failing to remove the device after consent is revoked, with specified exceptions. It also creates the offense of swatting with tiered penalties based on resulting harm and requires restitution for response costs.

The bill prohibits operating an unmanned aircraft system in certain restricted areas without FAA approval and law enforcement notification and requires proof of FAA registration upon request. Finally, the bill removes the requirement that courts impose probation for Class IV felonies and makes related sentencing and appeal changes.

The Supreme Court states that there will be a minimal fiscal impact from LB 1020, but no additional resources are required.

The Nebraska Department of Correctional Services states LB 1020 could increase the incarcerated population. However, the number of additional inmates and the related costs are indeterminable at this time. The FY25 per diem cost was \$33.73 per incarcerated individual (\$12,309.72 annually).

**Explanation of Estimate:**

LB1020 provides for and changes offenses involving mobile tracking devices, stalking, unlawful intrusion, operation of unmanned aircraft systems, and swatting, and eliminates the requirement that courts impose probation for Class IV felonies. The bill could increase the number of persons in prison. The specific amount of impact is indeterminable.

The FY25 per diem cost was \$33.73 for each incarcerated individual, or \$12,309.72 per year.
