This bill requires the appointment of a dementia services coordinator within the Department of Health and Human Services at an unspecified date. DHHS indicates the annual cost of 1 FTE at the rate of a Program Specialist to be \$85,866 of which 50% can be federally funded. The fiscal impact depends when the coordinator is hired.

Explanation of Estimate:

LB913 requires the Department of Health and Human Services to appoint a dementia services coordinator to serve as a centralized point of contact for dementia-related services and supports. The bill would also authorize the collection and monitoring of additional dementia-related data to inform service coordination, planning, and policy development, which may expand upon data currently gathered by the Alzheimer's Disease and Other Dementia Advisory Council.

Assuming the effective date October 1, 2026, the total cost for adding an FTE in SFY26 and SFY27 would be \$61,333 and \$85,866, respectively.
