LB1119 updates the Age-Appropriate Online Design Code Act by expanding when an online service is considered to have knowledge of a user's age, broadening the types of design features covered by the Act, prohibiting one-step privacy downgrades and repeated prompts for minors to reduce privacy protections, and requiring a clear tool for minors to request account unpublishing or deletion within 15 days. The bill also maintains limits on data collection and use, profiling, targeted advertising, certain notifications, geolocation collection, prohibited product advertising, and dark patterns when the user is a covered minor.

There is no fiscal impact.
