LB1078 would adopt the Fair Online Pricing Act to limit how prices are generated and shown to consumers through an online device. It would prohibit setting a price based on device hardware or hardware state, the presence or absence of software, or geolocation data when used to price based on inferences about the consumer, with specific exceptions (device repair/maintenance, trade-in value, immediate real-time demand pricing, and legitimate location-based cost or tax differences).

The bill would allow public-facing coupons and discounts offered on the same terms if they do not use the prohibited data. Violations would be enforced by the Attorney General through civil actions, with civil penalties up to \$10,000 per violation.

The Supreme Court states the fiscal impact is minimal for judicial education, and no additional resources are needed. The Attorney General estimates no fiscal impact.
