LB1185 adopts the Conversational Artificial Intelligence Safety Act.

The bill requires clear disclosure when a user could reasonably believe they are interacting with a human and adds additional safeguards for minor account holders, including recurring AI disclaimers, limits on engagement-based rewards, and reasonable measures to prevent sexually explicit or sexualizing content and the system presenting itself as human or fostering emotional or romantic dependence.

The bill also requires a protocol to respond to prompts involving suicidal ideation or self-harm that includes referral to crisis services and prohibits the service from explicitly claiming it is designed to provide professional mental or behavioral health care.

The Nebraska Attorney General may enforce the act through civil actions, and the act does not create a private right of action. The act becomes operative on July 1, 2027.

The Attorney General states its office needs at least one additional full-time attorney to enforce the act, with estimated costs of \$252,468 in FY26-27 and \$255,923 in FY27-28. The Attorney General also notes that enforcement and litigation could require additional funding, depending on workload, and that technical or complex cases can involve significant expert witness costs, which may exceed \$100,000 per case.

The Supreme Court states the fiscal impact is minimal for judicial education, and no additional resources are needed.

Explanation of Estimate:

LB1185 would have a fiscal impact on the Attorney General's Office (AGO). The Conversational Artificial Intelligence Safety Act will require the AGO to hire at least one full-time attorney to enforce the Act. The AGO will likely need additional funding for its enforcement and litigation efforts, which could amount to a large volume of matters. For context, expert fees in technical or otherwise complex lawsuits often surpass \$100k in expert fees alone.
