Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB1176 adds new sections to Nebraska Rules of the Road for the protection of highway workers in Nebraska §60-3202. This bill defines a highway work zone and a speed control enforcement system. The bill allows for the speed control enforcement system to detect and record the speed plus obtain a clear photo or image of the rear license plate; only for vehicles which are exceeding the maximum lawful speed limit by 11 mph or more. This bill further states that if any workers are present in the highway work zone, then speed control enforcement systems may be used to enforce the maximum speed limit, as long as: a sign is placed at the entrance of the work zone informing of the system's use, and a clearly identifiable law enforcement vehicle and officer is present in or near the work zone. Additionally, this bill amends §60-3202(2) to clarify that automatic license plate reader systems do not include a speed control enforcement system under the Automatic License Plate Reader Privacy Act.

This bill would become effective three calendar months after the adjournment of the Legislature.

The Nebraska Supreme Court, the Nebraska Department of Motor Vehicles, the Nebraska Department of Transportation, and the Lincoln Police Department have all indicated no fiscal impact.

There is no basis to disagree with these estimations.

Explanation of Estimate:

LB1176 updates the Nebraska Rules of the Road by adding definition for "highway work zone" and "speed control enforcement system." The bill authorizes the use of speed enforcement systems to enforce speed limits in a highway work zone when proper signage is posted and a law enforcement officer is present in or near the work zone. The speed control system may only capture a vehicle's speed and image when the vehicle is traveling more than eleven miles per hour above the posted speed limit.

The bill also clarifies that an automatic license plate reader system does not include a speed control enforcement system as defined under the Nebraska Rules of the Road.

No fiscal impact to Nebraska Department of Transportation is anticipated.
