LB 1123 requires prosecuting agencies that maintain Brady-Giglio lists to adopt minimum procedures for placing an officer on a list, including written notice, an opportunity to provide input, a reconsideration process with timelines (including for officers already on a list), and a limited right to seek district court review under seal.

The bill also provides that an officer may not be disciplined or face certification action solely because the officer is placed on, considered for, or disclosed as being on a Brady-Giglio list, and it prohibits retaliation for exercising these rights. In addition, the bill limits public release of an officer's official photograph absent written permission or a public records request. It requires redaction of the specified officer's personal information before records are publicly released.

Finally, LB 1123 increases the penalty for impersonating a peace officer from a Class I misdemeanor to a Class IV felony.

The Supreme Court states that the fiscal impact on judicial education is minimal and that no additional resources are needed.

Nebraska Department of Correctional Services states LB 1123 could increase the incarcerated population due to the penalty change for impersonating a peace officer; however, the number of additional inmates and the related costs are indeterminable at this time. The FY25 per diem cost was \$33.73 per incarcerated individual (\$12,309.72 annually).

Explanation of Estimate:

LB1123 provides requirements relating to Brady-Giglio lists, protections for certain officers, and duties for prosecuting agencies and public safety agencies, and changes the penalty for impersonating a peace officer. The bill could increase the number of persons in prison. The specific amount of impact is indeterminable.

The FY25 per diem cost was \$33.73 for each incarcerated individual, or \$12,309.72 per year.
