LB 236 provides for an increasing amount of general funds and federal funds to be appropriated in 2009-10 through 2012-13 to fund services for persons on the waiting list for developmental disability services after their date of need for such services as of November 14, 2008. The funds will be appropriated to the Department of Health and Human Services to be distributed as aid for developmental disability providers.

A report pursuant to LR 156 was issued in December, 2008 addressing the waiting list for developmental disabilities. Contained in the report was an estimate of the funds needed to fully fund the waiting list for developmental disabilities. LB 236 proposes to fully fund the waiting list of persons, waiting past their date of need as of November 14, 2008, over a four year period. The bill provides for an additional \$32.5 million (50% General, 50% Federal) to be appropriated each year from 2009-10 through 2012-13 as follows:

The estimate in the report does not take into account any increase in rates for developmental disability providers, changes to the rate methodology or additional funds needed to start-up services, provide service coordination, or increase state level administrative staff. The waiting list estimate is based upon typical acceptance of service rates where 60% of requests for day service, 80% of residential requests, and 70% of requests for respite services are typically accepted, if funds are made available.

The bill also provides for a one-time general fund appropriation of \$150,000 in 2009-10 to contract for the development of a new rate methodology for services for persons with developmental disabilities.

Technical Note: The Department of Health and Human Services indicates the funding mix would need to be changed to reflect the current percentage of Medicaid eligible individuals receiving developmental disability services. The fund mix would change to about 45% general funds and 55% federal funds based upon current spending patterns.
