SUMMARY OF ENACTED BILLS

LB565/AM1314 (Bostelman) COMMITTEE PRIORITY BILL;

Adopt the Public Water and Natural Resource Project Contracting Act and the Nuclear and Hydrogen Development Act and change provisions relating to regional clean hydrogen hubs, public power and irrigation districts, and natural resources.

LB565 was passed and signed by the Governor with the following other bills and provisions:

The original Committee Amendment AM827 contained the following bills:

LB565 (Bostelman) in its original form amends §66-2301 to fund steps necessary to continue forward to compete for designation by the United States Department of Energy as a location for a regional clean hydrogen hub and directs appropriation of \$250,000 from the General Fund for FY2023-24 and \$250,000 for FY2024-25 to the Department of Economic Development for the purpose of providing grants to any public power district that serves a majority of the counties in the state to be used for engineering and modeling work to prepare and support the State's competitiveness for one of the regional clean hydrogen hub designations and associated federal funding. (Sec. 34 AM1314)

LB567 (Bostelman) amends §70-619 (district powers) to allow high level mangers employed by a district to not be disqualified from service on another district board. (Sec. 42 AM1314)

LB567 amends §70-1001.01 adds the word "reliable" and its definition to the statement that "In order to provide the citizens of this state with adequate electric service at as low overall cost as possible . . . " Section 70-1001 was drafted in 1963 with emphasis on "adequacy" in transmission. Since 1963, the term "reliable" has become more prevalent in the public and in the energy/electricity industry conversations. (Sec. 42-44 AM1314)

LB567 also amends the reporting requirements of the annual Load and Capability portion of §70-1025 (3), that requires that the representative organization include in its annual Load and Capability Report "such other information" that the Power Review Board (PRB) requests in writing, so long as the information requested is consistent with the Power Review Board's statutory responsibilities and that the inclusion of the requested information can be accomplished at a reasonable cost. (Sec. 45 AM1314)

<u>LB568</u> (Bostelman) as amended by AM357 creates the Nuclear and Hydrogen Development Act to support workforce development and advancement of advanced nuclear and hydrogen industries in Nebraska. The bill directs creation of a Nuclear and

Hydrogen Industry work group to recommend the workforce training needed of the nuclear and hydrogen industries in Nebraska and provide an opportunity for collaboration among the industries and higher education in the state to provide grants, training, curriculum, programming, and marketing to meet the workforce needs of the industry as identified by the work group. The Work Group is to consist of a representative of the Nebraska Community College System, a representative of the Nebraska state college system, two representatives of the nuclear industry, two representatives of the hydrogen industry, and the Director of Economic Development, all to be appointed by the Governor; along with the chairpersons of the Natural Resources, the Appropriations, and the Government, Military and Veterans Affairs Committees or their designees. The Nuclear and Hydrogen Development Act Fund is created to carry out the purposes of the Act. The Fund terminates on July 31, 2028. (Sec. 35-41 AM1314)

LB723 (Bostelman) at the request of the Governor, creates the Public Water and Natural Resources Project Contract Act. The Act enables the Department of Natural Resources to employ alternative methods of contracting for public water and natural resources public surface water or groundwater-related infrastructure projects, regardless of the funding source and governs the procurement process in the use of the additional methods.

The Act authorizes the department to solicit and execute three additional methods of contracting — design-build, progressive design-build, or construction manager-general contractor contracts for public surface water or groundwater-related infrastructure projects; authorizes the department to hire an engineering or architectural consultant to assist with the development of project performance criteria and requests for proposals and any additional services as requested by the department in relation to a project and precludes consultants used from providing services in a proposal for a project upon which they have consulted.

LB723 directs the department to obtain requests for qualifications and compile and publish a pre-qualified contractor list, and authorizes the use of public-private partnerships. The department is required to be responsible for oversight of any function that is delegated to or otherwise performed by a private partner and directs—the Director to adopt and promulgate rules and regulations setting forth criteria to be used in determining when a public-private partnership is to be used for a particular project. Finally, LB723 requires the department to annually report to the Natural Resources Committee regarding private-public partnerships which have been considered or are approved. (Sec. 1-20 of AM1314)

The following bills were amended into LB565 on Select File with AM1314:

LB217 (Hughes) extends the sunset date for new scrap tire projects under §§ 81-15,160 to 81-15,160, which is the Waste Reduction and Recycling Fund and authorizes that proceeds from the fees imposed under the Waste Reduction and Recycling Incentive may be used for costs of administration and to assist political subdivisions for creation and

modification of recycling systems and market development to enhance recycling. (Section 46 of AM1314)

LB289 (Bostelman) amends §18-2441 to grant the Municipal Cooperative Financing companies authority to maintain and service Advanced Metering Infrastructure (AMI) and offer cyber-security type services on behalf of public utilities members to provide savings for members and thus, ratepayers. (Sec. 21 of AM1314)

LB395 (Erdman) amends §57-904 to changes per diem compensation of members of the Nebraska Oil and Gas Conservation Commission from \$400 per day to \$500 per day and eliminates the \$6,000 annual cap and provides for automatic adjustment to reflect CPI on July 1 of add numbered years beginning July 1, 2025. (**Sec. 33 of AM1314**)

LB400 (Brewer) Amended by AM878 provides for the reduction of specific predators, including mountain lion year round by authorizing landowners, their tenants, or agent to destroy or have destroyed specific predators preying on livestock or poultry or suspected of causing other damage on their land. Authorizes the killing of a mountain lion if encountered in the process of stalking, killing, or consuming livestock on the person's property. Requires immediate reporting to Game and Parks and to aid in transfer to Commission. ((Sec. 31 of AM1314)

<u>LB425</u> (Bostelman) amends provisions of the Game Law found in Chapter 37 to define a quorum for the Commission meetings is five out of nine members instead of four out of nine members and raises the caps on fees for several nonresident hunting and fishing permit fees. The bill also expands the amount of land for a controlled shooting area from 2% to 5% of the county's total acreage; Clarifies that an auction permit for a mountain sheep does not count against the lifetime limit of one; allows elk to be hunted in state refuges if the population is deemed detrimental to the refuge. (Sec. 22-30, 32 of AM1314)
