## BILL SUMMARIES: BILLS ENACTED

### **LB 108      (Jacobson) Change contributions provisions under the Cities of the First Class Firefighters Retirement Act**

LB 108 amends the Cities of the First Class Firefighters Retirement Act to change contribution rates for both the city and firefighters in certain cities of the first class.

Under the bill, beginning March 1, 2025, each firefighter employed by a city of the first class with a population of more than sixty thousand in a county with a population of more than one-hundred thousand and covered by an absolute coverage group will contribute a sum equal to 6.5% of their salary to the retirement system.

Beginning March 1, 2025, each city of the first class with a population of more than sixty thousand located in a county with a population of more than one-hundred thousand which employs any firefighter covered by an absolute coverage group will contribute a sum equal to 13% of such firefighter's salary to the retirement system.

LB 108 contains the Emergency Clause.

---

### **LB 179      (Clouse) Change retirement contribution rates for police officers employed by cities of the first class**

LB 179 amends the Police Officers Retirement Act to change contribution rates for both the city and police officers in cities of the first class. Under the bill, beginning October 1, 2025, each police officer employed by a city of the first class will contribute a sum equal to 9% of their salary to their retirement system.

Under Nebraska Revised Statute §16-1006, each city of the first class which employs any police officer is required to contribute a sum equal to the amount contributed from such police officer's salary to the retirement system. As a result, LB 179 provides that beginning October 1, 2025, each city of the first class which employs any police officer will contribute a sum equal to 9% of such police officer's salary to the retirement system.

On General File, LB 179 was amended with AM 592, which incorporated the provisions of LB 461 (as amended by AM 426) into the bill.

LB 461, as amended, amends the Cities of the First Class Firefighters Retirement Act to provide that optional benefit forms available to firefighters in cities of the first class shall include a single lump-sum payment or one or more partial payments in an amount and frequency as elected by the firefighters.

The provisions of LB 461, as amended, contain an operative date of October 1, 2025.

---

**LB 295      (Nebraska Retirement Systems Committee) Change provisions relating to the County Employees Retirement Act, the Judges Retirement Act, the Nebraska State Patrol Retirement Act, the School Employees Retirement Act, the State Employees Retirement Act, the Spousal Pension Rights Act, and the Public Employees Retirement Board**

LB 295 is a “clean-up” bill introduced at the request of the Nebraska Public Employees Retirement Systems (NPERS). The bill amends various sections of statute governing state and county retirement plans administered by NPERS as well as statutes governing the Public Employees Retirement Board (PERB).

Changes contained in LB 295 include: 1) providing a process for the PERB board to waive repayment of retirement benefits if the board determines that those benefits were the result of an inadvertent overpayment; 2) updating eligible types of identification documents under the retirement systems statutes; 3) including the Class V school employees retirement system (OSERS) in the definition of statewide public retirement system under the Spousal Pension Rights Act; 4) including leave of absence pay in the definition of compensation under the School Employees Retirement Act; 5) codifying the formula currently used by NPERS to determine whether a school employee is considered full-time or part-time under the School Employees Retirement Act; 6) providing that lump-sum payments to multiple beneficiaries under the School Employees Retirement Act can be made independently of each other; 7) clarifying the definition of early retirement under the Class V School Employees Retirement Act; 8) providing that employees deemed full-time under the Class V School Employees Retirement Act remain full-time employees once they are deemed as such; 9) eliminating the 60-day deadline for beneficiaries to

elect a lump-sum distribution under the Class V School Employees Retirement Act; 10) ensuring that school employees who are members of the OSERS plan receive leave with pay to attend preretirement planning programs sponsored by the PERB board; 11) authorizing the PERB board to offer online preretirement planning programs; 12) clarifying appropriations language regarding actuarially required contributions under the Nebraska State Patrol Retirement Act; 13) clarifying that the vice-chairperson of the PERB board may call a meeting of the board; 14) allowing for mileage reimbursement for members of the PERB board; and 15) prohibiting the use of any name, logo, symbol, or similar name, logo, or symbol related to a state retirement plan in written solicitations to plan members without PERB board approval.

The committee amendment, AM 404, made several changes to the underlying bill and incorporated the provisions of LB 420 (as amended by AM 388) into the bill.

### **Changes to LB 295**

Changes made to LB 295 by the committee amendment include: 1) extending the retirement application deadline under the School Employees Retirement Act from 120 days prior to the effective date of the member's initial benefit to 270 days prior to the effective date of the member's initial benefit; 2) striking changes in the bill regarding actuarially required contributions to the Nebraska State Patrol Retirement Act; 3) clarifying language regarding inadvertent overpayments to provide that such overpayments may only be waived by the PERB board if the repayment would cause a significant hardship; 4) changing the 60-day deadline for beneficiaries to elect a lump-sum distribution under the Class V School Employees Retirement Act to a 90-day deadline, rather than eliminating the deadline; and 5) correcting a drafting error.

### **Provisions of LB 420**

LB 420, as amended, strikes language in Nebraska Revised Statute §24-703 requiring that state contributions to the Nebraska Retirement Fund for Judges occur by way of an administrative transfer by the State Treasurer.

The provisions of LB 420, as amended, contain the Emergency Clause.

On Select File, the bill was further amended with AM 797, a technical amendment which updated the list of eligible identification documents for

retirement plan purposes in another section of statute outside of the retirement statutes.

---

**LB 645      (Ballard, at the request of the Governor) Change provisions relating to the School Retirement Fund**

LB 645 amends the School Employees Retirement Act to provide for a gradual reduction in state contributions to the School Retirement Fund, contingent on the actuarially funded ratio of the fund. The currently required state contribution to the fund is an amount equal to 2% of the compensation of all members of the retirement system.

Under the bill, for each fiscal year beginning July 1, 2025, the state contribution to the School Retirement Fund would be:

- If the actuarially funded ratio is less than 92%, an amount equal to 2% of the compensation of all members of the retirement system;
- If the actuarially funded ratio is 92% or greater and less than 94%, an amount equal to 1.6% of the compensation of all members of the retirement system;
- If the actuarially funded ratio is 94% or greater and less than 96%, an amount equal to 1.2% of the compensation of all members of the retirement system;
- If the actuarially funded ratio is 96% or greater and less than 98%, an amount equal to 0.8% of the compensation of all members of the retirement system;
- If the actuarially funded ratio is 98% or greater and less than 100%, an amount equal to 0.4% of the compensation of all members of the retirement system; and
- If the actuarially funded ratio is 100% or greater, the state shall not be required to make a contribution.

Should the actuarially funded ratio decrease, the state contribution would automatically be increased accordingly in the following fiscal year.

The committee amendment, AM 876, struck the original provisions of LB 645 and replaced them with provisions providing for a gradual reduction in employee, employer, and state contributions to the School Retirement Fund, contingent on the funded ratio on the actuarial value of assets in the fund for the most recent previous year as reported to the Public Employees Retirement Board (PERB) pursuant to Nebraska Revised Statute §84-1503.



Under the amendment, for each fiscal year beginning with July 1, 2025, state contributions to the School Retirement Fund would be:

- If the funded ratio on the actuarial value of assets in the fund is less than 96%, an amount equal to 2% of the compensation of all members of the retirement system;
- If the funded ratio on the actuarial value of assets in the fund is 96% or greater and less than 100%, an amount equal to 0.7% of the compensation of all members of the retirement system; and
- If the funded ratio on the actuarial value of assets in the fund is 100% or greater, the state shall not be required to make a contribution.

Under the amendment, beginning July 1, 2025, employee contributions to the School Retirement Fund would be:

- If the funded ratio on the actuarial value of assets in the fund is less than 96%, 9.75% of employee compensation;
- If the funded ratio on the actuarial value of assets in the fund is 96% or greater and less than 98%, 8.75% of employee compensation;
- If the funded ratio on the actuarial value of assets in the fund is 98% or greater and less than 100%, 8% of employee compensation; and
- If the funded ratio on the actuarial value of assets in the fund is 100% or greater, 7.25% of employee compensation.

Employer contributions to the School Retirement Fund under AM 876 would continue to be coupled to employee contributions, and would continue to be set at the current 101% of employee contributions pursuant to Nebraska Revised Statute §79-958.

Should the funded ratio on the actuarial value of assets in the fund decrease, the respective employee, employer, and state contributions would automatically be increased accordingly in the following year.

AM 876 contains the Emergency Clause.

On Select File, the bill was further amended with AM 1108 and AM 1135.

### **Provisions of AM 1108**

AM 1108 clarified language regarding employee and employer contribution rates, providing that employee contribution rates would be

adjusted annually each July 1<sup>st</sup>. Employer contribution rates would continue to be set at 101% of employee contribution rates.

### **Provisions of AM 1135**

AM 1135 incorporated the provisions of LB 76 (as amended by AM 798) into the bill.

LB 76, as amended, changes survivor's benefits under the Nebraska State Patrol Retirement Act from a survivor's benefit equal to 75% of the plan member's benefit to a survivor's benefit equal to 100% of the plan member's benefit.

On Final Reading, LB 645 was returned to Select File for the adoption of a specific amendment, AM 1190.

AM 1190 made two changes to the bill. First, the amendment delayed implementation of the provisions of LB 76, as amended, until the following biennium starting on July 1, 2027. Second, the amendment clarified that the provisions of LB 645 do not impact state contributions to the Omaha School Employees Retirement System (OSERS).

## **BILL SUMMARIES: BILLS ON GENERAL FILE**

### **LB 76 (Bostar) Change provisions of the Nebraska State Patrol Retirement Act**

LB 76 makes two changes to benefits under the Nebraska State Patrol Retirement Act. First, the bill would change survivor benefits under the State Patrol retirement plan from a survivor's benefit equal to 75% of the plan member's benefit to a survivor's benefit equal to 100% of the plan member's benefit.

Second, beginning July 1, 2025, LB 76 would increase the cost-of-living adjustment (COLA) under the State Patrol retirement plan to the lessor of the percentage change in the Consumer Price Index or 4%. Currently, the COLA for members who joined the retirement plan prior to July 1, 2016 is the lessor of the percentage change in the Consumer Price Index or 2.5%, while the COLA for members who joined the retirement plan on or after July 1, 2016 is the lessor of the percentage change in the Consumer Price Index or 1%.

The committee amendment, AM 798, struck provisions increasing the COLA under the State Patrol retirement plan.

*Portions/Provisions of LB 76 were amended into LB 645.*

## BILL SUMMARIES: BILLS HELD IN COMMITTEE

### **LB 433 (Sorrentino) Exempt deputy directors and agency attorneys from the State Personnel System and change membership provisions under the State Employees Retirement Act**

LB 433 excludes state agency deputy directors and attorneys from the State Personnel System. Any deputy director hired after the effective date of the bill would serve as an at-will employee and have their salary fixed by the agency director and approved by the Governor. Any deputy director or attorney employed on the effective date of the bill could elect to be excluded from the State Personnel System and become an at-will employee.

LB 433 also amends the State Employees Retirement Act to allow temporary state employees who were previously members of the state employees retirement system and who return to state employment less than 120 days after leaving state employment to be rehired and begin participation in the retirement system within 30 days of returning as a temporary employee.

Finally, LB 433 clarifies that employees of the Legislature who are hired for a limited period of time or for a grant-funded position or a special project are considered temporary employees for purposes of the State Employees Retirement Act.

---

### **LB 571 (Cavanaugh, J.) Require cost-of-living adjustments for retirees for any public power district that operates a defined benefit plan**

LB 571 requires that beginning January 1, 2026, any public power district operating a defined benefit retirement plan shall pay a cost-of-living adjustment (COLA) equal to the annual COLA determined by the federal Social Security Administration to any retiree who is not eligible to receive social security benefits.

The Omaha Public Power District (OPPD) is currently the only public power district which operates a defined benefit pension plan.

**LB 661            (Andersen) Change provisions relating to the duties of the Nebraska Investment Council, the state investment officer, and the State Treasurer**

LB 661 requires that the Nebraska Investment Council (NIC) and the State Investment Officer, for any investments related to retirement systems administered by the Public Employees Retirement Board (PERB), not engage in investment activities and divest from all holdings and investment activity with restricted entities connected to the People’s Republic of China. The State Investment Officer would be required to provide semiannual written reports to the Nebraska Retirement Systems Committee and the Clerk of the Legislature regarding any investments related to retirement systems administered by the PERB board related to restricted entities connected to the People’s Republic of China.

LB 661 also requires that the State Treasurer create and publish a list of restricted entities connected to the People’s Republic of China on or before October 1, 2025 and update such list at least every six months.

LB 661 contains an operative date of July 1, 2025 and contains the Emergency Clause.

---

**LB 689            (Lonowski) Redefine terms under the School Employees Retirement Act and the Class V School Employees Retirement Act**

LB 689 amends the School Employees Retirement Act and the Class V School Employees Retirement Act to eliminate restrictions on substitute or volunteer service that can be provided by retired plan members during the 180-day period following termination or retirement to establish a bona fide separation of service. Currently, retired plan members can only provided substitute or volunteer service for eight calendar days per month during the 180-day separation period.

---

**LB 713            (Ballard) Change provisions of the School Employees Retirement Act**

LB 713 eliminates the definition of “prior service” under the School Employees Retirement Act.

The bill was introduced as a placeholder bill in the event that changes to any retirement plan administered by the Public Employees Retirement Board (PERB) were necessary during the 109<sup>th</sup> Legislature.

## BILL SUMMARIES: BILLS INDEFINITELY POSTPONED

### **LB 420 (Nebraska Retirement Systems Committee) Change provisions relating to the Public Employees Retirement Board**

LB 420 changes the minimum experience requirements for at-large members of the Public Employees Retirement Board (PERB) by increasing the years of experience required in the field of actuarial analysis or the administration of employee benefit plans from five years to ten years.

The bill was introduced as a placeholder bill in the event that changes to any retirement plan administered by the PERB board were necessary during the 109<sup>th</sup> Legislature.

The committee amendment, AM 386, is a white-copy amendment that replaces the bill.

AM 386 strikes language in Nebraska Revised Statute §24-703 requiring that state contributions to the Nebraska Retirement Fund for Judges occur by way of an administrative transfer by the State Treasurer.

AM 386 contains the Emergency Clause.

*Portions/Provisions of LB 420 were amended into LB 295.*

### **LB 461 (Juarez) Change provisions of the Cities of the First Class Firefighters Retirement Act**

LB 461 amends the Cities of the First Class Firefighters Retirement Act to require that optional benefit forms available to firefighters in cities of the first class also include annual payments, quarterly payments, and monthly payments of the firefighter's retirement value. Currently, the only required optional benefit form under the Act is a single lump-sum payment.

The committee amendment, AM 426, provides that optional benefit forms available to firefighters in cities of the first class shall include a single lump-sum payment or one or more partial payments in an amount and frequency as elected by the firefighter.

AM 426 contains an operative date of October 1, 2025.
