Mr. President, I have new A bills. (Read LB 653A for the first time by title. LB 285A for the first time by title. Read

The A bill is \$7,643, '89-90; and \$6,518 in 1990 and '91, and it's to redesign some forms, printing some forms, some postage and some supplies. I would ask your support for the A bill.

SPEAKER BARRETT: Any discussion? Seeing none, all in favor the advancement of the bill to E & R please vote aye, opposed nay. Have you all voted? Record, Mr. Clerk.

CLERK: 27 ayes, 0 nays, Mr. President, on the advancement of LB 231A.

SPEAKER BARRETT: LB 231A is advanced. LB 285A.

CLERK: LB 285A, Mr. President, is offered by Senator Lamb.

SPEAKER BARRETT: Senator Lamb.

SENATOR LAMB: Mr. President and members, you may remember this bill, LB 285, was advanced the other day without opposition. It's a bill that has to do with complying with the federal mandates in regard to licensing of truck drivers. And you will remember in the explanation that we did our best to keep the costs as low as possible, yet to comply with the federal mandate. As a result of our negotiations, under the terms of the bill the cost of a driver's license for these selected truck drivers would increase from the present \$10.00 to \$20.00 each four years and those provisions have been accepted by the industry. So this bill reflects the federal funds that will be coming as a result of this program which you can see the first year is \$336,580. Those are federal funds; \$78,000 from state That's the additional \$10.00 per licensee, the estimate funds. of the amount that will come, plus another \$3,000 from the self-inspection system. The subsequent years the state involvement is somewhat similar and I would ask that the A bill be advanced.

SPEAKER BARRETT: Any discussion? If not, those in favor of the advancement of the bill, please vote aye, opposed nay. Record, please.

CLERK: 28 ayes, 0 nays, Mr. President, on the advancement of 285A.

SPEAKER BARRETT: LB 285A is advanced. LB 338A.

CLERK: LB 338A, Mr. President, by Senator Wesely. (Read title.)

SPEAKER BARRETT: Senator Wesely, please.

SENATOR WESELY: Thank you, Mr. Speaker. LB 338 is the Community Public Health Services Act. It's a bill introduced by the Health and Human Services Committee. It's on Final Reading. This A bill would fund that act and I think we have discussed it already on the floor on both General and Select File. I would move for the advancement of the bill.

SPEAKER BARRETT: Thank you. Discussion? Senator Haberman.

SPEAKER BARRETT: Thank you. To the next priority bill, LB 714. Mr. Clerk.

CLERK: Mr. President, LB 714 was a bill that was introduced by Senator Lamb, Senator Bernard-Stevens, Hefner, Robak, Smith and Conway. (Read title.) The bill was introduced on January 19, referred to the Revenue Committee. The bill was advanced to General File. I have committee amendments pending by the Pevenue Committee, Mr. President.

SPEAKER BARRETT: Chairman Hall, on the committee amendments.

SENATOR HALL: Thank you, Mr. President, members, Mr. Clerk, the amendment that I have is an amendment to the committee amendments?

CLERK: Mr. President, thank you, yes. Your Committee on Judiciary whose Chair is Senator Chizek, to whom was referred LB 465 instructs me to report the bill back with the recommendation it be advanced to General File; LB 552, General File; LB 554, General File; LB 565, General File; LB 579, General File; LB 719, General File with amendments; LB 769, General File with amendments; LB 108, indefinitely postponed, as is LB 484, LB 553, LB 626, LB 699, LB 806, all those indefinitely postponed. Revenue Committee reports LB 707 to General File with amendments and LB 581, General File with amendments. Those are signed by Senator Hall as Chair. New resolution, LR 66 by Senator Rogers. (Read summary of resolution.) That will be laid over. Lobby report for this week, Mr. President. Amendments to be printed, Senator Lamb to LB 285A, Senator Wehrbein to LB 431. And, Mr. President, I have motions from Senator Warner, as Chair of the Appropriations Committee, regarding introduction of a new bill and a rules suspension accompanying that. Both of those will be laid over. That's all that I have, Mr. President. (See pages 1406-10 of the Legislative Journal.)

to LB 281, several people have had some problems with that, and LB 281, at this point, we are seriously considering holding over till next session so that we can deal with this problem. We are...science is getting ahead of the law, and we have a problem of electronically transmitted convictions and how to deal with that where you do not have a certified abstract of that conviction. Now there is some language in here on several pages here, but the amendment would delete the language which would give the Director of Motor Vehicles the authority to certify that this electronically transmitted information was a true abstract. So we are going to go back to the old system which we currently have where each abstract of a conviction has to be certified because we are not comfortable with our current language, and as I mentioned, we discussed this considerably in regard to LB 281. So the amendment would strike the language which would not require the abstracts of convictions to be certified. So at some future time, we are going to deal with this problem of electronic transmission of those abstracts, but at this point, we are not comfortable with it and so we would ask that that part of the bill be deleted.

SPEAKER BARRETT: Discussion? If not, those in favor of the adoption of the amendment vote aye, opposed nay. Record.

CLERK: 25 ayes, O nays, Mr. President, on adoption of Senator Lamb's amendment.

SPEAKER BARRETT: The amendment is adopted.

CLERK: I have nothing further on the bill, Mr. President.

SPEAKER BARRETT: Senator Lindsay.

SENATOR LINDSAY: Mr. President, I move that LB 285 as amended be advanced to E & R Final.

SPEAKER BARRETT: You have heard the motion to advance LB 285 to E & R for Engrossment. Those in favor say aye. The ayes have it, carried. The bill is advanced. To the A bill, Mr. Clerk, LB 285A.

CLERK: Mr. President, I have no E & R. I do have an amendment to the bill by Senator Lamb.

SPEAKER BARRETT: Senator Lamb, please.

SENATOR LAMB: Yes, Mr. President and members, we are adding about \$228,000 to the A bill. The A bill will be increased from the current \$78,000 to \$306,100. This is to start us on the way toward computerization. We need to get started on that and we believe we should start now. The reason for this increased General Funding is the amendment earlier to LB 285, which calls for the Department of Motor Vehicles to provide the license examiners the capability in the field to complete the national information checks on commercial driver's license applicants, and an examiner which has this capability will be able to approve issuance of the permanent commercial driver's license by the county treasurer and the need to provide a temporary license pending approval of the permanent license from DMV will no longer exist. So with this additional funding, we can get away from the temporary driver's license. We can provide the information out there to those counties so that they can issue the permanent license immediately, and that has several advantages, as you can understand. A much cleaner way to do it, it is going to have to come sooner or later, so that is the reason for the extra \$228,000.

SPEAKER BARRETT: Discussion. Senator Hall.

SENATOR HALL: Thank you, Mr. President. Just a question of Senator Lamb, if he would respond.

SPEAKER BARRETT: Senator Lamb.

SENATOR LAMB: Yes.

SENATOR HALL: Senator Lamb, Howard, is this just a one-time appropriation that buys the hardware?

SENATOR LAMB: This is about a \$180,000 for hardware, and about \$130,000 for transmission.

SENATOR HALL: Is that transmission cost then going to be a yearly cost that would be built into the budget yearly?

SENATOR LAMB:

SENATOR HALL: Okay, thank you.

SPEAKER BARRETT: Senator Pirsch.

SENATOR PIRSCH: Senator Lamb, there are federal funds that are involved in this, is that correct?

SENATOR LAMB: There are iederal funds involved in the whole program but not specifically for this purpose, is my understanding.

SENATOR PIRSCH: Not for the addition, for the amendment, then?

SENATOR LAMB: Not for this hardware, this computerization we are talking about here.

SENATOR PIRSCH: And that was an extra, how much, again?

SENATOR LAMB: The total of what we are talking about, a total of \$228,100.

SENATOR PIRSCH: Just for hardware and ...

SENATOR LAMB: No, \$180,000 for hardware, and the other \$130,000 is transmission cost that we are going to have to absorb continuously as we get into the electronic transmission of data.

SENATOR PIRSCH: For ...

SENATOR LAMB: ...ever.

SENATOR PIRSCH: Well, I mean, these are, what, for stations across the state?

SENATOR LAMB: Oh, we will have. well, we will have, each county will issue licenses. Now under the system that we are starting with, in most counties they will have a temporary because they don't have the capability to instantaneously check nationwide, with DMV or nationwide about whether this person has other convictions in other states or whether he is eligible for a license. So they issue the temporary license. Then they mail the information down to Lincoln to the DMV. DMV checks it out, and sends it back, and when it gets back, then the county treasurer will issue the permanent license. In the meantime, that driver has been using this 30 day temporary license. Now one of the amendments that was adopted earlier stated that, though some counties are computerized now and can handle it, so the amendment would allow

those counties to immediately bypass the temporary license, go directly to the permanent license.

SENATOR PIRSCH: But we are talking about transmission, that would be the transmission cost between counties?

SENATOR LAMB: Between the counties and...

SENATOR PIRSCH: ...and the main...

SENATOR LAMB: ...and DMV.

SENATOR PIRSCH: ...general computer then?

SENATOR LAMB: I believe so, yes.

SENATOR PIRSCH: That is time on computers then?

SENATOR LAMB: Yes.

SENATOR PIRSCH: Okay, I still don't understand but I will check on it. Thank you.

SPEAKER BARRETT: Any other discussion? If not, shall the amendment offered by Senator Lamb be adopted? Those in favor vote aye, opposed nay. Record,

CLERK: 25 ayes, 0 nays, Mr. President, on the adoption of Senator Lamb's amendment.

SPEAKER BARRETT: The amendment is adopted.

CLERK: I have nothing further on the bill, Mr. President.

SPEAKER BARRETT: Senator Lindsay.

SENATOR LINDSAY: Mr. President, I move that LB 285A as amended be advanced to E & R Final.

Mr. President, confirmation reports from the Transportation Committee. (See page 2192 of the Legislative Journal.)

Senator Moore offers LR 160. (Read brief description of LR 160.) LR 161 is a study resolution by Senator Moore, as is LR 162, LR 163 and LR 164. Senator Pirsch offers a study resolution, LR 165. Senator Lynch has LR 166, study resolution. LR 167 is offered by Senator Hefner. (Read brief description of LR 167.) LR 168 by Senator Wesely. (Read brief description of Study resolutions, LR 169 by Senator Wesely, LR 170, LR 171 and LR 172. (See pages 2192-2202 of the Legislative Journal.)

Mr. President, I have amendments to be printed to LB 285A by Senator Lamb. (See page 2202 of the Legislative Journal.) That's all that I have, Mr. President.

PRESIDENT: LB 352.

Mr. President, LB 352 is on General File. It was introduced by Senator Abboud. (Read title.) The bill was introduced on January 11, referred to the Government Committee, advanced to General File. I have committee amendments pending by the Government, Military and Veterans Affairs Committee, Mr. President. (See page 779 of the Legislative Journal.)

PRESIDENT: Senator Baack, did you want to take the committee amendments? Can you do that in your uniform?

SENATOR BAACK: Yes.

PRESIDENT: All right.

SENATOR BAACK: Yes, Mr. President and colleagues, the...we're on LB 352. The committee amendments simply change the appeal time limit. The time limit in the bill was originally written at 20 days. We changed that to 30 days to make it consistent with all of the other appeal processes, otherwise we would have...I think it could be confusing to the people involved if it was...this is the only one that would be 20 days, all the rest of them are 30 days. So we simply changed that 20 to 30 days. Thank you.

SENATOR WITHEM: Okay, okay. Thank you for that. As I understand your amendment to 285, it is just to make 285 consistent when and if LB 352 passes. So, the discussion that the three of us have been having maybe is more appropriate over So, I appreciate your...and I think your amendment probably is...needs to get adopted to LB 285, so I will be supporting it. Thank you very much.

SPEAKER BARRETT: Thank you. Shall the amendment to 285 be adopted? Those in favor vote aye, opposed nay. Please record.

30 ayes, 0 mays, Mr. President, on the adoption of the amendment.

SPEAKER BARRETT: The amendment is adopted. Senator Abboud.

SENATOR ABBOUD: I move to readvance it.

SPEAKER BARRETT: The question is the readvancement of the bill. All in favor say aye. Opposed no. Ayes have it, motion carried, the bill is readvanced. Before going to the A bill, Mr. Clerk, I'd like to announce that Senator Abboud does have some visitors in the north balcony, five students from Ralston Middle School with their guidance counselors. Would you folks please stand and be recognized. Thank you, we're glad you could spend a little time with us this morning. Mr. Clerk.

Mr. President, Senator Lamb would move to return LB 228A, I'm sorry, LB 285A to Select File for a specific amendment. Senator Lamb's amendment is on page 2202.

SPEAKER BARRETT: Senator Lamb.

SENATOR LAMB: Mr. President and members, the modifications, the amendment to the A bill merely reflects the delay for one year in the implementation date. I do have a marked up copy of A bill, which I could go through, if there are questions.

SPEAKER BARRETT: Any questions? Any discussion? Senator Haberman.

SENATOR HABERMAN: I wonder if Senator Lamb would yield to a question, please.

SPEAKER BARRETT: Senator Lamb.

SENATOR LAMB: Yes, sir.

SENATOR HABERMAN: Senator Lamb, I noticed on the green sheet that this is a \$1,500,000 bill, and I have an amendment up there to postpone the first payment of...or the first General Fund of 308,000 a year. Would you...which is your amendment I'm doing, as I understand, is that correct?

SENATOR LAMB: Yes, that part of that \$306,100 is stricken.

SENATOR HABERMAN: Well your...but then you're putting everything off one year, that's what you're...

SENATOR LAMB: Yes, that's correct.

SENATOR HABERMAN: Would you mind explaining, if you would, please, why this is costing over a million bucks.

SENATOR LAMB: Well, much of it is federal funds. In the amendment...

SENATOR HABERMAN: No, we have General Funds, Senator Lamb, on the green sheet. We have federal...General Funds of \$1,500,000. If you look on the back of the green sheet, under LB 285, it shows a four-year expenditure of \$1,500,000 and I...I am questioning, what's it for?

SENATOR LAMB: Well, the increase in fees is included in that.

SENATOR HABERMAN: That's doesn't... that's \$75,000.

SENATOR LAMB: Yeah.

SENATOR HABERMAN: Seven hundred and fifty people at \$10 apiece, but I am concerned, I would like to, if you can tell me what all that money is for.

SENATOR LAMB: Well, we're going to have to have computer... computerization in the counties to make this workable, Senator. In the A bill, you may notice that there's...in the original A bill, there's \$422,000 from federal funds for the first year. That will be reduced 313,000, and there is a \$228,816 General Fund amount which, of that, \$78,000 is for the...from the increased license fees. And then from July 1, 1990 to June 30,

1991, there's 247,000 federal fund amount.

SENATOR HABERMAN: Well, Senator Lamb, are you telling me that the \$1,500,000 is for computers? What is the money for? I'm just reading off the green sheet and they show that total and from '89-90 through '92-93. I am not opposing your bill. I'm trying to find out....

SENATOR LAMB: Okay, Senator, I'm trying to sort it out here for you. We do have eight additional examiners and a couple of auditors that will be included in that total.

SENATOR HABERMAN: Well, they're not going to cost that kind of money, I don't think, Senator Lamb.

SENATOR LAMB: What else is in there? Well, there will be something over 100,000 for communication costs from the counties, I'm informed.

SENATOR HABERMAN: Well, so what you've come up with then for the 1.5 million is 10 more examiners and \$100,000 for what?

SENATOR LAMB: I'm sure there are some other costs in there that we could trace down for you, Senator. I don't have them right here at my fingertips...

SPEAKER BARRETT: One minute.

SENATOR LAMB: ..but would be happy to visit with you about that issue.

SENATOR HABERMAN: Well, then would you mind holding the A bill up until you get that information?

SENATOR LAMB: Well, I don't thank that's necessary at this time, Senator.

SENATOR HABERMAN: Well, it's a little unusual, Senator Lamb, for you to get up and ask us to spend \$1,500,000 and for us not to know what it is. I mean it's usually the other way around; is you're the one that's questioning instead of me questioning you. I just wanted to bring to the attention of the body that the A bill on 285, on the green sheet, reads \$1,500,000. I am just trying to find out what the money is for. I have been told it's for a computer program. I have been told it's for 10 more

employees; Senator Lamb says eight more employees. This is on a...the licensing is on a four-year cycle. Every four years they're going to have to get a new license.

SPEAKER BARRETT: Time.

SENATOR HABERMAN: I'm not through, but that's all right.

SPEAKER BARRETT: Thank you. Any other discussion? Senator Haberman.

SENATOR HABERMAN: Every four years they're going to get a new license, so this means that out of these 7,500 licenses, if it's split up anywhere near into force, we're saying that it's going to cost originally \$308,000, the next year it's \$262,000, then the next year it goes to \$482,000, and then the next year it goes to \$500,000. So as we roll these licenses over every four years or every whatever it is, it should come down. It shouldn't go up. So I would like to and I am raising this question and evidently we can't get an answer at this time as to exactly what the money is for and I, for one, I, for one, am not going to vote to spend \$1,500,000 when we don't have the answers as to what it's for. I just can't do that. I agree with the program. We've taken care of the school buses. We've taken care of some of Senator Beyer's problems, but we haven't taken care of where this money's going to be spent. So, with those remarks, Mr. President, I will close and thank you for your attention.

SPEAKER BARRETT: Thank you. Any other discussion? If not, shall the bill be returned to Select File? Those in favor vote aye, opposed nay. Record.

CLERK: 26 ayes, 5 nays, Mr. President, on the motion to return the bill.

 $\ensuremath{\mathsf{SPEAKER}}$  BARRETT: The bill is returned. Senator Lamb, on the amendment.

SENATOR LAMB: Yes, Mr. President, Senator Haberman has raised some questions which, if you turn to the backside of the green sheet, you'll see \$308,000 in Fiscal Year '89-90; \$262,940, Fiscal Year '90-91; \$482,989 in '91-92; \$500,974 in the fourth year. He is adding all those together and coming up with a million whatever, a million eight, whatever it is, and, of

course, that certainly is what it costs over those...that four-year period. Now, as we mentioned, there are eight new examiners, a couple of new auditors that are going to be necessary. There are going to be some computer costs, communication costs, and it is going to cost three...well, amended bill is going to be slightly different than this because it's delayed, but there are going to be costs in that order to implement this program. Now, you know, you talk about adding those altogether and that certainly is an appropriate way to do if you want to see what the costs are over a four-year period. However, when you add more employees it does...it does add to the cost in subsequent years, so we're talking about the same costs, primarily the same costs being repeated year after year. That's about all I can say about it at this point. You can also see what the increased revenue from the extra \$10 on the fee will bring in. First year, they're estimating 78 thousand, and then 75 thousand, and then 78, and then 75. But it is a program that costs some money and when you add new employees that money is something that has to be paid every year that the program is in effect and that, in a nutshell, is what the program will cost and these changes to the A bill at this point are just reflecting the fact that the program will go into effect a year It just delays some of those costs somewhat.

SPEAKER BARRETT: Senator Haberman.

SENATOR HABERMAN: Well, Mr. President, members of the body, Senator Lamb has been touching very heavily on new employees, new employees. Well, if you take eight new employees, as he said, and you divide it into \$300,000, that's roughly \$40,000 per employee. Then Senator Lamb is saying that those salaries are going to go up from \$300,000 to \$500,000 in four years, so those same employees, instead of getting \$40,000 a year, are roughly going to get 50 or 55 thousand dollars a year, and they're examiners. That's what he...they're examiners. Well, I can't... I don't buy the fact that the big cost of this is the eight employees. He mentions computers. I would like to see it spread out. Who's buying the computers? How are they going to use the computers? Where are the computers going to be established? Those are questions that we should know before we vote on this A bill. We know in the past that computers has cost this body millions and millions of dollars, and there are some questions as to how they're being used; are they returning our investment. So I would like to know who's going to get computers, the computers, who's going to use them, where are

they going to find the room for them, where are they going to put the eight employees, and just exactly what these costs are. Thank you, Mr. President.

SPEAKER BARRETT: Thank you. Any other discussion? Lamb, would you care to close?

SENATOR LAMB: Well, Mr. President and members, I do have a sheet here in my hand which breaks down all these costs which I'd be happy to circulate and it's from the Fiscal Office on the Department of Motor Vehicles and it does break down all the and in Fiscal Year...I could just read a few of them: Fiscal Year '89-90, and we have expenditures, expenditures administrative assistant, one full-time, FTE, 26,000; driver's license examiners, eight FTE, \$24,420; benefits, \$10,084, for a total of \$60,504. So then we have this whole sheet and I'll just circulate it so you can see it and...because there are no secrets here and we'll...we will make this readily available and, in the meantime, I'd hope that you would adopt the amendment and readvance the bill.

SPEAKER BARRETT: Thank you. The question is the adoption of the Lamb amendment to LB 285A. All in favor vote aye, opposed nay. Please record.

CLERK: 29 ayes, no nays, Mr. President, on adoption of the amendment.

SPEAKER BARRETT: The amendment is adopted. Senator Lamb.
