SENATOR BECK: Yes, Mr. President, I would. I move that we adjourn until next Monday morning at nine o'clock and that is February 6.

PRESIDENT: Thank you. You've heard the motion. All in favor

SPEAKER BARRETT: LB 157 is advanced. LB 360.

CLERK: Mr. President, 360 by Senators Wesely and Smith. (Read title.) The bill was introduced on January 11, referred to the Health Committee, advanced to General File. I have no amendments to the bill, Mr. President.

SPEAKER BARRETT: Senator Wesely.

SENATOR WESELY: Thank you, Mr. Speaker, and members, just a brief explanation and then Senator Smith will follow in the opening. The bill deals with two subject matters. One deals with burial expenses allowed under Medicaid. Currently, that's \$3,000. This is the amount you retain in assets to cover your burial expenses when you go on Medicaid. The cost of burials have gone up dramatically and the \$3,000 now allowed is woefully inadequate. This bill would increase the 3,000 to \$4,000 this year and then in two years it would go to \$5,000 so that we could allow these individuals who do go on Medicaid adequate resources to have a proper burial. In addition, the bill deals with the subject of personal care allowance in care facilities. Right now we allow \$30.00 to individuals a month to retain in terms of income that they have. The rest of their income then goes toward the expense of their care. This bill would increase from \$30.00 to \$45.00 the amount of personal care allowance that we provide. That's a quick summary of the bill and I will give the rest of my time to Senator Smith.

SPEAKER BARRETT: Senator Smith, please.

SENATOR SMITH: Thank you, Senator Wesely. Mr. Chairman and members of the body, I will also be very brief. The bill is...and Don has already told you what the provisions of the bill would be and I would just use some examples. I'm in and out of the nursing home in Hastings a lot, and I will just tell you, very personally, I have had a father-in-law there. You've heard me mention about the fact that he was there for a period of time before he passed away, and now my mother-in-law is there. And so I do visit often, and I have a lot of contact with the other folks that reside in that nursing home and a lot of phone calls from them. And one of the biggest concerns that they have is that presently they're only allowed \$30 personal needs allowance for their...all the personal kinds of needs that

they may have, and that includes clothing, shoes, anything that they do with cutting hair, fixing hair, which...and Kleenex, all those special kinds of things that they might have to have. It simply does not reach any longer. Thirty dollars a month does not cover basic needs that they may have. So what we are asking here is an increase from \$30 to \$45 allowance for them. The second part, dealing with the burial expenses, again I can tell you first hand that we did have a set-aside for my father-in-law, the \$3,000 that is allowed today does not cover the cost. And we could give you an itemization of actual costs, for just an average funeral, which were given to us in the hearing. But what it comes to is that we all know about inflation, and \$3,000 does not pay the cost of a funeral today. So we're asking for an allowed increase in that set-aside also. I would be glad to answer any questions, if you have any. But simply it is that and I guess that we see a real need there, and I'm sure that some of you have had experiences the same way as we have with those folks in the nursing homes and in the case of the burial needs. So we would just ask for your support in the advancement of the bill. Thank you.

SPEAKER BARRETT: Thank you. Discussion, Senator Pirsch, followed by Senators Rod Johnson and Schellpeper.

SENATOR PIRSCH: Thank you. I have a question perhaps of Senator Wesely, if...did you draft the bill, Senator Wesely?

SPEAKER BARRETT: Senator Wesely, please.

SENATOR WESELY: Yeah.

SENATOR PIRSCH: You had mentioned the former sum was \$30, and I don't see that in the statute that has been deleted. Is that in statute, or is that just a rule and regulation?

SENATOR WESELY: That's a rule and reg that the Social Services Department (interrupted).

SENATOR PIRSCH: Okay, so we are putting it into statute then for the first time, that personal allowance.

SENATOR WESELY: Um-huh, yeah.

SENATOR PIRSCH: Okay, thank you.

SPEAKER BARRETT: Senator Rod Johnson.

SENATOR R. JOHNSON: Mr. President, members, I rise to support Senator Wesely's bill. I was approached by some morticians in my district prior to the session beginning. And they showed interest in this issue in particular with the section that deals with Medicaid individuals and raising the fee up to \$5,000. I think Senator Smith covered many of the points I wanted to cover, but they had approached me about sponsoring a bill. But when they heard that Senator Wesely was working on this issue as well, I deferred to him, and I'm pleased to see the bill has made it to the floor and will be discussed here today and hopefully advanced. I think it is a necessary change that needs to be made. I support it wholeheartedly. I think it will be a benefit to all parties involved by making these recommended changes.

SPEAKER BARRETT: Thank you, sir. Senator Schellpeper, followed by Senator Smith.

SENATOR SCHELLPEPER: Thank you, Mr. Speaker and members. I would like to ask Senator Smith a question, please.

SPEAKER BARRETT: Senator Smith, would you respond.

SENATOR SMITH: Yes.

SENATOR SCHELLPEPER: I think that this bill is a very good idea, and I think it's a very even figure, except for maybe the \$5,000 in '91. Would you have any problem with an amendment to lower that down to maybe 4,000?

SENATOR SMITH: Not four....I think we're asking 4,005, aren't we, initially, in the increase? Four thousand, okay, so you're saying keep it at 4,000, is that....

SENATOR SCHELLPEPER: Yes, leave it at four.

SENATOR SMITH: I guess that I don't like the idea particularly, Senator Schellpeper, but I also think that if we can give the increase for \$1,000 more that....At this point in time, yes, I would, if that is the condition for passing the bill I would still support it, based on that. But what is going to happen is that over time we're going to be back, within a few years, asking for another increase. And that is my only concern.

SENATOR SCHELLPEPER: I guess one of the problems that I have with it is, if you leave it at 5,000, or the increase to 5,000, eventually you're going to have the figure higher for welfare than you have for other burials. I think maybe it should be at 4,000. I think that's a very even figure and realistic. I would probably put a motion or amendment up for that, if that would be okay.

SPEAKER BARRETT: Thank you. Senator Smith.

SENATOR SMITH: No, not right now.

SPEAKER BARRETT: Thank you. Any other discussion on the advancement of the bill? Any closing comment, Senator Wesely?

SENATOR WESELY: No, I'd just move for advancement. We'll work with Senator Schellpeper on his amendment.

SPEAKER BARRETT: Thank you. The question is the advancement of LB 360 to Enrollment and Review Initial. Those in favor vote aye, opposed nay. Have you all voted? Have you all voted? Please record.

CLERK: 25 ayes, 0 nays on the advancement of 360, Mr. President.

SPEAKER BARRETT: LB 360 is advanced. Anything to read in, Mr. Clerk?

CLERK: Not at this time, Mr. President. Mr. President, 360A, introduced by Senator Wesely. (Read title.)

Mr. President, a new resolution, LR 38 by Senator Lindsay and Senator Hartnett. (Read brief explanation. See pages 918-19 of the Legislative Journal.) That will be laid over.

Mr. President, an Attorney General's Opinion addressed to Senator Lynch regarding LB 595. (See pages 919-21 of the Legislative Journal.) An announcement, Mr. President, Senator Hall has selected LB 262 as his priority bill for this



CLERK: I have nothing further on the bill, Mr. President.

SPEAKER BARRETT: Senator Lindsay.

SENATOR LINDSAY: Mr. President, I move that LB 441 as amended be advanced.

SPEAKER BARRETT: Shall LB 441 as amended be advanced? Those in favor say aye. Opposed no. Carried. The bill is advanced. LB 360.

CLERK: Mr. President, LB 360 on Select File, I do have E & R amendments, first of all, Senator.

SPEAKER BARRETT: Senator Lindsay.

SENATOR LINDSAY: Mr. President, I move that the E & R amendments to LB 360 be adopted.

SPEAKER BARRETT: Shall the E & R amendments be adopted? All in favor say aye. Opposed nay. They are adopted.

CLERK: Mr. President, Senator Schellpeper would move to amend the bill. The amendment is on Journal page 893.

SPEAKER BARRETT: Senator Schellpeper.

SENATOR SCHELLPEPER: Thank you, Mr. Speaker, and members. First of all, let me say that this amendment is not the amendment that we discussed on General File. Then we were talking about taking the \$5,000 out altogether. This amendment does not do that. In talking to my mortician over the weekend from my local town, he said that what we should probably do is just set the date back of the \$5,000, and that is what we are doing. We are setting the date back from 1991 to 1993, and I don't think there would be any problem with that, but what we are really doing is just leaving the \$5,000 in there, but just putting the implementation date back to 1993.

SPEAKER BARRETT: Thank you. Discussion on the Senator Schellpeper amendment? Senator Wesely.

SENATOR WESELY: Thank you, Mr. Speaker, members. Senator Smith and I are the sponsors of the bill. We did talk to Senator Schellpeper since General File, and though we have talked to

funeral directors that we have been working with on this legislation, they do not support the change. And in reality, it is a compromise. It is not totally eliminating the \$5,000 figure. It does delay one year, only. In our estimation, it is a reasonable effort to compromise, and we are willing to do that with Senator Schellpeper, so we would support the amendment.

SPEAKER BARRETT: Thank you. Senator Dierks.

SENATOR DIERKS: Mr. Speaker and members of the body, I am rising in opposition to the amendment. I have had some conversation with the director of the funeral...Funeral Directors Association and I guess it is his opinion that they would like not to support this amendment, and so for that reason, I would oppose it, plus the fact that I think that we had an adequate hearing and it was accepted at the hearing time, and I just would rise in opposition to the amendment. Thank you.

SPEAKER BARRETT: Thank you. Senator Smith.

SENATOR SMITH: Thank you, Mr. Speaker, members of the body. I, along with Senator Wesely, also will support this amendment. As he said, this is a piece of legislation, originally the intent was that it would have been, first of all, to \$4,000, and then the following year to \$5,000. There is some feeling on the part of other people that this is quite an increase in a very short period of time, and we definitely would not want to convey to people just to raise prices just because they know that in another year this is going to be their opportunity to increase those prices. So for this reason, even though it does...I guess as far as I am concerned, whether they like it or not, they are getting an increase, and they may not be getting exactly what they want when they want it, but it certainly is a lot better than we presently now...presently provide for. So for that reason, I am going to support the Schellpeper amendment. Thank you.

SPEAKER BARRETT: Thank you. Any other discussion on the amendment? Senator Schellpeper, would you care to close?

SENATOR SCHELLPEPER: Thank you, Mr. Speaker, and members. Let me say again that my local mortician is the one that brought this to my attention in the first place, and he said that he thought the \$5,000 was really too high, but that he would go

along with the extension of the date out further. And so that is the reason that I put the amendment on. I just think, like Senator Smith, that if you are going to raise it, I have no problem raising it, but let's put it out just a couple more years. Thank you.

SPEAKER BARRETT: Thank you. The question is the adoption of the Schellpeper amendment to LB 360. Those in favor vote aye, opposed nay. Voting on the Schellpeper amendment. Have you all voted? Senator Schellpeper. I'm sorry, Senator Schellpeper.

SENATOR SCHELLPEPER: Mr. Speaker, I guess I would call for...have a call of the house.
