SPEAKER BARRETT: Thank you, Mr. Clerk. The question before the body is one of adjournment. Those in favor of adjourning please vote aye, opposed nay. Have you all voted? Record, Mr. Clerk.

CLERK: 12 ayes, 22 nays, Mr. President, on the motion to adjourn.

SPEAKER BARRETT: Motion fails. Back to discussion on the advancement of the bill. Senator Baack.

SENATOR BAACK: Are there others lights after mine?

SPEAKER BARRETT: I'm sorry, yes, there are. Senator Baack, I'm sorry, I overlooked one light. Senator Withem's light has been on.

SENATOR WITHEM: Yes, I was going to call the question.

SPEAKER BARRETT: The question has been called. Do I see five hands? I do. Those in favor of ceasing debate vote aye, opposed nay. Record.

CLERK: 25 ayes, 1 nay, Mr. President, to cease debate.

SPEAKER BARRETT: Debate closes. Senator Baack.

SENATOR BAACK: I think we've debated enough. I would just urge the advancement of the bill. Thank you.

CLERK: 26 ayes, 0 nays, Mr. President, on adoption of LR 52.

PRESIDENT: LR 52 is adopted. LB 53.

CLERK: Mr. President, LR 53, offered by Senators Chizek, Beyer and Abboud, on page 1139 of the Journal, congratulates the Millard South boys basketball team for winning the Class A state basketball title.

PRESIDENT: Senator Chizek, please.

SENATOR CHIZEK: As the Clerk said, this resolution honors the Millard South boys basketball team, the 15th team to win back-to-back Class A titles since the tournament began in 1911, and undefeated this total season. I would ask the body...urge their support of the resolution. Thank you.

PRESIDENT: Thank you. The question is the adoption of the resolution. All in favor vote aye, opposed nay. Record, Mr. Clerk, please.

CLERK: 22 ayes, 0 nays, Mr. President, on adoption of LR 53.

PRESIDENT: LR 53 is adopted. We'll skip LR 55, since Senator Bernard-Stevens is not here. LR 56, please.

CLERK: LR 56, by Senator Haberman, Mr. President, is on page 1166, congratulates the Perkins County High School basketball team for winning the Class C-2 boys basketball championship.

PRESIDENT: Senator Haberman, please.

SENATOR HABERMAN: Mr. President, members of the body, Perkins County High School is also known as Grant, Nebraska, U.S.A. Grant, Nebraska, U.S.A. football team also won the state championship this year and Grant, this year, won the C-2 basketball tournament of the state. They were defeated once

this year, only once did they lose a ball game, and fellow members that was to the Imperial Longhorns. I want you to be sure and notice that that was what happened, they lost one game to Imperial, but they were the champions in football and basketball, and, quite frankly, I think they're going to win basketball next year again. PRESIDENT: Senator Wehrbein, please.

SENATOR WEHRBEIN: Mr. President, members, thought this was appropriate to call this to your attention today, seeing how this is National Ag Day, and there will be a resolution on that a little later, so I won't get into the importance of Ag Week, which I know all of you recognize. But I thought it was important to call to your attention today that this particular individual, Marlan and Mary Johnson, were the national award winners, one of four chosen in the United States, as the National Outstanding Young Farmer award, sponsored by the Jaycees. I can't recall how long it's been since there's been one...another one from Nebraska, but this is truly a very prestigious award, and I think it only appropriate to pass this resolution in his honor. I understand he will be here today in the Capitol to receive the award presented to him by the Governor because of some conflict previously before. So he will be here this afternoon. He's from Waverly, Nebraska, within my district, and I just would appreciate honoring him in this manner today.
