So the counties already have this protection. This merely extends that protection to cities that may, for some reason, acquire a bridge from a county. It is a very logical bill. It is one that was passed, of course, without dissent in the committee. I would ask that it be advanced.

SPEAKER BARRETT: Thank you. Any discussion? Seeing none, those in favor of the advancement of LB 1077 please vote aye, opposed nay. Have you all voted? Record.

We have in the statute books, if a high school falls below 25 students for three consecutive years they will be closed by the state. Some high schools have abused that privilege by counting foreign exchange students in their count for keeping the count above the 25 students. This would prohibit that. It doesn't address any of the other things that are used for foreign exchange students, only this one section of statute calling for the count for membership for staying open. With that, I would just urge the body to advance the bill. Thank you.

SPEAKER BARRETT: Thank you. Any discussion? Seeing none, those in favor of the advancement of LB 1037 please vote aye, opposed nay. Have you all voted? Record, please.
