Every now and then we say, okay, fine, I will draft it and we'll introduce it. My guess is for everyone of those, you have got two or three bills that are suggested to you that you say I don't think it will work or I would rather not carry that. Best of luck, maybe you have got another avenue, but, in fact, we can't take that ... I am not going to take that problem on. Maybe we don't do it enough but we do it. But imagine a Legislature in which any person in the State of Nebraska could provide us a bill idea that we would have to draft into bill form, hold a public hearing on, have a debate on this floor, and then write our decisions as a body, not just our own individual

We have in the bill that they have to buy back during a specific time period, July 1, 1990, through July 30, 1990, or six months. Officers who have already retired cannot buy the years back. Mr. President, I ask for the advancement of the bill.

In other words, what we're trying to do is the back windows, nothing to do with the passenger windows or the front window, but these back windows that some of the vans and so-called mini buses that are coming out would not comply with it or just trying to fix it up so those are legal and the state patrol was basically signed off. Maybe they didn't really like it, but they understand. A lot of pickups, even on the farm if you've got some bales of hay or some cows in it you couldn't see out the back window anyway. Move for its advancement.
