CLERK: Mr. President, 114 offered by Senators Schellpeper and Owen Elmer. (Read title.) The bill was introduced on January 5 of this year, referred to the Transportation Committee, advanced to General File. I have committee amendments pending by the Transportation Committee, Mr. President.

PRESIDENT: Senator Lamb, please.

LAMB: Mr. President and members, I think appropriate we are talking about this ATV bill which would allow rural electrics more latitude in how these vehicles are because some of those people are in the audience today. bill expands the use of ATVs. It allows the rurals to operate them on the road when such operation is incidental to their work taking care of the lines. Now the committee amendment provides just a little bit of clarification in that the words added when the course...within the course of employment. This allows all-terrain vehicles be operated on public streets, roads, highways outside the corporate limits of any municipality by electric utility personnel, and then we the words, "within the course of their employment", because we did not want to give license to those employees to operate ATVs when they're not actually working for the power district. So I would move the adoption of the amendment, Mr. Chairman.

PRESIDENT: You have heard the motion. The motion is to adopt the committee amendments. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

ASSISTANT CLERK: 26 ayes, 0 mays on the adoption of the committee amendments, Mr. President.

PRESIDENT: The committee amendments are adopted. Senator Schellpeper, we're back to the bill.

SENATOR SCHELLPEPER: Thank you, Mr. President and members, I think the one thing I want to make the body aware of this morning is that this bill for ATVs is strictly for public power districts. I don't want to get it confused with the other ATV bill that's out there. This one, all it does, it let's the

public power districts able to use the ATV vehicles to go out to check lines, to cross roads. In case of a storm or an outage, they now use these vehicles to go out to check their lines. This does not open it up for anybody else. It's strictly for public power districts. Right now, they are using these vehicles in emergencies but it is illegal to operate on the roadways after we passed the bill in 1987. So I want to make the point very clear that this is strictly for public power districts. If there are any questions, I would be glad to answer them.

PRESIDENT: Thank you. Senator Elmer, please, then Senator Barrett, please.

SENATOR ELMER: Thank you, Mr. President. I appreciate Senator Schellpeper introducing this bill and allowing me to co-sponsor it. Out in the southwest Nebraska areas the roads are very sparse in many areas and the lines that the public power districts have to service, transit, pastures, fields and lots of areas that the access is very poor, and also many of the meters that they need to read are off of the public access roads and they have to go back into the fields and such. The use of the these public power allows districts much better transportation to inspect their facilities and is a bill that I think that they really do need. And it was well stated by Senator Schellpeper that it does not give any leniency in any other area. And I would urge your support. It will save these public power districts considerable time, man hours and, therefore, reduce their budgets somewhat if they are allowed to use these convenient vehicles for that purpose. Thank you.

PRESIDENT: Speaker Barrett, please, then Senator Moore.

SPEAKER BARRETT: Thank you, Mr. President, and members, as Senator Schellpeper has just described, the bill does allow personnel of electric utilities companies to use ATVs on public roads and with the committee amendment, I understand, only during the course of their employment. This is a bill which does allow an exemption to the bill which I introduced in 1987 which disallowed the use of ATVs on public roads, with the exception of parades and for agricultural uses. At that particular time, I did warn the body that there would be attempts to create exemptions and this is the first bill that we're discussing this session which does, in fact, create an exemption. That concerns me. However, with the amendment

itself and with the bill which states that you shall be outside the corporate limits of any municipality, it is just a bit more palatable to me and perhaps not quite as large a problem as it might be. There is a bill out there, I believe it's 101, which might be following LB 114, which does open up the use of ATVs, I remember it, for use on public roads. This bill, 114, might be considered perhaps the proverbial nose of the camel under the flap of the tent but, again, REAs are safety oriented. Their personnel are used to operating under specific safety rules and I guess as long as they're operating outside the municipal limits and for purposes that are stated in the bill, I don't have quite as much problem with it. So I believe I would reluctantly perhaps support the amendment...or the bill, rather, that's introduced by Senator Schellpeper, but because the REAs can make and have made some good arguments for the passage of the bill. But I believe at this point I can safely say that I will strongly oppose any other efforts to open up the use of ATVs on public roads. I think this body needs to remember that ATVs are designed for off-road use and they should not be allowed on public roads. Thank you, Mr. President.

PRESIDENT: Thank you. Senator Moore, please.

SENATOR MOORE: I just want to briefly mention what Senator...reiterate what Senator Barrett said. I, myself, am one of the sponsors of LB 101. Just to eliminate any confusion, 101 is the bigger ATV bill that does a lot of worse things if you're of the mind of Senator Barrett. And I guess I just want to mention that LB 114 is a little teeny bill that shouldn't be any problem to anybody and I nope you listen to Senator Barrett and this bill passes with little trouble.

PRESIDENT: Thank you. Senator Schellpeper, would you like to close on your motion to advance?

SENATOR SCHELLPEPER: Yes, I would like to thank Speaker Barrett for his comments and I think that, with that, I would just move that we advance the bill.

PRESIDENT: The question is the advancement of the bill. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

CLERK: 27 ayes, 0 nays, Mr. President, on the motion to advance LB 114.

PRESIDENT: LB 114 is advanced. May I introduce some guests, please, of Senator Owen Elmer and Speaker Barrett. Under the south balcony, we have Larry Reynolds of Lexington, Nebraska and Doyle Lavine and Kay Lavine of Bertrand. Would you folks please stand and be recognized. Thank you for visiting us today. Move on to LB 43.

CLERK: LB 43, Mr. President, was a bill offered by Senator Bernard-Stevens. (Read title.) The bill was introduced on January 5, referred to Natural Resources, advanced to General File. I have no amendments to the bill, Mr. President.

PRESIDENT: Senator Bernard-Stevens, please.

SENATOR BERNARD-STEVENS: Thank you, Mr. President, and members of the body, LB 43 simply increases the amount of liquidated damages for unlawfully killing, destroying, taking or possessing certain animals, fowl, birds or fish, such as follows, and can read in through the text if you want. In essence, what we have we divided it into categories. Big game fees would go from 300 to 600. That would be, for example, elk, deer, swan, big horn sheep. Medium game fees from 25 to \$50 on the fine would be examples, turkey, goose, on conservation animals. And then we have the final category which is the statute already, birds and fish from \$5 to \$20. This fee is more than doubled because it was too low for replacement costs originally. Members of the body, these fees, in essence, are the first to change in fees we've had on liquidated damages of these...of this wildlife since 1929. Nothing has really changed since They were, in many cases, undervalued at this time. There are certain states, for example, Kansas, surrounding us, Missouri and Wyoming, who do not have a set value for game as we do in Nebraska. Other states surrounding us, for example, would be Iowa, South Dakota and Colorado. They all have civil penalty similar to Nebraska's statute 37-614 which liquidated damage law. What these fees would do would put us in line, number one, with those states surrounding us. And, number two...in fact, it will put us almost right in the middle of those states surrounding us; and number two, it would increase the deterrent at this point for poachers or poaching that is going on within the state. At the present time, the fees now are not a deterrent whatsoever and thus we feel it will be helpful the wild game animals in this particular area. And, with that, Mr. President, that was the opening comments I have.
