CLERK: Mr. President, I do, thank you. (Read LBs 1195-1219 by title for the first time. See pages 378-83 of the Legislative Journal.)

Mr. President, two new constitutional amendments. (Read LRs 242-243 by title for the first time. See pages 383-88 of the Legislative Journal.)

Mr. President, Government Committee gives notice of hearing for January 25, signed by Senator Baack. Banking Committee, whose Chair is Senator Landis reports LB 983 to General File, LB 984 to General File, LB 981 General File with amendments, LB 982 General File with amendments. (See pages 388-90 of the Legislative Journal.) That's all that I have, Mr. President.

SPEAKER BARRETT: Thank you, Mr. Clerk, proceeding to Select File, LB 259.

CLERK: Mr. President, the first order of business on 259 are Enrollment and Review amendments.

SPEAKER BARRETT: E & R amendments. Senator Withem, would you handle the E & R amendments on 259.

SENATOR WITHEM: Yes, beings our E & R Chairman is too busy at the moment, I'll be happy to move that the E & R amendments to 259 be approved.

PRESIDENT: We will move on, Senator Lamb, are you in position to handle that confirmation report. Okay.

SENATOR LAMB: Mr. President, and members, I would offer to the body the confirmation report for Mr. Myers.

CLERK: Senator, yeah, Lawrence Myers, the Nebraska Power Review Board.

SENATOR LAMB: Yes, Mr. Myers appeared before the Natural Resources Committee about two days ago and he is a reappointment. He was appointed, I believe, late last year and there was no opposition to his reappointment, and the committee voted unanimously to recommend that Mr. Myers be appointed to

SPEAKER BARRETT: Thank you, sir. Members, return to your seats for a roll call vote on the adoption of the McFarland amendment. Mr. Clerk, proceed.

CLERK: (Read roll call vote.) 20 ayes, 21 nays, Mr. President, on adoption of the amendment.

SPEAKER BARRETT: Motion failed. The call is raised. Mr. Clerk.

CLERK: Mr. President, I have nothing further to the committee amendments at this point.

SPEAKER BARRETT: Back to the committee amendments. Anything further, Senator Coordsen?

SENATOR COORDSEN: At this time, I would only move the adoption of the committee amendments, Mr. Speaker.

SPEAKER BARRETT: Thank you. Any discussion? Seeing none, those in favor of the adoption of the committee amendments to LB 313 please vote aye, opposed nay. Have you all voted? Please record.

CLERK: 34 ayes, 5 nays, Mr. President, on adoption of the committee amendments.

SPEAKER BARRETT: The committee amendments are adopted. To the bill, Senator Coordsen.

CLERK: Mr. President, may I make an announcement?

SPEAKER BARRETT: Excuse me, Senator Coordsen. Mr. Clerk.

CLERK: Mr. President, Banking Committee, chaired by Senator Landis, wants to have an Exec Session at eleven in the Senate Lounge, eleven o'clock for Banking Committee. Mr. President, may I read some items?

SPEAKER BARRETT: Proceed.

CLERK: Mr. Fresident, your Committee on Government reports LB 1216 to General File and LB 1056 indefinitely postponed, those signed by Senator Baack. Health Committee reports LB 1167

SPEAKER BARRETT: Chair recognizes Senator Hartnett.

SENATOR HARTNETT: Mr. Speaker, members of the body, this, as was stated by the Clerk, would amend the Nebraska Public Transportation Act, allowing municipalities or counties to contract with school districts, public school districts to use school buses for emergency evacuation of members of the public by qualified law enforcement personnel during an emergency or crisis situation which threatens the public's safety or well-being. The contract must require county the municipality to be liable for costs, maintenance, operation, insurance and other reasonable expenses. Schools are relieved of liability for damage of personal property. Schools are not required to alter vehicles and so forth. At the present time we have...special ed people are able to transport this way, and so are elderly. So this would just expand it to counties, and it's permissive...counties and municipalities, and it's simply permissive legislation for a contract between the school district and the counties. So, with that, I'd ask for the advancement of the bill.

SPEAKER BARRETT: Thank you. Discussion? Seeing none, those in favor of the advancement of LB 1086 vote yes, opposed no. Please record.

CLERK: 25 ayes, 0 nays, Mr. President, on the advancement of 1036

SPEAKER BARRETT: LB 1086 advances. LB 1216.

CLERK: LB 1216, Mr. President, was a bill introduced by Senator Baack. (Read title.) The bill was introduced on January 18, referred to Government, advanced to General File. I have no amendments to the bill, Mr. President.

SPEAKER BARRETT: Senator Baack, please.

SENATOR BAACK: Mr. Speaker and colleagues, this is another very simple bill, but it is a very important one, because it does provide the Veterans Home Building Fund, as presently in statute, was put into statute, and the only purpose they could use that fund for was for the building of new nursing facilities in this state. This would allow for them to use these funds for either the building of nursing facilities, or improving those

nursing facilities. That's the word that we add "or improving". And the reason we need this is because by the federal standards we are already at our capacity for nursing beds in this state, we don't need any more nursing beds in this state. What they need to do is they need to use these funds...by the time they use these funds there would be approximately \$770,000 in these funds which would be in conjunction with \$705,000 of 309 funds, and they would get about 2.7 million of federal matching funds, and then they can use these funds to make improvements at the various nursing homes across the state. So this just allows them to use that. The Governor has recognized that they need to use this fund, and it will be in the budget as we do the budget a little bit later on. This is just some enabling legislation that we need to pass to allow this to happen. With that I would just urge advancement of the bill. Thank you.

SPEAKER BARRETT: Thank you. Discussion, please. Senator Schellpeper, Senator Bernard-Stevens, followed by Senators Lindsay, Coordsen, Kristensen, Hall, Landis and Haberman. Senator Schellpeper, please.

SENATOR SCHELLPEPER: (Laughter.) Thank you, Mr. Speaker and members. I'd like to ask a question of Senator Baack, if I might.

SPEAKER BARRETT: Senator Baack, would you respond.

SENATOR BAACK: Certainly.

SENATOR SCHELLPEPER: Are there any funds in this bill that will actually fund the nurses to go there, to have an education, or just a place that they can stay?

SENATOR BAACK: This will only be used for the improvement of existing facilities, it will not be used for personnel.

SENATOR SCHELLPEPER: Thank you.

SPEAKER BARRETT: Senator Bernard-Stevens.

SENATOR BERNARD-STEVENS: Thank you, Mr. Speaker. Senator Baack, would you yield to a question?

SPEAKER BARRETT: Senator Baack.

SENATOR BAACK: Certainly.

SENATOR BERNARD-STEVENS: The question I had on the bill is, when the funds are used will this...this will in no way bypass the CON review on new programs or other areas, is that correct?

SENATOR BAACK: I think all the projects would fall under those limitations that we put in place last year.

SENATOR BERNARD-STEVENS: So there is no way that we would be bypassing CON review with this legislation.

SENATOR BAACK: No.

SENATOR BERNARD-STEVENS: Thank you.

SPEAKER BARRETT: Senator Lindsay.

SENATOR LINDSAY: Thank you, Mr. President. Could I ask Senator Baack a question?

SENATOR BAACK: Certainly.

SENATOR LINDSAY: Has this been through the 407 process?

SENATOR BAACK: No.

SENATOR LINDSAY: Thanks.

SPEAKER BARRETT: Senator Coordsen.

SENATOR COORDSEN: Thank you, Mr. Speaker. Would Senator Baack yield to a question, please?

SENATOR BAACK: Yes, I will.

SPEAKER BARRETT: Senator Baack.

SENATOR COORDSEN: Are there any restraints in this bill to require certain colors to be used in the decorations of the nursing home because...of the veterans home, because I have had complaints from residents in some of them that they are somewhat bland.

SENATOR BAACK: I don't think there are, but I suppose if you

wanted to put those on Select File, you could do that.

SENATOR COORDSEN: Thank you.

SPEAKER BARRETT: Senator Kristensen.

SENATOR KRISTENSEN: Thank you, Mr. Speaker, members. Would Senator Baack yield to a question, please.

SPEAKER BARRETT: Senator Baack.

SENATOR BAACK: Yes.

SENATOR KRISTENSEN: Senator Baack, does this legislation entitle nurses to have a choice? (Laughter.)

SENATOR BAACK: Of what?

SENATOR KRISTENSEN: Well, I guess I was just asking, since you're kind of the father of choice, that maybe you could explain if that has anything to do with this legislation.

SENATOR BAACK: No, it does not.

SENATOR KRISTENSEN: Thank you.

SPEAKER BARRETT: Senator Hall.

SENATOR HALL: Question.

The City of Milford cemetery is nearing capacity, and DPI has some land there that they could sell. But, with t'at, DPI needs permission to sell the land at the Soldiers and Sailors Home, and the cemetery land at Mead, Nebraska. That's all it does.

PRESIDENT: Any further discussion? If not, the question is the advancement of the bill. All those in favor vote aye, opposed nay. Senator Nelson, what do you think?

SENATOR NELSON: I'm not sure about that. I don't know...
