Mr. President, amendments to be printed, Senator Hall has amendments to LB 240A, Senator Lamb to LB 369. (See pages 707-09 of the Legislative Journal.)

Mr. President, a new resolution, LR 252 offered by Senators Conway, Korshoj, Warner, Nelson and Beyer, asking the Legislature to acknowledge the service, knowledge and expertise that Phil Kruse has contributed to the State of Nebraska. That will be laid over, Mr. President. (See page 710 of the Legislative Journal.)

Mr. President, I have a referencing report referring LR 251 to the Judiciary Committee for public hearing, as well, Mr. President, as a request for the sale of revenue bonds by Kearney State College. As part of that process, Mr. President, I have a letter from Senator Labedz to the Clerk advising the Legislature as to the reference of that proposed bond sale.

Mr. President, finally, a request from Senators Hall and Chizek as Chairs of the Revenue Committee and Judiciary Committee to

SPEAKER BARRETT: Proceed.

CLERK: Senator Hartnett would graciously defer holding the Urban Affairs Committee until adjournment, Mr. President. It was scheduled to meet at three o'clock. They will meet upon adjournment and I understand General Affairs Committee will meet approximately 30 minutes after the Urban Affairs Executive Session. Mr. President, 1217 by Senator Lindsay. (Read title.) The bill was introduced on January 18, referred to Banking, advanced to General File. I have no amendments to the bill, Mr. President.

SPEAKER BARRETT: Senator Lindsay, please.

SENATOR LINDSAY: Thank you, Mr. President, members, this bill is an amendment to last year's Consumer Rental Purchase Agreement Act. It provided for consumer protection for those persons renting furniture from rent-to-own institutions. Unfortunately, at that time there was an error in the language that was a little bit unclear. Obviously, it wasn't me that drafted it. That error is based...it's a little unclear as far as what the damages are that a person is entitled to recover. The intent was to provide that it be the greater of either actual damages or 25 percent of the total payments to acquire ownership, but not less than 100 nor more than 1,000. Because of the placement of the greater of language, that is not clear. What this is intended to do is to make that clear. I would add that it does not change any policy or intention. It merely puts that intention into place. I would urge the adoption of the bill.

SPEAKER BARRETT: Thank you. Discussion. Seeing none, those in favor of the advancement of LB 1217 please vote aye, opposed nay. Record, please.

CLERK: 27 ayes, 0 nays on the advancement of 1217, Mr. President.

SPEAKER BARRETT: LB 1217 is advanced. LB 1228.

CLERK: 1228, Mr. President, offered by Senator Pirsch. (Read title.) The bill was introduced on January 18, referred to Banking, advanced to General File. I have no amendments to the bill, Mr. President.

SPEAKER BARRETT: Senator Pirsch, please.

SENATOR PIRSCH: Thank you, Mr. Speaker and members of the Legislature, LB 1228 clarifies and proposes technical amendments to the LB 482 that we passed last year dealing with the Nebraska Uniform Limited Partnership Act. We also had a technical amendment offered by the Secretary of State's Office to eliminate the requirement that the hour or the time of the filing would be placed on the document, so we also put that in the bill to accommodate the Secretary of State's Office. With that, I would move the advancement of 1228.

SPEAKER BARRETT: Thank you. Is there discussion? Seeing none, shall LB 1228 be advanced? All in favor vote aye, opposed nay. Have you all voted? Please record.

CLERK: 25 ayes, 0 nays, Mr. President, on the advancement of 1228.

SPEAKER BARRETT: LB 1228 is advanced. LB 1105.

CLERK: 1105 offered by Senator Haberman. (Read title.) The bill was introduced on January 11, referred to Retirement for public hearing, advanced to General File. I have no amendments to the bill, Mr. President.

SPEAKER BARRETT: Senator Haberman.

SENATOR HABERMAN: Mr. President, members of the body, LB 1105 allows current state patrol officers who were previously employed by the patrol to repay contributions that they withdrew, plus interest. They will then be given service credit for those years of service that they bought back. This bill will affect approximately, five to ten people and has no impact on the patrol's retirement fiscal system. This type of buy back has been allowed for the schools retirement systems also. We have in the bill that they have to buy back during a specific time period, July 1, 1990, through July 30, 1990, or six months. Officers who have already retired cannot buy the years back. Mr. President, I ask for the advancement of the bill.

SPEAKER BARRETT: Any discussion? If not, those in favor of the advancement of LB 1105 to E & R please vote aye, opposed nay. Record, please.
