PRESIDENT: Thank you, Mr. Harris. We appreciate your coming and giving us the benediction, not the benediction, the invocation this morning. Roll call, please.

CLERK: I have a quorum present, Mr. President.

PRESIDENT: Thank you. Do you have any messages, reports, or announcements?

CLERK: Mr. President, I have a Reference Report referring LBs 1172-1242, and LRs 242-245, signed by Senator Labedz, as Chair of the Reference Committee. Senator Coordsen gives notice of hearing for the Business and Labor Committee for February 5 and January 29. (Re: LB 1135, LB 1117.)

I have a report of registered lobbyists for the week of January 18, and, Mr. President, an Attorney General's Opinion addressed to Senator Landis regarding LB 272A. (See pages 421-24 of the Legislative Journal.) That is all that I have, Mr. President,

PRESIDENT: We will move on, Senator Lamb, are you in position to handle that confirmation report. Okay.

SENATOR LAMB: Mr. President, and members, I would offer to the body the confirmation report for Mr. Myers.

CLERK: Senator, yeah, Lawrence Myers, the Nebraska Power Review Board.

SENATOR LAMB: Yes, Mr. Myers appeared before the Natural Resources Committee about two days ago and he is a reappointment. He was appointed, I believe, late last year and there was no opposition to his reappointment, and the committee voted unanimously to recommend that Mr. Myers be appointed to

prerogative. We shouldn't have to go to the executive branch for permission. So the purpose of the bill is to place the authority for approval of these expense payments, in cases where individuals involved are assisting this Legislature, with the Executive Board instead of the Governor. It's that simple. That's the only change, the expenses still...must still be allowable as they are under current law, and the appropriation must have been made specifically for that purpose. That, essentially, is the bill. I would move for its advancement.

SENATOR LABEDZ: Thank you, Senator Barrett. We're voting on...there are no further lights, Senator Barrett. We're voting on the advancement to E & R initial of LB 1032. All those in favor vote aye, opposed nay. Have you all voted? Record, Mr. Clerk.

SENATOR LABEDZ: LB 1032 is advanced. Before we go on with further business, I would like to introduce a guest of Senator Byars. Terry Volkman from Beatrice, Nebraska, under the south balcony. Please welcome Terry to the Legislature. Mr. Clerk.

CLERK: Madam President, LB 1236 was a bill introduced by Senator Smith. (Read title.) The bill was introduced on January 18, referred to the General Affairs Committee for public hearing. The bill was advanced to General File. Senator, you want to offer your amendment at this time?

SENATOR SMITH: Yes, please.

SPEAKER BARRETT PRESIDING

CLERK: Senator Smith would move to amend her bill, Mr. President. The amendment is on page 878 of the Journal.

SPEAKER BARRETT: The Chair recognizes Senator Smith.

SENATOR SMITH: Thank you, Mr. Speaker, members of the body. This amendment is basically clarifying and harmonizing, and it does a few things. Number one, it harmonizes Sections 51.211 and 51...I should say "dash" 212. And that way there will be no conflict between the two provisions in the first part of it. And then when you go down to line 18, number 2, it was a

drafting error. I never intended for libraries to charge for assistance from librarians, and so I want that to be stricken from the language. And then on line 20, "primary" is really unnecessary language, and we don't want to complicate it in any way by putting that word in, so we decided to remove that also. So that is really basically what the amendment does to the bill. The bill, as has already been stated, is a bill relating to public libraries, and it deals with allowing them to charge for extra kinds of services which they are now, quite honestly, some of them performing illegally, but not for basic services, and I will talk about that in the bill. This amendment is, to me, tightens it up more yet. So I would ask your support on the amendment, please.

SPEAKER BARRETT: Thank you. For discussion purposes, Senator Nelson.

SENATOR NELSON: To the bill. Thank you.

SPEAKER BARRETT: Thank you. Any discussion on the Smith amendment? Anything further, Senator Smith?

SENATOR SMITH: No.

SPEAKER BARRETT: Thank you. The question is the adoption of the Smith amendment to LB 1236. Those in favor vote aye, opposed nay. Please record.

CLERK: 25 ayes, 0 nays, Mr. President, on the adoption of Senator Smith's amendment.

SPEAKER BARRETT: The amendment is adopted. Senator Smith, please.

SENATOR SMITH: Thank you, Mr. Speaker, members of the body. This is a bill that actually amends Chapter 51, Article II, dealing with public libraries. In the first section of the bill all I'm doing is defining what basic services are that are provided by libraries, and I wanted to make very clear that basic services are something that are going to continue to be free services. As I mentioned a little earlier, right now this is to address a problem which has been created by the fact that probably because of the hard economic times in some of the communities across the state, I think they're becoming resourceful in forcing...maybe that's not the correct word, but

maybe helping their libraries along to help support themselves a little more by asking them to charge for some nonbasic services, and they've been doing this, to this point in time, and it has not been legal because it was not in law that they could do it. And so the bill will just simply put it in law that they are able to charge for some nonbasic services, and those would be the ones that are not defined as basic services in Section 1. Section 2 specifies that basic services must be made available without charge and that goes clear...actually goes clear over...on two on page three and it talks about that the basic services will be available without charge to all residents. And then Section 3 is where the change is made, it allows them then to fix and impose reasonable fees, but not to exceed actual cost for nonbasic services. That's the extent of the bill. If there are questions, I will try to answer them. If there are no questions, I would ask for your support on the bill. Thank you.

SPEAKER BARRETT: Thank you. Senator Nelson, on the advancement of the bill.

SENATOR NELSON: Mr. Speaker, members of the body, Senator Smith very well and very aptly presented the bill and explained it to you. Again, I would hope that you would see very favorable. It's just for services, as she said, they're now using and maybe need to charge for. The small town libraries and a lot of them, financially, are having a lot of problems, and some of the services, that is video tapes or so on, that simply is what they're asking for. And it does not affect the membership or so on that the...that people do pay for. And I just simply support Senator Smith in this bill.

SPEAKER BARRETT: Thank you. Any other discussion. Any closing, Senator Smith.

SENATOR SMITH: Yes, I would. I'm sorry that I neglected to list for you some of the nonbasic services that they are presently charging for. Those are things like photocopying equipment. Right now they may be charging for running copies on a machine for you, which they have at your service in the library. If you're using special equipment, like telephones, facsimile equipment and other telephone communications equipment, media equipment, personal computers, video cassettes and so on, those are the kinds of things that they may have to have a charge or a fee for use of. And that is what we're asking in this bill, for them to have a charge which is actual

cost only for the use of that equipment. With that, I would ask for the support on the bill. Thank you.

SPEAKER BARRETT: Thank you. You've heard the closing. The question is the advancement of LB 1236 to E & R initial. All in favor vote aye, opposed nay. Voting on the advancement of the bill. Record, please.

CLERK: 26 ayes, 0 nays, Mr. President, on the advancement of LB 1236.

SPEAKER BARRETT: LB 1236 advances. Before proceeding to 1009, I'd like to announce that, time permitting, I'd like to go directly into LB 1172, Government Committee priority bill, to be followed by LB 1039, a priority bill of the Retirement Committee. Time permitting, 1172 and 1039. Mr. Clerk, LB 1009.

CLERK: Mr. President, 1009, offered by Senator Moore. (Read title.) The bill was introduced on January 4, referred to the Government Committee for public hearing. The bill was advanced to General File. I have committee amendments pending by the Government, Military and Veterans Affairs Committee, Mr. President. (Standing Committee amendments appear on page 463 of the Legislative Journal.)

SPEAKER BARRETT: The Chair recognizes Senator Baack.

SENATOR BAACK: Mr. Speaker and colleagues, the committee amendment is very simple. All it does...the bill, in itself, called for an appropriation of \$70,000, I think. The committee felt that instead of having the appropriation in the bill, that Senator Moore should have an A bill that would accompany 1009, so we simply struck out the appropriation that was in the bill. And that's all that the committee amendment does. Thank you.

SPEAKER BARRETT: Discussion on the committee amendments? Any questions? If not, those in favor of the adoption of the committee amendments, please vote aye, opposed nay. Voting on the adoption of the committee amendments to LB 1009. Please record.

CLERK: 25 ayes, 0 nays, Mr. President, on adoption of the committee amendments.

CLERK: Mr. President, Senator Wesely and Senator Schmit would move to amend the bill. Senator, I've got 3043 in front of me. (The Wesely amendment appears on pages 1428-30 of the Legislative Journal.)

PRESIDENT: Senator Wesely, are you going to handle that?

SENATOR WESELY: Yeah.

CLERK: Just one item, Mr. President, and that is bills read on Final Reading this morning have been presented to the Governor, for her review. (Re: LB 348, LB 542, LB 594, LB 965, LB 1032, LB 1236, LB 1094. See page 1435 of the Legislative Journal.) That is all that I have, Mr. President.

SPEAKER BARRETT: Thank you. Mr. Clerk, I believe we left of with LB 1090A, is that correct?

CLERK: Mr. President, it is and on LB 1090A the first order of business is consideration of an amendment to the bill by Senator Bernard-Stevens. (Bernard Stevens amendment is found on page 1435-36 of the Legislative Journal.)

SPEAKER BARRETT: (Gavel.) The Chair recognizes Senator Bernard-Stevens.

SENATOR BERNARD-STEVENS: Thank you. Members of the body, if you'll remember, on 1090 there were a few things added on and it increased the A bill slightly from about 5,000 to 390 some thousand, so a group of people obviously got together on the A bill, understanding that the bill may, in fact, be a little heavy on the bill itself and also realizing that there were things in 1090 that were very much needed particularly in regards to human relations and how we certify the teachers that are coming in to Nebraska from other states. So we did not want to jeopardize the bill. So, in essence, this amendment does two things. Number one, it sets the amendment up so that if for some reason the Governor does not like a single, a particular part of it, she would be able to use her line-item powers and line-item things back to or from whatever number she thought reasonable. It would then, thus, there is a possibility that the funding could be taken out in the areas she felt was not acceptable but it would not affect the statute of 1090. The second part of the amendment deals with the section that I had instituted which was LB 1195 and, in essence, what we agreed to do was to maintain the two sides but fund one of them. The funding would be decided by the educational consortium and it would change the A bill from what we had of a hundred some thousand dollars down to \$61,000, and that is simply the extent of the amendment. At this point I would urge the body to adopt the amendment.

SPEAKER BARRETT: Thank you. Any discussion on the amendment? Seeing none, those in favor of the adoption of the
