PRESIDENT: While the Legislature is in session and capable of transacting business I propose to sign and do sign LB 50, LB 143, LB 240, LB 240A, LB 465, LB 350, LB 350A, LB 692, LB 742, LR 8CA. (See page 820 of the Legislative Journal.) We'll move on to General File, A bills, LB 663A.

CLERK: Mr. President, 663A offered by Senator Scofield. (Read title.)

PRESIDENT: Senator Scofield, please.

SENATOR SCOFIELD: Thank you, Mr. President and members. You will recall this is the bill that creates the Juvenile Services Act. The vast majority of the \$581,000 figure in this bill for fiscal year '90-91 and the \$565,928 figure for '90-92, the vast majority of those two fiscal notes are grants that would go out to communities to help them set up alternatives for juvenile incarceration, diversionary processes, if necessary, facilities to incarcerate juveniles. There is...the other piece of this that you need to know about is simply the administrative costs and the primary expenditure here is the \$28,000 figure for a juvenile coordinator with some secretarial support and some start up costs for the office. You will recall we made the decision to put this under Probation so that that could work more closely with the judges to help us solve that problem. It would be my intent that that juvenile coordinator position would

linear would be based on pipes, and we are talking about pipes, 260 feet of those or less would be exempted from the license, businesses working in those. Mr. President, committee hearing notices from Appropriations Committee and from the Business and Labor Committee, signed by their respective Chairs. That is all that I have, Mr. President.

SENATOR WEIHING: Senator Barrett.

SPEAKER BARRETT: Thank you, Mr. President, and members. I am pleased to bring to the Unicameral today LR 261 found on page 993 honoring Dr. D.B. Woody Varner, who is a friend of this Legislature, a friend, I think probably, of every member of this Legislature. Woody has had a very long and outstanding career and record of public service, both as Chancellor and President of the University of Nebraska. He has distinguished himself in so many, so many ways over the years. He was an especially good friend of this Legislature in 1988 when he assisted us in the introduction of the Amendment 1 which dealt with a subject near and dear to our hearts. Other recipients of this prestigious award, of course, have included President Gerald Ford, and Bob Gray, Dr. Clayton Yeutter, and the NEBRASKAland Foundation is honoring Dr. Varner with their Distinguished NEBRASKAlander award on March 10. So I would hope that this Legislature would, through this resolution, extend its congratulations to Dr. Varner upon receipt of this very prestigious award. PRESIDENT: Back in session now. Anything for the record, Mr. Clerk, at this time?

CLERK: Not at this time, Mr. President.

PRESIDENT: All right. We will move on to LB 1244, please.

CLERK: Mr. President, LB 1244 was a bill introduced by the Business and Labor Committee and signed by its members. (Read title.) The bill was introduced on February 15 of this year. At that time, it was referred to the Business and Labor Committee for public hearing. The bill was advanced to General File. I do have committee amendments pending by the Business and Labor Committee, Mr. President.

PRESIDENT: Senator Coordsen, do you want to handle this matter, please?

SENATOR COORDSEN: Yes, thank you, Mr. President, members of the body. The approved claims bill, 1244, is almost exactly as it was presented to the Business and Labor Committee with several small changes. One of the changes in the committee amendment, I would like to run through these with you, is down on line 16 and 17 of the committee amendments, relate to a claim by the City of Gering for paving against the State of Nebraska. The Claims Board inadvertently wrote the bill with the total claim including interest from the City of Gering, and the approved amount was \$10,694.89. As a matter of general practice, the state does not pay claims to governmental subdivisions with interest. So the amount of the claim, the original claim was \$8,121. This is the amount that should have been in the claims bill and this is the amount then that was amended by the Business and Labor Committee. The other six claims that were approved totaled \$923.03, and I will just quickly run through the list; outdated income tax warrant, outdated income tax warrant, outdated income tax refund, payroll warrant that a person found in which they claimed the total amount, the gross salary of \$503, Business and Labor approved this claim in the amount of the net amount which was \$390, several more outdated income tax refunds, another outdated income tax refund. So we have six people with outdated warrants. I would like to run

through these just a little bit for the record and indicate to you what the change in procedure for the Claims Board that the Business and Labor Committee agreed might be a better way of handling outdated claims. I have been involved in discussions with the State Treasurer and the Claims Board for nearly three years now relative to the method of handling outdated claims from individuals that are, basically, small in amount and are the result of a refund check of some type being tucked away and then not rediscovered until some years later. The Claims Board has held until recently that since they can only verify these checks going back five years, and they are not then able to verify whether there has been a duplicate check issued prior to five years before the claim, that they should go through the claims process. I think, historically, the Legislature has always paid these claims by the citizens of the State of Nebraska. The Business and Labor Committee would like to indicate in the record for the use of the State Claims Board that it is the intent of the Legislature that the Claims Board pay all out-of-date state warrants on income, retirements, and similar accounts to individuals up to a total of \$500 if the board investigates a claim, and to the best of their ability, notwithstanding the five year retention rule, discovers that the warrant has not been paid or a duplicate issued and the warrant is to an individual. So if an individual check that is over five years old would come in that totaled more than \$500, they would still, the Claims Board would still be required to not approve that and send that as part of the rejected claims to the Legislature. The total of the committee amendments, then, reduces the amount of the fiscal note on 1244 from \$277,411.21 to \$275,760.35, of which \$117,396.97 will be from the General Fund, and \$158,364.27 will be from the various cash funds. In addition, 1244 authorizes a number of write-offs for uncollectible checks and warrants that various state agencies have. So with that, I would move for the adoption of the committee amendments.

PRESIDENT: Any further discussion? If not, the question is the adoption of the committee amendments. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

CLERK: 28 ayes, 0 nays, Mr. President, on the committee amendments.

PRESIDENT: The committee amendments are adopted. Anything further on the bill, Mr. Clerk?

CLERK: I have nothing further on the bill, Mr. President.

PRESIDENT: Senator Coordsen, did you wish to speak about the bill?

SENATOR COORDSEN: I think that I explained the bill in the conversation on the advancement of the bill. All those in favor of the advancement of the bill.

PRESIDENT: Thank you. Any further discussion? If not, the question is the advancement of the bill. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

CLERK: 26 ayes, 0 nays, Mr. President, on adoption of the motion to advance the bill.

PRESIDENT: LB 1244 is advanced. We will move on to Select File at this time, LB 688, please.

CLERK: Mr. President, LB 688 is on Select File. First order of business are Enrollment and Review amendments.

PRESIDENT: Senator Lindsay, please.

SENATOR LINDSAY: Mr. President, I move the adoption of the E & R amendments to LB 688.

PRESIDENT: You've heard the motion. All in favor say aye. Opposed nay. They are adopted.

CLERK: Mr. President, Senator Lindsay would move to amend the bill.

SENATOR LINDSAY: Thank you, Mr. President, this amendment is kind of a clean-up amendment, adds a couple of requirements that were worked out among some of the different parties. One would...the first part of the amendment would require two hours of training for the care providers. The procedures that are involved generally would not require even two hours for the training. The people who would be taking the training have usually have already had the experience in performing those functions anyway. The second part of the amendment would add to

Mr. President, the next amendment to the committee amendments I have is offered by Senator Withem. (Withem amendment appears on page 1339 of the Legislative Journal.)

PRESIDENT: Senator Withem, please.

SENATOR WITHEM: Mr. President, members of the body, this is an amendment somewhat similar to the last one dealing with our legislative process. Increased appropriation to the Legislative Council to the tune of \$20,000. The purpose of this is to fund ongoing telecommunication, actually it says television, maybe it should say telecommunication, if people are interested in changing that, we can do so, if this gets adopted, with another amendment or a Select File amendment...televise legislative hearings. Over the past year we have had two major interactive teleconferences with legislative leadership hearing people testifying on issues of concern to the public, we questioning
