SENATOR R. JOHNSON: Mr. President, members, during the past weekend I was in Aurora and addressing a group and received some information on a former colleague of ours, in fact, my predecessor, Senator Maurice Kremer. He is fighting a rather serious battle with cancer and has been undergoing chemotherapy treatments and is in rather poor health, and I am sure he would appreciate any calls or letters or cards that you might send to him to wish him well because he was a man of great integrity in this body, and I think those that had a chance to serve with him would echo my thoughts that he was an institution in himself and I think he would appreciate anything, any kind gesture we would send along to him.

PRESIDENT: Do you have his address or is he in the hospital or...

SENATOR R. JOHNSON: I can get it for those who would like it. He is home. He has been driving back and forth to receive his treatments at Hastings Memorial...or Mary Lanning Hospital but he is home at this particular time.

PRESIDENT: Okay, we could get that address from your office.

SENATOR R. JOHNSON: You sure can.

PRESIDENT: Fine, thank you for the announcement. We appreciate it. Now back to you, Mr. Clerk.

CLERK: Series of notices, General Affairs offers notice of hearing, signed by Senator Smith as Chair. Committee on Natural Resources, whose Chair is Senator Schmit, reports LB 56 to General File, LB 127 General File, LB 167 General File, LB 185 General File, LB 90 indefinitely postponed, those signed by Senator Schmit. Health and Human Services Committee, whose Chair is Senator Wesely, reports LB 342 to General File with amendments, LB 344 to General File with amendments, those are signed by Senator Wesely as Chair. Natural Resources Committee, whose Chair is Senator Schmit, reports LB 195 to General File with amendments. That is signed by Senator Schmit. (See pages 491-92 of the Legislative Journal.)

Mr. President, Senator Bernard-Stevens would like to print

that this body cannot solve through legislation, though Senator Wesely would try. We have an amendment that I am proposing that can say we are concerned with our young. We do want to stop sampling to our young and we hope that we can get the message across to our young, please, do not smoke cigarettes, tobacco products and use smokeless tobacco.

SPEAKER BARRETT: Your time has expired.

SENATOR BERNARD-STEVENS: If we can get it across as a nation, as a society, if people in here can also put themselves to the same test, we might get somewhere. The bill will not get us any closer. My amendment will take us a small step and I will regrettably say, it is an unfortunate small step but a small step is better than none.

SPEAKER BARRETT: Time has expired.

SENATOR BERNARD-STEVENS: Thank you, Mr. President.

SPEAKER BARRETT: Thank you. The question before the body is the adoption of the Bernard-Stevens amendment to LB 48. Those in favor please vote aye, opposed nay. Have you all voted? Please record.

CLERK: 17 ayes, 23 nays, Mr. President, on adoption of the amendment.

SPEAKER BARRETT: The amendment is not adopted. Messages on the President's desk.

CLERK: Mr. President, unanimous consent request from Bernard-Stevens to add his name to LB 521; Senator Pirsch to LB 441.

Your Committee on Education, whose Chair is Senator Withem, reports LB 357 to General File with amendment. Notice of hearing from Natural Resources, signed by Senator Schmit. Senator Hefner has amendments to LB 127 to be printed; Senator Barrett to LB 283; Senator Chambers to LB 165; and Senator Hall to LB 48. (See pages 523-25 of the Legislative Journal.) That is all that I have, Mr. President.

SPEAKER BARRETT: Senator Goodrich, would you care to adjourn us.

cooperation of the Game and Parks Commission to address a situation that has developed with the major fur buyers in Nebraska over the last several years, in that these larger fur buyers had been converting the record keeping over to a computer base system and this was being accepted by Game and Parks until someone looked at the statute and saw that the only legal means of keeping fur buying records was in a hand-entered book furnished by the Game and Parks Commission. So this spring they had to deny to these fur buyers the legitimacy of their computer records. In talking with the Game and Parks people they had absolutely no objection, in fact, they welcomed this opportunity to be able to develop rules and regulations to accept other methods of record keeping aside from those that were hand-lettered in the provided record book. So this bill is a simple one-line bill, the wording provided by Game and Parks. It gives them the flexibility to write regulations to be able to use computer records or such other improvement in record keeping that might be coming on in the future without any further changes in statute. So with that, I would urge the advancement of this bill.

PRESIDENT: Thank you. The question is the advancement of the bill. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

CLERK: 28 ayes, 0 nays, Mr. President, on the advancement of LB 56.

PRESIDENT: The bill is advanced. LB 127.

CLERK: LB 127, Mr. President, was a bill introduced by Senators Hefner, Dierks and Rogers. (Title read.) The bill was introduced on January 5, referred to the Natural Resources Committee, advanced to General File. Senator, I do have your amendment. Would you want to offer that now or do you want to defer for a bit?

PRESIDENT: Senator Hefner.

SENATOR HEFNER: Okay, maybe I should explain the bill first and then we'll take up the amendment. Mr. President, members of the body, this is called a muzzle-loader's bill. LB 127 allows the Game and Parks Commission to establish a muzzle-loading deer season and I introduced this on behalf of several constituents in my district. I'm sure that most of you are familiar with

muzzle-loaders. We see them from time to time at parades. They are loud, they're noisy and they have a lot of smoke. Right now it is against the law to use high-powered rifles to hunt wild animals other than deer during the firearms deer season. This prohibition has been established to help stop illegal hunting of deer and some of you that were down here about 10 years ago, well, we passed this bill. LB 127 amends a current law to state that it is against the law to use high-powered rifles to hunt wild animals other than deer during the center-fire cartridge deer season. Firearms is a broad term which includes high-powered rifles and muzzle-loaders. Center-fire cartridges is a narrower term which does not describe or include muzzle-loaders. By using the wording in the bill, the Game and Parks Commission is given the authority to establish a separate deer season for muzzle-loaders. The bill merely authorizes this to be done. If the bill passes, the Game and Parks Commission could hold a public hearing on any proposed rules and regulations to establish a new season. The use of high-powered rifles to hunt wild animals other than deer would not be prohibited during the muzzle-loading deer season. This bill is supported by the Game and Parks Commission and they testified at the public hearing. I'm now ready for the amendment.

CLERK: Mr. President, Senator Hefner would move to amend by adding the emergency clause.

SENATOR HEFNER: Mr. President, members of the body, I would like to have the emergency clause on this bill because the Game and Parks Commission usually holds hearings in March to establish hunting seasons. If the bill passes before then, it would then be in effect at the times of these hearings and the Game and Parks Commission could make their decision at this time. So I would move for the adoption of this amendment. This amendment would merely add the emergency clause.

SENATOR LAMB PRESIDING

SENATOR LAMB: Senator Hartnett, please.

SENATOR HARTNETT: Mr. President, members of the body, could I ask Senator Hefner a couple of questions?

SENATOR LAMB: Senator Hefner, would you yield?

SENATOR HEFNER: Certainly.

SENATOR HARTNETT: How many muzzle-loader guns are in the state, I guess just more out of curiosity?

SENATOR HEFNER: Well, I really don't know that answer, but I know there are quite a few.

SENATOR HARTNETT: Is that right?

SENATOR HEFNER: We have several groups up in the 19th Legislative District and when I was drafting this bill and after the introduction of it, well, I heard from quite a few more, so there are a number of groups across the state. Dennis...Senator Byars was just telling me here that there is one in his district or maybe more than one.

SENATOR HARTNETT: Another question, would it be a separate season than the...is that what the Games and Parks, that weren't...is that what they testified, would it be a separate season from the normal season or would it be part of?

SENATOR HEFNER: The Game and Parks Commission feel that it perhaps would be a special season.

SENATOR HARTNETT: Yeah, thank you.

SENATOR HEFNER: And one thing about it, these muzzle-loading, these people that shoot these muzzle-loaders would only get one shot because the deer would certainly be gone after that.

SENATOR HARTNETT: Thank you, Senator Hefner.

SENATOR LAMB: Senator Elmer, please.

SENATOR ELMER: Thank you, Mr. President and members. I had a letter from a constituent regarding this particular bill saying, we have more deer out there than people. They are quite detrimental at times and anything that would extend the season and maybe deplete the population would be desirable and I doubt if there is enough muzzle-loaders in the state that would do very serious damage to the deer population, but out in my country anything that will help reduce the numbers would be welcome and I would strongly support LB 127 and the amendment.

SENATOR LAMB: The Chair recognizes Senator Scofield.

SENATOR SCOFIELD: Mr. President and members, I would just rise to say that I think Senator Hefner has hit on something that would be of particular interest in my area simply because we have a number of people that come in there for rendezvous and black powder shoots and events and, consequently, I felt compelled to respond when Senator Hartnett asked you how many there are. I can't answer that but that is a fairly popular activity in northwest Nebraska and we see people coming in to the state to participate in those activities as well as a number of local residents, so I think this is something that will probably not have a great impact on the deer population but will be a popular activity. Thank you.

SENATOR LAMB: Senator Hefner, that is all the speakers. Did you care to close on your amendment?

SENATOR HEFNER: Mr. President and members of the body, just briefly, I do have the information here on the number of muzzle-loaders that's in Nebraska. They have over 400 members with 24 affiliated clubs. Their organization is called the United Nebraska Muzzle-loaders Association. I move for the adoption of the emergency clause on this bill.

SENATOR LAMB: The motion is the adoption of the amendment by Senator Hefner. Those in support vote yes, those opposed vote no. Have you all voted? Record, Mr. Clerk.

CLERK: 28 ayes, 0 nays, Mr. President, on the adoption of Senator Hefner's amendment.

SENATOR LAMB: The amendment is adopted. On the bill, there are no speakers, Senator Hefner, do you have a close on the advancement of the bill?

SENATOR HEFNER: Mr. President and members of the body, I move for the advancement of LB 127.

SENATOR LAMB: The motion is the advancement of LB 127. All those in support vote aye, those opposed vote nay. Have you all voted? Record, Mr. Clerk.

CLERK: 27 ayes, 0 nays, Mr. President, on the advancement of 127.

SENATOR LAMB: LB 127 is advanced to E & R Initial. Mr. Clerk.

CLERK: Mr. President, the next bill is LB 167 offered by Senator Schmit. (Read title.) It was introduced on January 5, referred to the Natural Resources Committee. The bill was advanced to General File. I have no amendments to the bill, Mr. President.

SENATOR LAMB: The Chair recognizes Senator Schmit.

SENATOR SCHMIT: Mr. President and members, this bill changes the penalty for entering a park permit area without a valid permit from an infraction to a Class V misdemeanor, which is a maximum of a \$100 fine and no minimum, no imprisonment. The reason for this bill is that when out of state persons visit our Game and Parks areas and violate the park permit principle they cannot be...the violation cannot be enforced as an infraction. This gives us the ability to enforce the use...the invalid use of a park permit or the absence of a park permit. I would be glad to answer any questions.

SENATOR LAMB: Senator Hartnett, please.

SENATOR HARTNETT: Mr. Speaker, members of the body, Senator Schmit, can I ask you a question?

SENATOR SCHMIT: Surely.

SENATOR LAMB: Would you respond, Senator Schmit?

SENATOR SCHMIT: Surely.

SENATOR HARTNETT: I'm on a question binge this morning. I guess one of the things I have with the fees and so forth, you know, I have occasion to go to the parks, maybe not...for a very short period of time and you have to pay the...you know, it's not that much but if you only want to go in there for 15 minutes, you've got to get the permit to get in the place. If they have...you know, for a short period of time, have they ever considered that? You work probably closer to the Games and Parks than I do, but that's one of my bones of contention with it.

SENATOR SCHMIT: Well, we could put a parking meter out there for you, I guess, Senator Hartnett, but that probably wouldn't

I don't think I am here, just like neither is Senator Chambers here to serve as a rubber stamp for the Omaha City Council. I have the...it's my job to question and my job to exercise my right, to exercise my judgment. In my judgment, it's bad policy to elect the whole city council at once. For that reason, and not only...I don't care if it was the York City Council asking for it or the Omaha City Council asking for it, I'd still be voting no on this and I am sorry if I am not cowering and licking the boots of the Omaha City Council like
