Transportation Committee to whom was referred LB 280 instructs

PRESIDENT: The question is the advancement of the bill. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

CLERK: 25 ayes, 0 nays, Mr. President, on the advancement of LB 441.

PRESIDENT: LB 441 is advanced. We will take up LB 250 next, please.

CLERK: Mr. President, LB 250 was a bill that was introduced by Senator Hall and Senator Withem. (Read title.) The bill was introduced on January 9.

PRESIDENT: The Speaker has asked that we skip over 250. We will go on to LB 157. Is that correct, Mr. Clerk?

CLERK: Yes, Mr. President, I believe it is.

PRESIDENT: Okay.

CLERK: Mr. President, 157 is a bill that was introduced by Senator Chizek. (Read title.) The bill was introduced on January 5, referred to the Health Committee. The bill was advanced to General File. Mr. President, I have no committee amendments but Senator Chizek would move to amend the bill and that amendment is on page 808 of the Journal.

PRESIDENT: All right, Senator Chizek, do you wish to talk about your amendment first?

SENATOR CHIZEK: Mr. President and colleagues, the amendment to LB 157 is on page 108 of the Journal and, in essence, becomes the bill. This bill was here last year and was on the floor and we have done substantial negotiations, if you would, with the interested parties. Basically, the intent was to provide notice to emergency medical service providers when they have been exposed to any of fifty some three infectious communicable diseases in the course of their duties. The amendment preserves that intent while taking care of some technical matters that were raised at the hearing. As I said, since the hearing all parties concerned have worked hard to reach meaningful accord. Statutes from other jurisdictions were examined. Specifically, the amendment before us proposes that the bill provide protection to emergency medical service providers,

confidentiality of patient identity and imposes certain duties on the EMS providers. We have done the amendment this way simply as a matter of convenience. In a nutshell, the EMS provider must request notification which is then provided to the physician designated by the provider within 48 hours. Only the fact of diagnosis is revealed, never the identity. Provisions are made in the bill for diagnostic testing. If there has been... a patient has the right to refuse the consent to testing. The bill is not a substitute in any way for positive action by the EMS provider. And I think it's important to emphasize that all health care facilities and providers are to adopt procedures addressing methods of preexposure safeguards and postexposure risk reduction. I would urge the body's adoption of the amendment. We passed out a summary of the bill and, as I said, I would urge the adoption.

PRESIDENT: Senator Wesely, did you wish to speak about the committee amendments?

SENATOR WESELY: Thank you. Mr. President and members, I would rise in support of the amendment and ask the body to adopt it and then I would also ask the body to advance the bill. I chaired the hearing on this legislation. If you look at LB 157, you will see a great number of individuals testified in support of it at the hearing. There were also a number of opponents to the bill. The opponents were very concerned about the original piece of legislation which was similar to a bill that Senator Chizek introduced last year. We did work toward compromise last year and did advance a bill at the end of the session. We went back to work once again and further compromised in trying to arrive at a consensus on this issue. Where we're at, essentially, is that the original bill that's before us, without the amendment, would be intrusive of personal confidentiality and I would object and I think the Health and Human Services Committee would object to it. But recognizing the integrity and honesty of Senator Chizek, we knew that he would come back with this amendment and work out the differences of different individuals. The different parties involved, the medical association and the hospital association, I understand, are agreed to this amendment. I am not yet certain of other potentially interested parties and I don't know if everybody has really had a chance to review the language in detail. I, personally, haven't but I think the thrust of it is fine. I think the intent is good and we're certainly better off with this amendment than the original bill. Currently, Senator

Chizek has identified an important issue and an important problem and so, with that, I would ask for the adoption of the Chizek amendment and support for it. I think it clearly improves this legislation and is necessary before we advance the bill.

SPEAKER BARRETT PRESIDING

SPEAKER BARRETT: Thank you. Senator Abboud, discussion on the amendment.

SENATOR ABOUD: Mr. President, colleagues, I rise to support the amendment as well. I feel that Senator Chizek has spent a great deal of time analyzing what I see as a very serious problem dealing with emergency personnel and I feel that this particular amendment provides protection for the emergency personnel as well as ensuring the privacy of those patients. And I think the body should commend Senator Chizek for all the time and effort he has put in in dealing with this very serious problem. Thank you.

SPEAKER BARRETT: Thank you. Any other discussion on the amendment? Senator Chizek, would you care to close? Thank you. The question before the body is the adoption of the Chizek amendment to 157. Those in favor vote aye, opposed nay. Record, Mr. Clerk.

CLERK: 27 ayes, 0 nays, Mr. President, on the adoption of Senator Chizek's amendment.

SPEAKER BARRETT: The amendment is adopted. To the bill itself as amended, Senator Chizek, would you like to explain the bill?

SENATOR CHIZEK: Mr. Speaker, I think, basically, the amendments are now the bill and I would just simply say that we have taken a lot of pains over two years to try and deal with everybody's concerns and I would urge the adoption of the...or the advancement of the bill.

SENATOR WESELY: Thank you, Mr. Speaker, and members, just a brief explanation and then Senator Smith will follow in the opening. The bill deals with two subject matters. One deals with burial expenses allowed under Medicaid. Currently, that's \$3,000. This is the amount you retain in assets to cover your burial expenses when you go on Medicaid. The cost of burials have gone up dramatically and the \$3,000 now allowed is woefully inadequate. This bill would increase the 3,000 to \$4,000 this year and then in two years it would go to \$5,000 so that we could allow these individuals who do go on Medicaid adequate resources to have a proper burial. In addition, the bill deals with the subject of personal care allowance in care facilities. Right now we allow \$30.00 to individuals a month to retain in terms of income that they have. The rest of their income then goes toward the expense of their care. This bill would increase from \$30.00 to \$45.00 the amount of personal care allowance that we provide. That's a quick summary of the bill and I will give the rest of my time to Senator Smith.

SPEAKER BARRETT: Senator Smith, please.

SENATOR SMITH: Thank you, Senator Wesely. Mr. Chairman and members of the body, I will also be very brief. The bill is...and Don has already told you what the provisions of the bill would be and I would just use some examples. I'm in and out of the nursing home in Hastings a lot, and I will just tell you, very personally, I have had a father-in-law there. You've heard me mention about the fact that he was there for a period of time before he passed away, and now my mother-in-law is there. And so I do visit often, and I have a lot of contact with the other folks that reside in that nursing home and a lot of phone calls from them. And one of the biggest concerns that they have is that presently they're only allowed \$30 personal needs allowance for their...all the personal kinds of needs that

And so what my amendment, and they should be passed out right now, does is substitute patient's attending physicians for the health care facility and so on for those tests to be done and it's really to conform the bill to the normal course of the way a hospital operates and works and this bill...this is a cleanup. I still strongly believe in the bill. This is not made to gut the bill in any manner. It's basically to conform to the way that the procedures actually work in a hospital. Other things that the amendment does is allow for the doctor or the attending physician to be notified if there are any positive test results and so on. There has not been any opposition to these amendments that I know of and I would ask for its adoption.

PRESIDENT: Thank you. Senator Chizek, please.
