It is assumed that the cost will be borne by the General Fund since the prestige plates are deposited...or the fees are deposited to the General Fund. This bill may generate increased General Fund revenue if the additional one character to the plate results in additional individuals applying. And I have been told there is about 12,000 people that now have prestige plates and they're estimating that if we add one more character to the plates, there will be approximately 18,000 that will apply for the prestige plates. I urge the advancement of LB 158 to E & R Initial.

SPEAKER BARRETT: Thank you. You have heard the motion. Is there discussion? Seeing none, Senator Labedz, any closing?
