ASSISTANT CLERK: 25 ayes, 0 nays on the advancement of the bill, Mr. President.

SPEAKER BARRETT: LB 828 is advanced. The final revisor bill of the day, LB 829.

ASSISTANT CLERK: LB 829 was introduced by Senator Labedz. (Read title.)

SPEAKER BARRETT: The Chair recognizes the member from the 21st Legislative District, Senator Peterson.

SENATOR PETERSON: Mr. Speaker, this is the last revisor bill although I have a bill that was introduced, 830, that is right under it. I presume we could take that up, too, Mr. Speaker. Just funning, yeah, mine is a...Mr. Speaker, and members, this bill would repeal a section relating to payments by certain prisoners that is obsolete. The bill also corrects internal references in two sections. I ask for the movement of the bill, Mr. Speaker.

SPEAKER BARRETT: Any discussion? Those in favor of advancement of the bill to E & R please vote aye, opposed nay. Record, please.

ASSISTANT CLERK: 27 ayes, 0 nays on the advancement of the bill, Mr. President.

SPEAKER BARRETT: LB 829 is advanced. Any new bills, Mr. Clerk?

ASSISTANT CLERK: New bills. (Read for the first time by title: LBs 1091-1095, LB 163A. See pages 259-61 of the Legislative Journal.) A new resolution, LR 237CA by Senators Wesely, Chambers, and Chizek. (Read brief explanation. See pages 261-63 of the Legislative Journal.)

SPEAKER BARRETT: Thank you. Moving to item seven, General File, 1989 Speaker priority bills, LB 37. Mr. Clerk.

CLERK: Mr. President, LB 37 was a bill originally introduced by Senator Rod Johnson. (Read title.) The bill was introduced on January 5 of last year. Mr. President, at that time, it was referred to the Agriculture Committee for public hearing. The bill was advanced to General File. I do have committee

SPEAKER BARRETT: Senator Beck, please.

SENATOR BECK: Thank you, Mr. President, and our good Clerk. I would just like to ask to move over the three amendments that I have, temporarily move over those, pass over those, and look towards Senator Moore's motion, which may be next on the agenda.

CLERK: Mr. President, Senator Moore would move to indefinitely postpone LB 163. Senator Johnson, as primary introducer, would have the option to lay the bill over, Mr. President.

SPEAKER BARRETT: Senator Johnson.

SENATOR JOHNSON: Mr. President, I ask to lay it over today.

SPEAKER BARRETT: So be it, the bill is laid over. That will, of course, be the case with LB 163A as well. Proceeding then to LB 543 on the agenda, Mr. Clerk.

CLERK: Mr. President, LB 543, introduced by Senator Chambers. (Read title.) The bill was introduced on January 18 of last year, referred to the Appropriations Committee. The bill was advanced to General File. I have committee amendments pending by the Appropriations Committee.

SPEAKER BARRETT: Thank you. In the absence of the Appropriations Committee Chair, Senator Chambers, could you perhaps handle the amendments?

SENATOR CHAMBERS: Yes, Mr. Chairman, I was downstairs listening to the debate on the solid waste bill. Senator Beck, knowing where I was, passed over some amendments and forced me to have to run up here, probably hoping I'd have a heart attack, which I almost did. But, anyway, this bill was rereferred to the Education Committee which held a hearing on it, so it would have been Senator Withem's committee. He and I have discussed it. And I have an amendment which I have offered, it's on the Clerk's desk. And anybody can get a copy whose interested in one. But I can tell you what it does. First of all, the program was put in place last year through a resolution. The money has already been appropriated, and the scholarship is underway. There was not enough time last year to consider the bill, and I feel, and I've discussed it with Senator Withem and others, that it still should be a statutory provision. There

to see LB 163 advance to Select File. I think we have a good opportunity to work with the various senators who have offered amendments this morning, to come together, hopefully, have a meeting of the minds on some of these ideas, and then get this bill passed this year. I think it is vitally important for Nebraska to begin moving on this issue before the hammer falls, in 1992, or whenever EPA standards come down. I think we need to be moving forward now so that we're prepared, we're ready to go, that we're not waiting until the last second, as we always seem to do, until there is a crisis and then we have to respond. The League of Municipality, the counties, many other private individuals have told me they're anxiously watching what happens to 163 because I think there are a number of communities out there who need the financial assistance to move forward, and this is the vehicle to do that. So I would ask the body to please advance LB 163 this morning.

PRESIDENT: Thank you. The question is the advancement of the bill to E & R initial. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

CLERK: 30 ayes, 0 nays, Mr. President, on the advancement of LB 163.

PRESIDENT: The bill is advanced. Before we take up the A bill, may I introduce Dr. Douglas Wheatly. Would you please rise so that we may recognize you. He is our doctor of the day from Omaha. Would you please welcome him. Dr. Wheatly, we appreciate your service for the day. And any of you members who feel faint or overweight or need a heart operation, please see Dr. Wheatly some time during today. Take up the A bill, Mr. Clerk.

CLERK: Mr. President, LB 163A was offered by Senator Rod Johnson. (Read title.) The bill was introduced on January 10 of this year, Mr. President. Senator Johnson, I do have an amendment from you, Senator. (The Johnson amendment is on page 353 of the Journal.)

PRESIDENT: Senator Rod Johnson, please.

SENATOR R. JOHNSON: Mr. President, members, rather than try and tell you what this amendment does off the cuff, I'm just going to read to you what this amendment does. This amendment to LB 163A removes the General Fund impact of the A bill.

Amendment 2018 to LB 163 allows the Department of Revenue to deduct their expenses from the fees collected under this bill. This amendment allows for the expenses of the Department of Revenue to be paid from the Waste Reduction Recycling Incentive Fee Collection refund rather than the General Fund. Because the Department of Revenue will use a portion of the fee revenue to offset their expenses, the amount available to the Department of Environmental Control is also lowered by a like amount. So the adoption of this amendment basically allows LB 163A to be 100 percent cash funded. I would move the amendment.

PRESIDENT: Any further discussion? If not, the question is the advancement of the A bill. All those in favor...excuse me, adoption of the Johnson amendment. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

CLERK: 25 ayes, 0 nays, Mr. President, on adoption of Senator Johnson's amendment.

PRESIDENT: The amendment is adopted. Senator Rod Johnson, on the advancement of the bill.

SENATOR R. JOHNSON: I would just ask that the bill be advanced to Select File.

PRESIDENT: You've heard the motion. All those in favor of advancing the bill vote aye, opposed nay. Record, Mr. Clerk, please.

CLERK: 28 ayes, 0 nays, Mr. President, on the advancement of LB 163A.

PRESIDENT: The A bill is advanced. Anything for the record, Mr. Clerk, or new bills?

CLERK: Yes, Mr. President, I do. Mr. President, your Committee on Retirement, whose Chair is Senator Haberman, to whom was referred LB 242, instructs me to report the same back to the Legislature with the recommendation it be advanced to General File with committee amendments attached. So I would urge the body to advance the bill.

SENATOR WESELY: Yes, Mr. Speaker, members, just very briefly, I rise to indicate for the record why it is I'm going to change position today on this bill. I have supported the concept of the state participating in the cost of indigent care. I have worked and led task forces and introduced legislation to this effect, but I've had conversations with the Nebraska Hospital Association about the two-way street we live on and then that two-way street, when additional public tax dollars go into any particular area, it seems to me that an amount of accountability is in order and unfortunately we have had a desire on the part of the hospitals in particular to ask and request for Medicaid increases, for this legislation on indigent care reimbursement and additional public monies, but when requested to participate in different health care cost containment initiatives they object and block every effort we make practically. For instance, I remember last year on certificate of need their efforts blocked my concerns about certificate of need and that process to contain costs was weakened dramatically as a result of legislation promoted by the Hospital Association last year. This year we have a health care cost data bill that has got the support of a number of different organizations and interests with the exception of the Hospital Association and they are working very hard, as you all know, to block that piece of legislation. If we were able to pass that, if we were able to work with them on the cost containment side of things, I very much support the work of Senator Lynch and those in support of LB 187. The concept is valid. The state should take a responsibility in this area, but before further monies get spent in this field or any other field that go into the hospitals in particular in this state it seems to me appropriate to ask those hospitals to work with us, the public, the taxpayers, the Legislature, to try and deal with the cost issue, the cost containment problem that we have across the State of Nebraska and across this country. And as long as the hand is out to receive the money but there is no assistance whatsoever to help us deal with the cost of this, I, for one, feel unable to support further funding in this manner. I would want to add that in some of the data, in some of the information we have

obviously a little disappointed that this issue was not signed. But I think it's a substantial enough issue to ask for an override.

PRESIDENT: Thank you. The question is, shall the veto on LB 163 be overridden? All those in favor vote aye, opposed nay. Record, Mr. Clerk, please. Rod Johnson.

SENATOR R. JOHNSON: Mr. President, members, I think it takes 30 votes, so I would prefer to have a call of the house and check in and a roll call vote, please.

PRESIDENT: Okay, will you please check in. Record your presence. Please check in. Please punch your green light. Please check in. Senator Wesely. Senator Schmit, please. Senator Schellpeper. Senator Goodrich. Senator Haberman, punch in, please. Thanks. Roll call vote, and the question is, shall the veto of LB 163 be overridden. Mr. Clerk. Hold your conversation down so the Clerk can hear you, please. Thank you. Reverse order has been requested. Okay.

CLERK: (Roll call vote taken. See page 2033 of the Legislative Journal.) 31 ayes, 16 nays, Mr. President.

PRESIDENT: LB 163 is overridden. LB 1019...LB 163A.

CLERK: Mr. President, Senator Rod Johnson would move that LB 163A become law notwithstanding the objections of the Governor.

PRESIDENT: Senator Rod Johnson, the A bill.

SENATOR R. JOHNSON: Mr. President, I'd simply move the A bill to be...to override the Governor's veto of LB 163A.

PRESIDENT: Any further discussion? If not, the question is, shall the veto be overridden on LB 163A? All in favor vote aye, opposed nay. Have you all voted? Record, Mr. Clerk, please.

CLERK: (Read record vote as found on page 2034 of the Legislative Journal.) 31 ayes, 13 nays, Mr. President, on LB 163A becoming law notwithstanding the objections of the Governor.

SENATOR SCHELLPEPER: Thank you, Mr. Speaker, and members, I also rise to support this override. We have some very dedicated employees in this state and I think this is just another thing we can do for the employees. So I think Senator Haberman said it all and I would just move for the override.
