PRESIDENT: LB 106 advances. May I introduce some more guests please. In the north balcony, guests of Senator Coordsen, we have Merlin Volkmer, Wayne Hansen, and Doug Dickenson. Would you folks please stand and be recognized. And also in the north balcony, Senator Schellpeper has Dale Barth of the Stanton REA. Dale, would you please stand. Thank you. LB 194.

CLERK: Mr. President, LB 194 offered by Senator Crosby and Senator Schimek. (Read title.) The bill was introduced on January 9, referred to the Urban Affairs Committee, advanced to General File. I have no committee amendments. I do, however, have an amendment pending by Senator Crosby. (See page 521 of the Legislative Journal.)

PRESIDENT: Okay, Senator Crosby, do you wish to take up your amendment first?

SENATOR CROSBY: Yes, please.

PRESIDENT: All right.

SENATOR CROSBY: Thank you. Mr. President and members, the amendment is offered for technical reasons, and as you will see when we come to the bill, it is for clarification. The amendment is offered to further clarify the intent or scope of LB 194. This amendment adds a provision for security so that a Business Improvement District could hire security personnel, if needed, during festivals or special event, high traffic times, like a football game. An emergency clause was added so that this groundwork would be in place in time for cities to pass an ordinance to establish new Business Improvement Districts, if that is needed. The amendment was offered to the Urban Affairs Committee and I believe accepted by the members of the committee, except that they inadvertently failed to adopt it. Maybe Senator Hartnett would like to say something about that.

PRESIDENT: Senator Hartnett.

SENATOR HARTNETT: Mr. Speaker, members of the body, I want to apologize to one of our new colleagues, Senator Crosby, because she did bring the amendment to us, and in our Executive Session which we had to do not at the normal time that we do Executive Session, we inadvertently forgot to add that amendment to it, so it should have been a committee amendment, and so she is offering it as an amendment now and I support the amendment

wholeheartedly. Thank you.

PRESIDENT: Thank you. The question is the adoption of the Crosby amendment. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

CLERK: 25 ayes, 0 nays, Mr. President, on the adoption of Senator Crosby's amendment.

PRESIDENT: The amendment is adopted. Now, Senator Crosby, back to your bill.

SENATOR CROSBY: Thank you, Mr. Speaker, Mr. Chairman. As I stated earlier, LB 194 is for clarification purposes. The bill changes the section that enumerates the uses for which cities may spend available Business Improvement District funds. This change addresses some perceived problems about whether some specific uses are included in the general language of the section, for instance, the use of fund money for general promotion of retail activity and advocacy activity for these districts, or the use of fund money to provide for security measures in the improvement district. If you need further background to explain the need, the Downtown Lincoln Association is working with the city attorney to form a Business Improvement District in downtown Lincoln. This district would include development of a management program for downtown to assure the vitality of the area. This is based on the concept "why can't downtown manage themselves like shopping centers do?" Management is one of the soft programs allowed by the existing Nebraska legislation for BIDs. To date, the legislation has been used only for capital improvement programs, such as, Lincoln's beautification projects. It is innovative in Nebraska to consider funding in areas of management through the BID, but not in other cities in the United States. For instance, it has been successful in Seattle, Los Angeles, Tulsa and Richmond, Virginia. Our city attorney in Lincoln has asked for the clarification of the existing legislation in those areas. The ability to use these funds to provide security personnel, if appropriate, to promote the retail area, as a whole, and to be an advocate, such as, to advocate activity for downtown housing. The Urban Affairs Committee voted unanimously to advance it after their hearing to General File and there was no opposition or neutral testimony. In speaking with the Nebraska League of Municipalities and the City of Omaha, they have no problems with this bill. I urge you to vote in favor of LB 194. The only

Mr. President, your Committee on Government, Military and Veterans Affairs whose Chair is Senator Baack to whom was referred LB 546 instructs me to report the same back to the Legislature with the recommendation it be advanced to General File; LB 639 General File, LB 76 General File with amendments, LB 196 indefinitely postponed, LB 635 indefinitely postponed, LB 752 indefinitely postponed, those signed by Senator Baack as Chair of the committee. (See page 793 of the Legislative Journal.)

Received a report from the Department of Roads, quarterly report from the State Highway Commission, and a report from the Equal Opportunity Commission, Mr. President. Those will be on file in my office. And that is all that I have, Mr. President.
