Mr. President, I have a request from Senator Smith to withdraw LB 112. That will be laid over. I believe that is all that I have, Mr. President.

PRESIDENT: Senator Lynch, are you ready to go back to work now? We will return back to adopting of permanent rules. Senator Lynch.

SENATOR LYNCH: Mr. President and members, I have one more proposed committee amendment, simple little amendment. It has to do with cloture. This change would adopt a cloture rule that would become effective after 12 hours debate at each stage of debate on any appropriation bill, and after 8 hours at each stage of debate on all other bills. To briefly explain it, and then Senator Moore will take it from there, let me give you a scenario. Some of you may be familiar with 428, the motorcycle helmet bill. It was my bill. An amendment, say, was offered under this rule by Senator Moore to the bill. As you know, sometimes amendments can take and need more time for discussion and debate than the bill, itself. After 8 hours of debate on Select File, I would move for cloture, or if that bill happened to be a committee bill, the chairman of the committee would move for cloture. The presiding officer then, under this proposal, would immediately recognize the motion and orders debate to cease on Moore's amendment. The vote on the Moore amendment would be taken without further debate. After that, a vote on the cloture motion without debate, 33 votes would be needed for that motion on cloture would be successful. If the cloture motion were successful, a vote on the advancement of the bill,

SENATOR LANDIS: Senator Withem recognized on behalf of Senator McFarland to introduce 228.

SENATOR WITHEM: Senator Landis, members of the body, LB 228 is a bill Senator McFarland brought to the Education Committee. It's a bill that was brought to the committee last year also and we just ran out of time. Deals with authorizing school districts to create contingencies funds to cover losses. Maybe I didn't even understand the bill particularly well last year, I think I do now, that we're not talking about reserve funds, we're not talking about keeping money back. We're talking about establishing a specific fund to which some funds can be set aside in case a loss comes up, loss meaning some sort of settlement of a lawsuit, some sort of insurance claim, something along this line to help pay the deductible on an insurance. The experts in the area of school finance, business managers and such tell us if there is a fund such as this set aside, that it helps considerably those business managers when they're out getting quotes from insurance companies, that through having this fund established and dedicated for the purpose of covering losses, they can get a lot lower bids on their insurance rates and can save taxpayers money in the long run. That's what the bill does very simply. If anybody has any questions or comments, I would attempt to respond to those. Senator Wesely has also indicated to me that he'd help out a little bit if we have any questions or comments on the bill. If there are none, I'd just urge you to advance the bill.

SENATOR LANDIS: There are no lights, Senator Withem. You're recognized for closing. Waives the closing. The question is the advancement of LB 228. Those in favor vote aye, those opposed vote no. The Clerk will record.

ASSISTANT CLERK: 25 ayes, 0 nays on the advancement of the bill.

SENATOR LANDIS: The bill is advanced. We'll move on to the A bill. I want to thank the members, the 25 of us who are here. Came across this one and noted that there was an amendment that I had meant to propose way back when it was in committee and we didn't. I had the amendment drafted and filed. I was gone to a conference on Thursday and Friday and haven't even had a chance to visit with him about this. What Senator McFarland's bill does, and may I also...maybe it ought to be pointed out that this was a bill that the Education Committee had heard last year, had advanced it with an amendment similar to the one I'm proposing to the full Legislature. We ran out of

time and did not get it considered. So what I'm proposing is an amendment similar to one that the Education Committee had proposed last year. LB 228 is a bill by Senator McFarland that would allow school districts to establish a contingency fund, that fund being used primarily to stand against potential losses, losses brought about through insurable types of losses. And it is the contention of the education community, the business managers' community anyway that having such a fund would allow them setting some money aside into this fund, would allow them to bring about lower insurance costs, which is a good idea and the committee advanced the bill. We did, a year ago though, put a kind of a safeguard in the bill so school districts would not be able to squirrel away huge sums of money into a contingency fund while keeping the property taxes as high and then just building up, and in essence using this as an excuse to build up a big reserve. So what we did, a year ago, was we put a percentage cap requirement that this fund could go no larger than, I think it was 2 or 3 percent last year. What I'm saying this year is, with this amendment, is that this fund would be no larger than 5 percent of the operating budget of the school district. It's my hope that the body thinks this is a good idea. It's my hope that Senator McFarland thinks it's a good idea, and I would urge you to return the bill to adopt this amendment.

SPEAKER BARRETT: Senator McFarland, would you care to discuss the motion?

SENATOR MCFARLAND: I just wanted to say I have no objection to the amendment, I think it's a good idea and it's a good bill. I'd urge you to vote in favor of returning it for the adoption of the amendment, and then advancing the bill. Thank you.

SPEAKER BARRETT: Thank you. Any other discussion? If not, the question is, shall the bill be returned? Those in favor vote aye, opposed nay. Record, please.

CLERK: 32 ayes, 0 nays, Mr. President, on the motion to return the bill.

SPEAKER BARRETT: The bill is returned. Senator Withem, on the amendment.

SENATOR WITHEM: The amendment places a 5 percent cap that the Contingency Fund can be no larger than 5 percent of the

operating budget. Again, apologize to Senator McFarland for not visiting with him earlier, but circumstances kind of prevented that. I appreciate his support of the amendment, would urge you to adopt the amendment.

SPEAKER BARRETT: Any discussion? Seeing none, all those in favor of the adoption of the amendment vote aye, opposed nay. Record, please.

Revenue that this is an issue that was a clarification process. We've done that three or four times this year on other bills. And, Mr. President, I have a communication from the Chair of the Reference Committee rereferring study resolution LR 88 from the Banking Committee to the General Affairs Committee. That is signed by Senator Labedz as Chair. And that is all that I have, Mr. President.

PRESIDENT: We'll go to Final Reading on number 9. We'll start with LB 429, but we need to get into our seats and get ready for Final Reading, please. Mr. Clerk, LB 429.

sets up...allows school districts to set up a contingency fund to cover for losses. Earlier this week, the end of last week, whenever it was, we filed an amendment. The intent of it was to limit the amount in that contingency fund to no more than 5 percent of a school district's budget, so that there would be some cap. It couldn't just become a slush fund. The language we used was 5 percent of the General Fund balance. The General Fund balance, through the course of a year in a school district, deviates from sometimes upward to 60 percent maybe of their budget down to sometimes even in the red. So we found that that amendment, the short of it is that amendment was improperly drafted, and we need to pull that bill back from the Governor's Office, reconsider the final passage, return it to Select File, put on an amendment to make it right. It's all very simple and easy and the bill was a noncontroversial piece of legislation. We just need to bring it back from the Governor's Office in order to do the amendment properly. Would appreciate it if you'd vote to do so.

SPEAKER BARRETT: Thank you. Senator Abboud, would you care to discuss the motion?

SENATOR ABOUD: Yes, Mr. President, would Senator Withem yield to a question?

SPEAKER BARRETT: Senator Withem, would you respond?

SENATOR WITHEM: Certainly.

SENATOR ABOUD: Senator Withem, did the Governor's Office threaten to veto this bill unless these changes were made, or...
