This is an industry that does not control its own pricing, we know is an economic downturn, different from all of the rest of the economy. They do not share in the rise of the economy. They only rise with the federal budget. The farm economy does well when the federal government allows it to do well but not according to the pricing or market mechanisms that govern the rest of the economy. But let us not throw away the key to action in this area. And, frankly, Senator Wesely raised a good point. Our initiative last year failed to bring real property tax relief because of the unexpected rise in local I agree with Senator Wesely on that point.
