Mr. President, hearing notices from Judiciary, signed by Senator Chizek as Chair; Revenue, signed by Senator Hall as Chair. Mr. President, a series of reports, two from the Lewis and Clark and the Middle Niobrara NRD districts regarding payment of January 26, 1989 LB 175, 261

employment situations. Again, I think if Senator Coordsen is correct, the \$50 just brings it in line with some of the other boards. I think that is entirely consistent. As I said, it is a financial impact of \$1,000. I don't see that as very dramatic and I don't see it setting any precedent that we are exceeding an amount that other boards would then try to match. Apparently, already the \$50 limit has been reached on other boards and we would be just bringing them into line as far as payment for other boards. And, really quite honestly, I haven't really opposed the increase from 40 to 50 dollars, but in my view, the original bill which proposed \$70 had a real semblance of legitimacy to it in that if you take what \$40 was worth back in 1977 and you figure in inflation over the past 12 years, \$40 in 1977 is probably equal to about \$70 in 1989. So, but in any event, I have not made a big issue of that. I think \$50 for this year is appropriate, and maybe as Senator Warner says, we need to address and look at the whole broad picture. I would urge your advancement of LB 175.

SPEAKER BARRETT: Thank you, sir. The question is the advancement of LB 175 to E & R Initial. All in favor vote aye, oppose nay. Record, please.

CLERK: 29 ayes, 0 nays, Mr. President, on the advancement of 175.

SPEAKER BARRETT: The bill is advanced to E & R. LB 261.

CLERK: LB 261, Mr. President, was a bill introduced by Senator Kristensen and Senator Robak. (Read title.) The bill was introduced on January 9, referred to Business and Labor, advanced to General File. I have no amendments to the bill, Mr. President.

SPEAKER BARRETT: The Chair recognizes the distinguished genuleman from Minden, Senator Doug Kristensen.

SENATOP. KRISTENSEN: Thank you, Mr. President, and I think I appreciate that. LB 261 amends Section 48-186 of our statutes and deals with the Workers' Compensation Court. As you all know, workers' compensation is a body of law that deals with employees and employers in injuries that employees suffer while they are on the job. This is a quite a busy area of law in the State of Nebraska. Right now when accidents occur by an employee on the job, the hearing and the dispute about that

claim will be held in whatever the county the injury occurs in long as the injury occurs in the State of Nebraska. as This bill addresses those injuries that occur outside the State of Nebraska but still affect a Nebraska employee. An example of that may be a Scottsbluff employee who is hired in Nebraska and who goes to work, let's say in Wyoming, and is hauling some construction materials or has a job over in Wyoming. He is injured in Wyoming and he comes back to his employer, he wants to have his workers' compensation case heard. Because it occurred in the State of Wyoming and outside of our state, that hearing goes to Lincoln and, so, he goes to Lincoln, his employer goes to Lincoln, his doctor goes to Lincoln, all the way in for these hearings. He also has the option of going to The trouble is they have a different law than we have Wyoming. and their system is much different. What this bill would allow us to do is to have the Workers' Comp Court decide which county this out-of-state hearing can be held in. So in other words, not everybody from Scottsbluff, in my example, would have to come into Lincoln, that the court could come on out and have that hearing in the western county. Now this applies, basically, to any county that surrounds a border in this state. That would include Omaha as well. It gives the flexibility of the court to set the hearing and it is a matter of convenience for employees and employers all over the state, and I would be happy to answer any questions, but I would urge the advancement of this bill.

SPEAKER BARRETT: Thank you. Is there discussion on the advancement of 261? Senator Coordsen, followed by Senator Robak.

SENATOR COORDSEN: Thank you, Mr. Speaker, members of the body. I think, as Senator Kristensen explained, this bill extends government to the people a little better in line with what we did several years ago in the court of allowing them the opportunity to carry their services out to the people. I think this bill is a necessary addition and I would urge its adoption.

SPEAKER BARRETT: Thank you. Senator Robak.

SENATOR ROBAK: Mr. Speaker and members of the Legislature, I ask for your support of LB 261. Senator Kristensen has done a fine job of explaining the merits of LB 261. For the record, let me just simply say that LB 261 applies only to cases where the injury has occurred outside of the State of Nebraska. The

court already hears instate cases, injury cases in the county where the injury has occurred. Allowing the Workers' Compensation Court to hold hearings in all the counties for all cases will make it easier for the injured workers to get their cay in court. I ask for your support of LB 261.

SPEAKER BARRETT: Thank you. Further discussion? Seeing none, Senator Kristensen, you are entitled to a closing statement.

SENATOR KRISTENSEN: I would waive closing, your honor, please.

SPEAKER BARRETT: Thank you. The question then is the advancement of LB 261 to E & R Initial. All in favor vote aye, opposed nay. Record, Mr. Clerk.
