CLERK: Mr. President, LR 3 is offered by Senator Baack and a number of the members. It is found on page 108. (Read.)

PRESIDENT: Senator Baack, please.

SENATOR BAACK: Mr. President and members, I bring this resolution in memory of my predecessor, Senator Clark from Sidney, and for his family who remains. I did allow an opportunity for all of the members who are still in the body that served with Senator Clark and most of them signed the resolution. I would also say that our Lieutenant Governor did an excellent job at the memorial service for Senator Clark in commemorating his service to the state and to his community. So, with that, I would urge your adoption of the resolution. Thank you.

PRESIDENT: Thank you. You've heard the motion. All those in favor vote aye, opposed nay. Have you all voted on the resolution? Record, Mr. Clerk.

CLERK: 31 ayes, 0 nays, Mr. President, on adoption of LR 3.

PRESIDENT: The resolution passes. We'll move on to bill introduction. Mr. Clerk.

CLERK: Mr. President, new bills. (Read LBs 280-288 by title for the first time. See pages 133-36 of the Legislative Journal.) That's all that I have at this time, Mr. President.

PRESIDENT: We'll move on to the revisor's bills then, under number eight.

CLERK: Mr. President, revisor bills, series of revisor bills this morning. The first is LB 1. It's a bill offered by Senator Labedz, as Chairperson of the Executive Board. (Read title.) The bill was introduced on January 5, Mr. President, referred directly to General File.

PRESIDENT: Senator Labedz, please.

SENATOR LABEDZ: Thank you, Mr. President. SPEAKER BARRETT: LB 134 is advanced to E & R. Anything for the record, Mr. Clerk?

CLERK: Mr. President, I do. Thank you. Your Committee on Transportation, whose Chair is Senator Lamb, to whom was referred LB 115, instructs me to report the same back to the Legislature with the recommendation it be advanced to General File; LB 283, General File; LB 284, General File; LB 58, General File with amendments; LB 142, General File with amendments; LB 156, General File with amendments; and LB 128 indefinitely postponed. Those are signed by Senator Lamb. (See pages 439-41 of the Legislative Journal.)

General Affairs Committee, whose Chair is Senator Smith, reports LB 298 to General File, LB 70 to General File with amendments, and LB 62 indefinitely postponed. Those signed by Senator Smith as Chair. (See page 441 of the Legislative Journal.)

Your Committee on Education, whose Chair is Senator Withem, reports LB 312 to General File with amendments. That is signed by Senator Withem. Banking, Commerce and Insurance reports LB 279 to General File; LB 296, General File; LB 321, General File; LB 322, General File; those signed by Senator Landis as Chair. (See page 442 of the Legislative Journal.)

Mr. President, I have hearing notices from the Natural Resources Committee, signed by Senator Schmit; Health and Human Services, signed by Senator Wesely. That's all that I have, Mr. President.

SPEAKER BARRETT: Thank you. While the Legislature is in session and capable of transacting business, I propose to sign and I do sign LB 13, LB 18, LB 19, LB 20, LB 21, LB 22, LB 23, LB 24, LB 25, LB 26, LB 27, and LB 28, and LB 29, LB 30, LB 31, and LB 32. The next bill, Mr. Clerk, LB 255.

Registration Operations Cash Fund, this particular portion of the statute did not get changed. And that, basically, is the bill, Mr. Chairman.

SPEAKER BARRETT: Thank you. Any discussion on 283? Anything further, Senator Lamb? Thank you. Those in favor of the advancement of LB 283 please vote aye, opposed nay. Record, please.

CLERK: 32 ayes, 0 nays, Mr. President, on the advancement of LB 283.

SPEAKER BARRETT: LB 283 is advanced. LB 284.

CLERK: Mr. President, LB 284 is a bill introduced by the Transportation Committee and signed by its members. (Read title.) The bill was introduced on January 10, referred to the Transportation Committee for public hearing, advanced to General File. I have no amendments to the bill, Mr. President.

SPEAKER BARRETT: Chairman Lamb, please.

SENATOR LAMB: Thank you, Mr. President. LB 284 deals with identification cards. You will recall a few years ago we established a system of identification cards primarily for those people who do not have drivers' licenses in this state. The drivers' licenses have sort of become an identification card, and those people who do not have drivers' licenses do not have the benefits of that card for identification purposes. identification card which has been in existence will undergo some changes in this bill. Currently, the card never expires and that is changed. It is changed, all the conditions concerning the card are now or would be under this bill some very similar to those with the driver's license. The cards will be issued by the county treasurer following application to the driver's license examiner, and that tightens it up somewhat because previously those cards were issued by the county treasurer only upon showing one form of identification. cards will bear a color photo of the holder, a different color background shall be utilized for minors. In order to get the card, you have to have two forms of identification rather than one. Cards shall expire upon the birthday in the first year after issuance in which the holder's age is divisible by four which is similar to drivers' licenses, and the fee will be \$10. Those valid for less than four years are at a lesser rate; three

or more years, \$10, two years but less than three years, \$8, one year but less than two, \$5.50. Cards valid less than one year, \$3.50. Basically, that is it. A duplicate card may be obtained from the county treasurer upon payment of \$5, and it is declared lawful for any person to display or have in their possession, unlawful, any fraudulently altered card, to make false statements in the application. I would move the bill be advanced.

SPEAKER BARRETT: Discussion on 284, Senator Withem.

SENATOR WITHEM: Yes, Mr. Speaker and members, Senator Lamb, would you respond to a question. This seems like an excellent bill. I am going to support it and all. I just had a question about point two here in your summary of purpose, and I couldn't find in the bill where it refers to that, but does this bill...it looks like from the fiscal note there are about 100,000 of these in existence around the state. Does this bill make all of those invalid on the date that this bill becomes effective, I assume sometime August or September of this year, or is there some sort of phase out of the current ones, when they would have to get those replaced?

SPEAKER BARRETT: Senator Lamb.

SENATOR LAMB: Any identification card issued under prior law prior to the operative date of this act shall be invalid after such date and, yes.

SENATOR WITHEM: So the intent is sometime between when we pass this bill and the effective date of it, these people need to become aware that their current card becomes invalid and get into the treasurer's office and get one of these new ones?

SENATOR LAMB: I believe that is correct.

SENATOR WITHEM: Okay. Yeah, I guess the department...I would hope that the department would go through some notification process so that people become aware of this change, and it might be something to think about, putting some sort of phase in so they don't all become invalid on the same particular date, only a question raised for you and the committee to consider. I think everything else there seems like an excellent bill and I am going to support it and I think it is a good idea.

SENATOR LAMB: Thank you for that suggestion. We will check it out.

SPEAKER BARRETT: Anything further on the bill? Senator Lamb.

SENATOR LAMB: No.

SPEAKER BARRETT: Thank you. The question before the body, then, is the advancement of LB 284 to E & R. Those in favor vote aye, opposed nay. Record, please.

CLERK: 29 ayes, 0 nays, Mr. President, on the advancement of 284.

SPEAKER BARRETT: LB 284 is advanced. LB 58.
