Mr. President, Senator Hartnett would move to amend by striking original Section 39.

SENATOR HARTNETT: Mr. President and members of the body, 39 is...

LR 211 at the request of the Nebraska Power Association. The Nebraska Power Association and its various members are deeply concerned by the fact that the Congress continues to pass laws such as the Tax Reform Act of 1986 that make it increasingly difficult and more expensive for state and local governments to use tax exempt bond financing. Tax exempt bond financing is a single most important source of revenue for state and local governments to use for roads and bridges, schools, waste water treatment, gas, utilities, solid waste management, drinking water facilities and that sort of public expenditure. The loss of this financing tool would probably add 20 to 30 percent to the cost of borrowing for state and local governments. This, of course, is just one more method whereby the various taxpayers have to increase their cost to government and in some ways it's rather an insidious method. The passage of LR 211 would send a signal to our congressional delegation and others that the continued use of this financing tool is critical to local government's ability to provide basic local services. I would be glad to answer any questions you might have and, if not, I would move for the adoption of the resolution.

SPEAKER BARRETT: Thank you. Any discussion? If not, those in favor of the adoption of LR 211 please vote aye, opposed nay. Record, please.

CLERK: 29 ayes, 0 nays, Mr. President, on adoption of LR 211.

SPEAKER BARRETT: The resolution is adopted. General File, A bill, Mr. Clerk.

CLERK: Mr. President, LB 289A was introduced by Senator Schmit. (Read title.)

SPEAKER BARRETT: Senator Schmit, please.

SENATOR SCHMIT: Mr. President and members, LB 289A is the financial support bill for LB 289, the so-called underground tank cleanup bill. As you know, there have been somewhat deep concerns expressed recently relative to the substantial environmental cost and impact of the various leaks that have been caused by a substantial number of different kinds of tanks that have been buried underground in some instances for many, many years. LB 289 is an attempt to provide and create a fund for that cleanup effort and at this time we need the A bill. There will be some additional amendments to LB 289 which should

substantially, if not totally, reduce the dependence upon the General Fund monies. The entire cost of the bill should be cash funded as we move into the implementation of the bill. I move for the implementation, for the introduction of the bill.

SPEAKER BARRETT: Thank you. Any discussion? If not, those in favor of the adoption of 289A please vote aye, opposed nay. Record, please.

CLERK: 27 ayes, 0 nays, Mr. President, on the motion to advance LB 289A.

SPEAKER BARRETT: LB 289A is advanced. Members, please return to your seats for Final Reading. Members will return to your seats for Final Reading. Unauthorized personnel, leave the floor. Before proceeding into our Final Reading agenda, let me share with members some thoughts that I do have for the remainder of the week, if I may have your attention, please. You have the agenda before you for today, the 83rd day, and as we move toward Friday evening, which will be our last day to amend and return, it is my hope that we can get started on the addendum which you have on your desks today as well. Obviously, that would come rather late in the day today. On today's agenda, the bills that are listed to be amended or be returned or not returned, as the case may be, have some what I consider rather substantive amendments on them. It is not my plan to read any of these bills today but to try to determine whether or not they are to be returned. It is also my hope that we will be able to use discretion in getting through the agenda today so that we can get started on the addendum that you have on your desks. Tomorrow we will start on the budget, budget bills on Select File and, if time allows, additional bills that are being returned to Select File for amendments. The earliest the budget can be read is Friday, with a rule suspension, so you might keep that for future reference as well. Wednesday, May 17th, bills on Final Reading which are to be returned for amendments; Select File, priority bills that failed to advance on General File. For all intents and purposes, General File is finished for this session. There are General File priority bills which failed to advance. They might be considered, time permitting. That is a great big question. Thursday, a continuation of Wednesday's agenda and Final Reading of bills without A bills; again Select File, priority bills which failed to advance on Select File, time permitting, again, a large question. Friday, read budget bills, read bills with A bills attached that were not returned,

PRESIDENT: Senator Kristensen, please.

SENATOR KRISTENSEN: Thank you, Mr. President. Mr. Clerk, is that the one that is printed on page 2149?

SENATOR KRISTENSEN: Thank you. Mr. President and members of the body, I almost shudder to say this but I think this might be one of the amendments to this bill that shouldn't receive a whole lot of controversy. What it is, and it deals with two things in specifics, most of you have probably been contacted by constituents of Senator Morrissey, myself, or Senator Dierks. You have probably seen people with their frustration levels at their highest, not only on the floor, but in the halls, and certainly within the communities that have been picked as potential host sites for this facility. One of the common themes, at least when I go out and do town hall meetings in those areas, is that there is a lot of tensions, a lot of scared people, a lot of people that have some grave concerns about the future of not only just their own personal lives and their farms and their communities but what is perceived about these farms and communities, and about what sort of image and cloud is going to be cast over them in the future, if they are selected, or the fact that they are just under consideration. I had several people come to me, and in particular a couple of ministers who are doing a lot of good work in that area in terms of counseling, and they have received a rash of people searching for some answers and some consoling, and, if for nothing else, just how to cope with this anxiety. The way we cope in here is we call the question, we take our votes, they are either up or they are down, and we can go on with the issues because we know

I know that those of us in the rural areas, particularly, as Senator Landis pointed out, appreciate your concern, and as we hold those hearings this summer, please try to participate and come out so that we can resolve these issues in an unhurried manner. I move for the adoption...or advancement of the bill.

SPEAKER BARRETT: The question is the advancement of the bill to E & R Engrossing. All in favor say aye. Opposed no. The ayes have it. Carried. The bill is advanced. To the A bill.

CLERK: Mr. President, LB 289A, I have no amendments to the bill.

I think it has flaunted its executive power too often for us to allow this sort of flexibility to be allowed under the law. I want to start back with the passage of LB 965, which is what is being amended here today. That was passed in 1986. Now 1986 is a mere three years ago, but as I counted, there are 20 of you that weren't here at that time, 20 new senators that have come onto the Legislature in 78, 79...I mean '87, '88, and '89. So there are 20 of you that aren't around and don't have the history involved, and I would like to give you a little bit of that institutional memory so you understand a little bit of why this is an important issue. Back in 1986, we followed up on a 1985 ad hoc committee on economic development which I chaired trying to look at problems that were identified with the Department of Economic Development. Now this was back at a time when we had...

And even though it has repeatedly been made...the point has repeatedly been made that we have, quote, to use Senator Landis's words, "built a wall here" to separate state funds from those other funds.
