Your Committee on Appropriations whose Chair is Senator Warner to whom was referred LB 301 instructs me to report the same back to the Legislature with the recommendation it be advanced to General File with amendments, as are LB 302, LB 303, LB 303A, LB 305, LB 308, LB 309, LB 309A, LB 310, LB 469, and LB 727, all reported to General File, all having committee amendments, all signed by Senator Warner as Chair. (See pages 1831-39 of the Legislative Journal.)

Mr. President, Senator Warner would move for the introduction of Committee Reg. 1249.

PRESIDENT: Senator Warner, please.

SENATOR WARNER: Mr. President and members of the Legislature, Req. 1249 would be the mainline budget bill. It would include everything other than...well, obviously, the bills, the constitutional officers are separate, legislative salaries are separate, salaries are separate, health insurance is separate, but this would include the other recommended appropriations for state agencies and state aid programs. I would move the suspension of the rule to permit its introduction.

PRESIDENT: Any further discussion? If not, the question is the introduction of the appropriation bill as described by Senator Warner. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

CLERK: Mr. President, 301 was a bill that was introduced by the Speaker at the request of the Governor. (Read title.) The bill wis introduced on January 10, referred to Appropriations, advanced to General File. I have committee amendments pending by the Appropriations Committee, Mr. President.

PRESIDENT: Senator Warner, are you going to handle this one?

SENATOR WARNER: Mr. President, members of the Legislature, this is, as you will recall, is the bill for the salaries of constitutional officers which is required by the Constitution to be in a separate appropriation bill and it includes the Supreme Court, the Clerk of the Supreme Court, Reporter of the Supreme Court, 53 district and juvenile judges, 57 county judges and then the Governor, Lieutenant Governor, Secretary of State, ٠

Auditor, Attorney General, Secretary of State, Public Service Commission and the Tax Commissioner which is also an office which is named in the Constitution. The committee amendment to the original bill does three changes. As you will perhaps recall and you will notice it in every agency, that under the risk management pool, workmen's compensation for all agencies of state government will function somewhat as an insurance policy in which every agency contributes to the insurance pool for workmen's comp covering state employees proportionate to the number of employees, of course, they have and with experience it will also reflect a loss ratio, but this amendment adds to the workmen's comp premium, if I may call it that, for that insurance pool for the constitutional officers that was outlined. In addition there is also an amendment that reflects change in social security as has been calculated and then the major change, however, which is more than a type of change that I have described, is that I think most people will recall that under the statutes, Lancaster County, when it reached 200,000 population was to have an additional juvenile judge and I believe there was a letter from the Attorney General indicating some time ago now that one was not required to wait until the federal census had been completed or in 1991, but rather that determination of 200,000 would take effect before that. So the that three-fourths of a year amendment provides for an additional juvenile judge in Lancaster County and, of course. the full year for the second half of the biennium. The amount for the three-quarters of a year is, with salary plus benefits, \$51,263 and the full year's salary with benefits, \$72,289. I would move adoption of that amendment to LB 301.

PRESIDENT: Any further discussion? If not, the question is the adoption of the Warner amendment to LB 301. All in favor vote aye, opposed nay. Need a little bit of help, ladies and gentlemen. We're voting on the adoption of the Warner amendment. Record, Mr. Clerk, please. Thank you.

SENATOR MOORE: Yes, Mr. President, and members, I know we are all busy, a beehive of activity this morning, but this first thing out of the shoot is of some significance. You may or may not want to listen. What this is is the approval for the bond financing of Phase III of the rec center construction. Those of you that were around in 1987 will remember at that point in time when we approved the indoor practice facility, that was the first of three phases of activity in the total hyperfitness area, whatever it was called, I forget. And Phase I and Phase II have already been... Phase I and Phase II have already been either built or in the process of being built and paid for, and the university is coming down...coming back with LR 223, and if you remember back, LR 69 two years ago, it basically said ... we basically said we approve Phase I and Phase II and Phase III; if on the chance that when you go to Phase III, and Phase III is rebuilding of the coliseum, which I would like to explain a little bit, if we get to Phase III, it is the university's choice to use bond financing, and they must come back to the Legislature for our approval. That is, indeed, what has occurred. That is what LR 223 is talking about. It grants the authority for the university to bond up to \$4.9 million for the UN-L recreation/athletic facility. Now as you remember, the indoor practice facility, you all remember, Phase II of that

Mr. President and members of the Legislature, as you know, the rule requires that the Appropriation Committee make a report to the Legislature on the overrides of the mainline bills, in this the only two, well, three of them, LB 301, LB 308, which case, the committee's recommendation is for no overrides, and I will indicate to you that on 301, it dealt with judges salaries and there was a simple clerical I suppose you would call a math error which was in the bill from the Governor's bill through ours that was just simply never caught and so that is of no consequence. The second one on LB 308, it is 150,000, and at least in the claims portion which was reduced by the Governor, the number that the bill had in it originally would have been a number suggested to us by the agency probably six weeks ago now, maybe two months almost of a. estimate, that is a deficit bill, of an estimate of what might be needed. My assumption can only be that with further time that the estimate of the amount of funds that are needed was reduced, hence we saw no need to However, on LB 813 and 814, we had a divided override that. vote of five to four, five members voting to recommend no overrides be enacted of the Governor's vetoes on those two That was the one option. The other option was to bills. recommend all of them, and the other is to take no position, and the third option was to make selected recommendations. However, I wish to call your attention, I suspect there may be some, and I hope it is not confusing, but there are some overrides that might be offered that by the nature of the bill's drafting, and it is drafted no different now than it has always been, but there may be more than one item within the same program and there is no way to separate those overrides. They both go or neither goes. In other cases, there could be many items where there is a lump sum appropriation to an agency, it might be many items, but by and large, there is no way to selectively override. You do them all or none. In other instances, there are a handful, some of you I suspect have already prepared motions, in which the dollar amount to the agency was vetoed but also some earmarking money within the budget where the language would say to the effect that contained within the appropriation is X amount of dollars for some purpose. You can override those earmarks, but that will not add any money to the appropriation to the agency. So whenever we do that, that particular function would be funded but also something else would not be, and we would not know what that is. So those things, you can argue it doesn't take any more money to make the override but you will be making a cut indirectly into something else.
