There also was a repeal of Section 4 in the original bill which was old and obsolete, was no longer necessary, and then it restricts Section 2 of the bill, which authorizes employer-representatives adjust terms and conditions of employment nonrepresentative employees to be consistent with those settled for representative employees through collective-bargaining What this amounts to is that there was a part for this coming year, for 1989-90 only, there is the practice of those benefits that were gained by collective bargaining through those employee groups that have collective bargaining would also accorded to nonrepresented employees so that there would be similar treatment for all employees but it is limited to and for the following fiscal year, '90-91, there will need to be addressed a number of issues, some of which were in bills introduced this session in other committees that have not been processed, but there are some long-term policy changes that need to be addressed, but for the coming fiscal year would have identical same practice that was used last year in that there would be similar and equal treatment for some of contracts...bargaining bargaining conditions, rather, represented and unrepresented employees alike and including those that are in constitutional offices and are outside of the bargaining contracts by the Department of Personnel. that, I would move adoption of the committee amendment to 309.

It changes, does nothing more than change the amount of compensation that the Board of Directors currently receive which is \$200 a month to \$500 and for the Chairman of the Board to \$600. Currently, the Chairman receives 250. The increase, I think, is justified in that it has not been increased since 1972, for 17 years. This is a board of five that is appointed by the Mayor of Omaha. They are responsible for a budget of nearly \$20 million. They have a number of They serve over 20,000 customers a day with regard employees. to the number of riders in the metro area and responsibilities with regard to the operation of the transit authority are numerous, as well as the liability that is involved with any operation of this nature. So the compensation question whether or not it is justified, I don't think can be raised but it is an issue that I think should be addressed and I would appreciate support, first of suspending the rules in order to allow the amendment to be considered, and then of adopting the amendment to LB 309. And I use LB 309 as a vehicle because it deals with the issue of salaries for state employees. I urge the body to first suspend Mr. Clerk...Mr. President, so that we could consider amendment.

SENATOR LAMB: The motion is to suspend the germaneness rule in order to take up the amendment by Senator Hall. The first speaker is Senator Warner.

SENATOR WARNER: Mr. President and members of the Legislature, I have no objection to the amendment.
