The purpose of the motion is to suggest that these two appropriations bills, which are aligned with 303A...or 303 and 309, the salary bill and the health insurance bill, go to the Appropriations Committee as opposed to being referenced directly to General File. The A bills have come over from the Governor's office for the first time, at least in my memory, as A bills, and it seems only practical that the A bills go along with the policy statement in 303 and 309, let the Appropriations Committee handle them, amend or change, if necessary, and come back with the main line bill. That is essentially it, Mr. President. I would move for the adoption of the motion to suspend the rules.

PRESIDENT: Thank you, Senator Barrett. The question is the suspension of the rules, and at the same time you are voting on sending these two bills to the Appropriations Committee. So it will be one vote, requires 30 votes. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

It would include everything other than...well, obviously, the bills, the constitutional officers are separate, legislative salaries are separate, salaries are separate, health insurance is separate, but this would include the other recommended appropriations for state agencies and state aid programs. The purpose of this amendment is to provide a personal service limitation flexibility to the State College Board of Trustees, specifically to take care of the options should they wish to use sources other than General Funds for

salary increases. An area of particular concern this year has been professional staff salaries and so this would simply change the personal services limitation to indicate that if funds other than funds appropriated in this section are utilized for salary improvements in fiscal year '89-90 and '90-91 personal service limitations for the state college system may be administratively increased to reflect utilization of such other funds. As I mentioned, there is an amendment to that amendment up there which clarifies that General Funds will not replace, at some point in the future, any decisions made at this time. But it is simply a mechanism to provide some flexibility to the individual campuses to make the salary adjustments. Thank you.

SENATOR LAMB: Is there any discussion in regard to Senator Scofield's amendment to Senator Scofield's amendment? If not, Senator Scofield, do you have any closing? She waives closing. The motion is the adoption of the Scofield amendment to the Scofield amendment. Those in support vote aye, those opposed vote no. Have you all voted? Record, Mr. Clerk.

CLERK: 26 ayes, 0 nays, Mr. President, on adoption of the amendment to the amendment.

SENATOR LAMB: The amendment to the amendment has been adopted. Senator Scofield, on the amendment.

Basically, what we have is you're taking the section of the bill that addresses the training funds, takes a million dollars out of the penalty interest fund from employment security, creates this Cash Fund with Economic Development for training purposes. Now I guess my posture is this will be...if this is done, you will then have four agencies of state government, that I'm aware of, in the training business. You will have the Department of Labor. You will have Social Services. You will have Voc Rehab and now Economic Development. I understand the arguments of those people who support Economic Development now getting into the job training business. The Department of Labor, historically, has been the training arm. The Department of Labor has 35, 40 years experience. There have been occasions where they have housed one of their people with Economic Development to help set up whatever structure is necessary, whether it be for a new employee or whether it be for a training program. The Department of Labor has offices from one end of the state to the other. The Department of Labor has staff in place. Obviously, colleagues, you know that Economic Development doesn't have all of the staff in place. As late as yesterday, we were dealing with four additional offices. So I think that if we're going to take the penalty interest money that the employers in this state pay on unemployment insurance and give it to Economic Development for training, I think we're making a mistake. Bear in mind you already have three state agencies in the training business. If you want to have another agency who is starting with a million dollars for training, if
