SENATOR L. The report was unanimously adopted by the Committee on Committees, and I, therefore, move at this time that it be accepted and approved by the Legislature.

PRESIDENT: Is there any discussion? If not, the question is the adoption of the report. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

CLERK: 28 ayes, 0 nays, Mr. President, on adoption of the Committee on Committees report.

PRESIDENT: The report is adopted. Back to you, Mr. Clerk. We're ready for the introduction of new bills. Mr. Clerk.

CLERK: Mr. President, new bills. (Read LB 1-80 by title for the first time. See pages 44-61 of the Legislative Journal.)

PRESIDENT: If I could have your attention just a moment, please, we'll introduce a couple of guests. Over under the north balcony, our first doctor of the day for this year is Dr. Dale Michaels of Lincoln, Nebraska. He's from Senator Warner's district. He's here to take care of us on behalf of the Nebraska Academy of Family Physicians. So would you welcome Dr. Michaels. Would you please stand, Doctor. Thank you for

PRESIDENT: If you don't have anything to do, there is some dry edible beans up in front here, if you would like to help yourself you may. John Weihsing knows all about them, so you can ask him if you want to know how to cook them or anything. (Gavel.) Senator Weihsing.

SENATOR WEIHSING: Mr. President and members of the Legislature, this year Nebraska is number one in the production of dry edible beans. I thought that you should realize that we have a very high standing with the production in the nation.

PRESIDENT: Mr. Clerk, you have something to do.

CLERK: Mr. President, your Committee on Agriculture, whose Chair is Senator Rod Johnson, to whom was referred LB 35, instructs me to report the same back to the Legislature with the recommendation it be advanced to General File; LB 36 and LB 38 to General File, all signed by Senator Johnson as Chair.

Mr. President, new bills. (LBs 496-536. Read for the first time by title. See pages 258-66 of the Legislative Journal.)

Mr. President, in addition to those items, I have the hearing notice from the Health and Human Service Committee. Mr. President, a Reference Report referring LBs 463 through 495.

Mr. President, Transportation Committee, whose Chair is Senator Lamb, to whom was referred LB 79, instructs me to report the same back to the Legislature with the recommendation that it be advanced to General File with committee amendments attached, and LB 158 to General File, both of those signed by Senator Lamb (See pages 268 of the Legislative Journal.)

three-year term and have it work out unless you start getting triple membership on those committees. What we neglected to do when we wrote the original bill is provide for staggered elections. So what this provides for is annual elections with some members going off of the advisory committee each year. The third thing we did with 940 is we said our intent was that if school district reorganization, because of the way our equalization formula is written, causes a school district to lose state aid, that we would hold that district harmless for five years. What we said in the bill was if they lose state aid and they reorganize, they are held harmless. So, conceivably, you could have a district that, through reorganization, received a couple more students and another percent or so of their valuation in new land, for some other reason losing state aid, a cut in state aid here in the Legislature, the fact that they got huge new valuation because of some new factories in their district, for a multitude of other reasons totally unrelated to the reorganization that took place, they could lose state aid. What we're saying is the only state aid loss that we want to hold harmless is that that was caused by reorganization. Those are the three changes that are made. If there are any questions, I would be happy to try to answer those. If not, I would urge you to advance LB 190.

PRESIDENT: Is there any further discussion? If not, the question is the advancement of the bill. All those in favor vote aye, opposed nay. Have you all voted? Record, Mr. Clerk, please.

CLERK: 33 ayes, 0 nays, Mr. President, on the advancement of LB 190.

PRESIDENT: LB 190 is advanced to E & R Initial. LB 35.

CLERK: Mr. President, LB 35 introduced by Senator Rod Johnson. (Read title.) The bill was introduced on January 5, referred to the Agriculture Committee, advanced to General File. I have no amendments to the bill, Mr. President.

PRESIDENT: Senator Rod Johnson, please.

SENATOR R. JOHNSON: Mr. President and members, LB 35 and 36 are two of our annual agriculture bills that come to us from the Public Service Commission. This particular bill deals with the Grain Buyers...or Grain Dealers Act, pardon me, and was brought

to us by Commissioner Eric Rasmussen that wanted to clarify a section as it relates to officers, partners or agents of partnerships or corporations. We have had a couple of situations come up that...where the corporation might have been in violation of the Grain Dealers Act but it is difficult to prosecute them under current law because it is vague and we're trying to make sure that this clarifies that situation. There has been some questions of whether this is the proper language to use. The committee talked about that and we decided that we would send the bill to the floor at this time and continue to check into whether we can tighten the language. But it should be relatively noncontroversial. Only a couple of situations have arisen that has caused the Public Service Commission some concern and this is an attempt to clarify that situation for the Public Service Commission.

PRESIDENT: The question is the advancement of the bill. Senator Owen Elmer's light came on, excuse me. Senator Elmer.

SENATOR ELMER: Thank you, Mr. President, and members, Senator Rod Johnson, I wonder if we might answer a question to clarify and put in the record the question that was brought before the committee. The question was when we changed it to...in the last portion of the bill on page 35 where it amends Section 75-909, it adds, besides any person, "any partner, officer or agent of any person," who would violate the grain storage act would be liable for prosecution. Is it...it's the understanding of the committee that this would apply only to individuals who knowingly and willingly participated in a violation. Is that true, Senator Johnson?

PRESIDENT: (Gavel.) Ladies and gentlemen, let's hold it down so we can hear the response. Senator Rod Johnson.

SENATOR R. JOHNSON: Mr. President, the answer is, yes, the Public Service is not interested in prosecuting innocent parties, only interested in those individuals on a board or as a partner in a corporation or partnership that might have knowingly participated in violating the law. And I appreciate Senator Elmer bringing that up. I failed to mention that in my opening.

SENATOR ELMER: Thank you, Senator Johnson. Nothing further.

PRESIDENT: Senator Rod Johnson, did you wish to close? The

question is the advancement of LB 35. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

CLERK: 26 ayes, 0 nays on the advancement of LB 35, Mr. President.

PRESIDENT: The bill is advanced. LB 36, please.

CLERK: Mr. President, LB 36, introduced by Senator Rod Johnson. (Read title.) The bill was originally introduced on January 5, referred to the Agriculture Committee, advanced to General File. I have no amendments to the bill, Mr. President.

SPEAKER BARRETT PRESIDING

SPEAKER BARRETT: Senator Rod Johnson, please.

SENATOR R. JOHNSON: Mr. Speaker and members, again, another housekeeping bill for the Public Service Commission. This particular bill would repeal Sections 88-601 to 88-616. The purpose of this act or this particular bill is to repeal some outdated language. Currently, under law the Public Service Commission is to regulate and to inspect grain facilities on farms across the State of Nebraska. This has been in effect for about the last 25 years but has not been used nor has there been any particular requests that have come in for the Public Service Commission to come out and to check to make sure that grain is being stored in those particular facilities. For those of you that are farmers, you are aware that the loan program through the ASCS office and the federal farm bill provides that the ASCS must come out and inspect your grain facility prior to receiving a loan from the ASCS to make sure that, one, to try and approximate how many bushels are in the bin, make sure that the grain is of substantial proper quality. And so, rather than duplicate this service that is now being done by the ASCS office and the federal government, we are simply asking to repeal these sections. As I said, it is not an activity that the Public Service Commission does currently. It has not been an activity that's been requested of the Public Service Commission for some 25 years and so rather than have this remain on the books and potentially open the state for potential liability and a lawsuit, the Public Service Commission would like to be relieved of this particular duty and would ask that the statutes be repealed and that's what this bill does.

Mr. President, the next amendment I have to LB 189 is offered by Senator Haberman. (Amendment appears on page 372 of the Legislative Journal.)

SPEAKER BARRETT: Senator Haberman, please.

SENATOR HABERMAN: Would you like to read the amendment, Mr. Clerk?

CLERK: (Read Haberman amendment.)

SENATOR HABERMAN: Mr. President, members of the body, the bill, LB 189, said, in essence, the chairperson and members shall be chosen in the same manner as chairpersons and members of the standing committees of the Legislature. That's fine. That's what we did. I agree with that. But now we reach the point that in 1991 should it or should it not be a standing committee? So let's examine the issue. If you will look on the work sheet dated January 20, 1989, there are 14 bills referred to General

SPEAKER BARRETT: Senator Lindsay.

SENATOR LINDSAY: Mr. President, I would move for the adoption of the E & R amendments to LB 35.

SPEAKER BARRETT: You have heard the motion to adopt the E & R amendments. All in favor say aye. Opposed no. Carried. They are adopted. Mr. Clerk.

CLERK: Mr. President, Senator Rod Johnson would move to amend the bill.

SPEAKER BARRETT: Senator Johnson.

SENATOR R. JOHNSON: Mr. Speaker, members, this bill deals with the Grain Dealers' Act and expands or, more specifically, enumerates those who might be liable for violation under the Grain Dealers' Act. It defines what a liable person might be, including partner, officer or agent. There were some members of the Ag Committee that had some concerns that this was an overly broad and vague language and this amendment simply tightens that to ensure that only intentionally...or intentional violations will be prosecuted by the Public Service Commission. We want to make sure that those individuals who had no knowledge of violating the Grain Buyers...or Grain Dealers' Act would be prosecuted, only those individuals that the Public Service Commission felt had violated the law would be prosecuted. This, more specifically, defines that, tightens the language and that's the purpose of the amendment.

SPEAKER BARRETT: Thank you. Discussion on the Johnson amendment. If not, those in favor of the adoption of the amendment please vote aye, opposed nay. Please record.

CLERK: 27 ayes, 0 nays, Mr. President, on adoption of Senator Johnson's amendment.

SPEAKER BARRETT: The amendment is adopted. Back to the bill as amended.

CLERK: I have nothing further on the bill, Senator Lindsay.

SPEAKER BARRETT: Senator Lindsay.

SPEAKER BARRETT: Committee amendments on 342, Senator Wesely.

SENATOR WESELY: Thank you, Mr. Speaker, and members, this bill was brought to us by the Health and Human Services Committee. It comes from a working group that was formed after the end of the last session, the Medical Association, the Health Department, the osteopaths of the state, to update osteopathic law in Nebraska. Osteopaths are a medical profession that has evolved over the years to be very similar in terms of training and preparation for practice as physicians are. It is a different philosophy but they frequently go to the same medical schools and have the same background. The committee amendments which are technical in nature simply clarify the references in the bill. The bill itself deals with updating the references to osteopaths. They will now be referred to as osteopathic physicians and osteopath physicians and surgeons, depending on the circumstance. That's the sum and substance of the bill and the committee amendments are needed to clarify some drafting errors. I would ask for the adoption of the amendments.

SPEAKER BARRETT: Thank you, sir. Any discussion on the adoption of the committee amendments? If not, those in favor of

Senator Schmit at the moment.

SENATOR LAMB: Yes, Mr. President, members, the committee did report favorably on the appointment of Mr. Dodge to this position and would recommend that the Legislature concur.
