SPEAKER BARRETT: Thank you, Mr. Clerk. Proceeding to item number six on today's agenda, a motion to rerefer. Mr. Clerk.

CLERK: Mr. President, Senator Weihing moves to rerefer LB 54 from the Agriculture Committee to the Health and Human Services Committee. Senator Weihing offered his motion yesterday. It is found on page 194.

SPEAKER BARRETT: For purposes of objecting to the referencing of a bill, the Chair recognizes Senator Weihing. (Gavel.)

SENATOR WEIHING: Mr. President and members of the Legislature, I request to move this bill because I feel it is much more in the medical area, the health area, and, therefore, it should be first heard, if it is heard at all, in the Realth and Human Services Committee. This bill is one which deals with cholesterol. Cholesterol has become a daily word within our

LB 46, Mr. President, was introduced by Senators Lamb and Schimek. (Read title.) The bill was introduced on January 5, referred to Retirement for hearing. The bill was advanced to General File. I have no amendments to the bill, Mr. President.

PRESIDENT: Senator Lamb, please.

SENATOR LAMB: Yes, Mr. President, members, this is a bill that corrects an oversight in retirement laws, and all it does is allow county superintendents of schools who were employed before July 10, 1976 to buy into the retirement system. Just because of an oversight in the retirement system, they have not been able to buy into the system. The bill had no opponents in committee and was advanced with no negative votes, and for years I have been looking for a "Herbie" and a "Howie" bill and I think this is it, and I would ask that the bill be advanced.

PRESIDENT: Thank you. Senator Haberman, please.

SENATOR HABERMAN: Mr. President, members of the body, I would heartily ask you to endorse the bill and ask you to advance it as everything Senator Lamb says is absolutely true and I think it should be done. Thank you, Mr. President.

PRESIDENT: Thank you. The question advancement...Senator Schimek, please. Okay, the question is the advancement of the bill. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

CLERK: 28 ayes, 0 mays, Mr. President, on the advancement of LB 46.

PRESIDENT: LB 46 advances. LB 388.

CLERK: LB 388, Mr. President, was a bill introduced by Senator Haberman. (Read title.) The bill was introduced on January 12, referred to the Retirement Committee for hearing, advanced to General File. I have no amendments to the bill, Mr. President.

PRESIDENT: Senator Haberman, please.

SENATOR HABERMAN: Mr. President, I am operating without my file, so until I get it I would like to slip over this bill. have got it now, all right. Well, first of all, the bill changes the age for voluntary participation in the State Employees Retirement System. Currently full-time employees who are 25 years of age with one year of service may elect to participate in the State Employees Retirement System. LB 388 would reduce the eligibility age for voluntary participation from 25 to 20 years of age. The purpose behind the legislation is that we have many, many young employees who start to work for the state at 19 and 18 years old, and they work, and they are 20 years old, they have to work for five years before they can join the retirement system. Now it seems to me that that is unfair to have somebody wait that long when they are doing good work or they would not be kept on the payroll before they are to join a retirement system. This would stop proliferation of good state young employees to other entities if they are given this opportunity to join the system. The bill was not opposed. There were no no votes, and I ask you to heartily support LB 388.

PRESIDENT: Thank you. Senator Schimek, please. Your light is Senator Pirsch, please.

SENATOR PIRSCH: Thank you, Mr. President, I just rise to support Senator Haberman in this effort, and am glad that he didn't pass over it because I think it is a matter of fairness that these young employees should be able to start participating in the retirement plan after they have had one year of service. Thank you.

PRESIDENT: Okay, thank you. Senator Haberman, would you like to close.

SENATOR HABERMAN: Mr. President, I would just ask for the advancement of the bill.

PRESIDENT: Okay, the question is the advancement of the bill. Ail those in favor vote aye, opposed nay. Please vote if you care to. Record, Mr. Clerk, please.

CLERK: 25 ayes, O nays, Mr. President, on the advancement of LB 388.

And it also inserts "any amounts contributed." It helps to give the city complete flexibility in establishing the employees' contribution as established by city ordinance or resolution. The employees may contribute an amount equal to, less than, or greater than the employers contribution, and it just adds flexibility to the bill, and I am sure that the introducer does not object to this. Thank you, Mr. President.

PRESIDENT: Any further discussion on the committee amendments? If not, the question is the adoption of the committee amendments. All those in favor vote aye, opposed nay. We are voting on the committee amendments. Record, Mr. Clerk, please.

CLERK: 26 ayes, 0 nays, Mr. President, on adoption of committee amendments.

PRESIDENT: The committee amendments are adopted. Before we proceed, Senator Baack, I would like to introduce some guests of Senator Ashford, please. In the north balcony, we have 39 eighth grade students from St. Margaret Mary School in Omaha with their teacher. Will you folks please stand and be recognized.
