PRESIDENT: Roll call, please. Record, Mr. Clerk, please.

CLERK: There is a quorum present, Mr. President.

PRESIDENT: Thank you. What should we do first, Mr. Clerk? Any reports or announcements?

CLERK: Yes, Mr. President, I do. Your Committee on Enrollment and Review respectfully reports they have carefully examined and reviewed LB 77 and recommend that same be placed on Select File; LB 714 on Select File, both of those having been signed by January 8, 1990 LB 409, 958-1013, 1031, 1032 LR 235

SPEAKER BARRETT: Let's stand at ease until eleven-fifteen, Mr. President.

PRESIDENT: Okay, thank you.

CASE

CLERK: Three quick announcements. Reference will meet underneath the south balcony now. Referencing Committee, underneath the south balcony right now.

SPEAKER BARRETT PRESIDING

SPEAKER BARRETT: (Microphone not activated immediately.) ... return to the Legislative Chamber. The Legislature will reconvene and continue our discussion on the adoption of our permanent rules. Please return to the Legislative Chamber. Mr. Clerk, would you read in new bills, please.

CLERK: (Read LB 1031 and LB 1032 by title for the first time. See pages 198-99 of the Legislative Journal.)

Mr. President, in addition to those items, I have a new resolution. (Read brief summary of LR 235. See page 199 of the Journal.) That will be laid over.

I have amendments from Speaker Barrett to be printed to LE 409. Mr. President, I also have a Reference Report referring LBS 958-1013, as well as certain gubernatorial appointments received. That's all that I have, Mr. President. (See pages 199-201 of the Legislative Journal.)

SPEAKER BARRETT: Thank you, Mr. Clerk. Have you a motion, Mr. Clerk, to reconsider action taken last week?

CLERK: Mr. President, Senator Chambers would move to reconsider the vote on the Wesely amendment to the rules, which I believe the Legislature discussed on Thursday afternoon.

SPEAKER BARRETT: Thank you. The Chair recognizes Senator Chambers.

SENATOR CHAMBERS: Mr. Chairman and members of the Legislature, this motion is designed to reconsider the vote that was taken on SENATOR LANDIS: Thank you, Mr. Clerk. The next item of business is LB 409 introduced by Senators Barrett and Hefner, the Nebraska Small Business Incubator Act, and the Chair would recognize Senator Barrett on this action. Senator Barrett, to introduce LB 409.

CLERK: Mr. President, LB 409, as you indicated, was introduced by the Speaker and Senator Hefner. (Title read.) The bill was referred to Government Committee, advanced to General File. Mr. Speaker, I have amendments. Do you wish to take those up at this time?

SPEAKER BARRETT: I think so, Mr. Clerk. Let me just very briefly state what the bill does, then I'd like to go to the amendment. Is that all right with the Chair?

SENATOR LANDIS: The Chair would accept a statement of the bill and then move to the motion on the amendments.

SPEAKER BARRETT: Thank you. Mr. President and members, 409 is a bill, it's a carryover bill which was held by the Government Committee last year for some additional work. It establishes the Nebraska Small Business Incubator Act. Basically, under that particular concept, vacant or partially vacant public buildings can be transformed into places where a number of businesses can collaborate and cooperate into places where they can start up their expansion services and cooperate with copy machines, utilities and that sort of thing. But more specifically, the Government Committee had some concerns with it last year. We agreed to hold the bill over and rework it. This summer there was another hearing on it and at this point I am very, very satisfied with the end result as is the Government Committee. The counsel for the Government Committee has done an exceptional job of helping rework the bill. The committee amendments themselves to 409 essentially are the bill and I think you've got a very, very good explanation, if I could call the body's attention to the summary which I passed out, Mr. President. You'll see that the original bill was drafted to apply only to state-owned buildings. The primary intent of the major amendment is to make it clear that the bill applies to any public buildings, on the amendment.

SENATOR LANDIS: Mr. Speaker, since we're now moving to the amendments, the Chair would need a piece of action before it. Would you move to adopt the committee amendments and then take

up that motion?

SPEAKER BARRETT: Thank you, I would, Mr. President. I move that the committee amendment be adopted.

SENATOR LANDIS: And you're now recognized to address that.

SPEAKER BARRETT: Thank you. Three major changes I guess. Number one, we clarify the factors to be considered in the feasibility study, that is Section 6 of the bill. I believe it is found on page 5. The second change, we removed a requirement that the incubator designation be in effect for 15 years. We...instead of 15 years, let's see...the agreement is that the incubation center remains in effect for such time as agreed to by the public agency and the community board. Instead of the 15 years then, we thought this might discourage a county board or a school board from signing over too long. Number three, we extend the period in which a tenant business could relocate outside the incubator from 18 months to two years, and I think that is found in Section 11. As suggested, the other changes are technical. We internally tightened it up a bit and made some other references consistent. That is the amendment itself, Mr. President. I would hope the body would approve.

SENATOR LANDIS: Thank you, Mr. Speaker. I have a point of order here by Senator David Bernard-Stevens and then the speaking order which is Senator Coordsen, followed by Senator Hefner. The Chair recognizes David Bernard-Stevens for a point of order. State your point.

SENATOR BERNARD-STEVENS: Actually, it's more of a clarification I think, and if it needs to be a point of order, that's fine. I just wanted to clarify, at least for the record's sake, that the bill was reported out of committee clean, so this is not a committee amendment per se. There were no committee amendments. Speaker Barrett was recognized because it is his bill and he has an amendment that he worked with the committee on the interim in order to perfect, and this is simply should be not considered a committee amendment, but simply an amendment to the bill. And I wanted to try and clarify that before we got too far in the wrong direction.

SENATOR LANDIS: Thank you for that point. We now go to our regular line of speakers. Senator Coordsen is recognized. Senator Coordsen.

SENATOR COORDSEN: Thank you, Mr. Speaker, members of the body. I forgot what to call you, Senator Landis. You're usually on this side eloquently expressing yourself on various issues, were to have that talent. This bill is one that we viewed with a great deal of seriousness in Government Committee, one which supported in the original form and then we found that there were possible problems with that implementation of the original bill. as Speaker Barrett, Senator Barrett indicated, th ms were worked out. In Nebraska we have a number And those problems were worked out. of buildings that stand empty and I would point one's attention to how this might work to something that has been done privately in one of my communities, Geneva, Nebraska, where there was an interest of local individuals and they created in several empty buildings a business incubator of a type on their own, has been very successful in a community of about 2,500 people, has provided a place for people with very little money, but an interest in doing something entrepreneurial to have a place to start with the support of other business people in the same We have seen in several years of operation two businesses area. from that that have already spun off until they are into their own facility. So I think that if we had this authorization and encouragement in law, we would see more of those types of things happening in Nebraska and would have a better use of some of the facilities, public and private, that do exist out there now and are currently falling into disrepair because they are not being used. So I would encourage the adoption of this amendment and then the advancement of the bill. Thank you.

SENATOR LANDIS: Thank you, Senator Coordsen. There are three lights remaining, Senator Hefner, followed by Senator Schmit and then Senator David Bernard-Stevens. Senator Hefner.

SENATOR HEFNER: Mr. President and members of the body, I rise to offer my support to the Barrett amendment. I think it's needed because when the bill was originally drafted we didn't say all public buildings. I think the bill said just state buildings, but this would allow for all public buildings. This is a good opportunity for government to work with private business, work with small businesses. I've seen this work and what this would do is put it in statute and help it along a little bit. But so many times, so many times a small business when they are getting started needs a little help and this way they would be able to share, like perhaps maybe a secretary and a copy machine or a fax machine or whatever else you'd have. It

would also give the small business an opportunity to see whether it's going to work. I think this says that it allows it up to two years and with a vote of that particular community board it would give them another 12 months if they needed it. But I think this is a good way for us to help it along. This originally...this bill of this type originated out of the New Horizons program and I just want to thank Senator Barrett for letting me co-sponsor it with him because I'm a strong believer in it. So I support the Barrett amendment and I also support the bill. Thank you.

SENATOR LANDIS: Thank you, Senator Hefner. There is one light remaining on the amendment by Senator Barrett and that is Senator David Bernard-Stevens. The Chair recognizes Senator Bernard-Stevens.

SENATOR BERNARD-STEVENS: It's a mouthful, thank you, Mr. Chairman. Senator Barrett, would you be kind enough to respond to a question?

SENATOR LANDIS: Senator Barrett, would you respond to a question?

SPEAKER BARRETT: Yes.

SENATOR BERNARD-STEVENS: And, again, Senator Barrett, I know the Government Committee appreciated your bringing this to it. We deeply appreciate the work that you have done in the interim period to bring us a better bill and this particular amendment will improve the green copy, to my mind, to a very passable state right now. I do have a question I'd like to at least have in the record, at least a little bit of discussion. Part of the discussion in the Government Committee centered around the 18 months where originally a company that was under the incubator program would be able to take advantage of the help, if you wish, for 18 months and the amendment extends that to two Is that...it's on the first page, part 3, extends the years. period within which a tenant business must relocate outside the incubator from 18 months to two years.

SFEAKER BARRETT: As I recall, the discussion a year ago, Senator Bernard-Stevens, that was to help minimize the effect of unfair competition. We were concerned about competitiveness with local entrepreneurs.

SENATOR BERNARD-STEVENS: Right, I guess the question I want to try and clarify and have you clarify for the body in the record is, in the committee there was some discussion of, yes, the tremendous need to help entrepreneurial enterprises, particularly in western Nebraska and rural areas, and that there was no disagreement. But what about the area that there could be some competition between one company already established and another one that is under the incubator program, one that is obviously receiving aid and ... aid from the community and from the state government where the other, competing on their own is not? There was some discussion about unfair competition, in fact, and 18 months or two years may be too long of time to keep them in the incubator, and I just wanted you to respond to that type of discussion that we had earlier so we can have that on the record.

SPEAKER BARRETT: Certainly. We did build some safeguards into the bill to prevent that competition that you refer to, or against and for businesses already in the community. I think Section 9 in the committee amendments would speak to that, Senator, listing the criteria that the community board looks at to decide who will be accepted as a tenant into the business incubator. It requires that the product or service be new to the state or to the community and that it will not eliminate existing jobs. There is some local control built into the bill because the community board asks for the incubator and it decides who the tenants will be. So I have no problem with that anymore and that was a good point that was brought out by the committee.

SENATOR BERNARD-STEVENS: And I thank Senator Barrett for working on that point to extend it to two years. I'd also like to make sure the body understands that after the two-year period there is a 12-month possibility of an extension to give the business that has been under the incubator program a transition period in order to break out on their own. The committee can, in fact, extend that to 12 months if they deem that desirable, and I thank the Chair for the time and that ends my remarks and hope the bill moves on to Select File.

SENATOR LANDIS: Thank you. Senator Barrett, you're recognized to close on the Barrett amendment. There are no other lights on the bill itself. We'll proceed now to the closing on the amendment. Senator Barrett. January 12, 1990 LB 409

SPEAKER BARRETT: Thank you, Mr. President and members. As т indicated earlier, the amendment actually becomes the bill and I'm tremendously pleased with our end product here because I believe that this is a way that small businesses, particularly in rural Nebraska, will be able to get a little competitive edge in terms of real revitalization of rural Nebraska. T think incubators can be a very valuable contributor to rural economic vitality. Actually, we could go on and on, Mr. President, it's permissive, it doesn't cost a dime, it's a tool that businesses in this state will be able to use very, very well to establish new businesses and to help existing small businesses. I would move that the bill be advanced. Thank you.

SENATOR LANDIS: Well, the motion is to adopt the amendment, Senator Barrett, I would suggest, and for that reason we will move the question at hand which is the adoption of the Barrett amendment. All those in favor vote aye, those opposed vote no. The Chair would announce that the time is eleven fifty-five. Mr. Clerk, would you record, please.

CLERK: 26 ayes, 0 nays, Mr. President, on adoption of Senator Barrett's amendment.

SENATOR LANDIS: Thank you, Mr. Clerk. Senator Bernard-Stevens' light is still on, but apparently wants to pass. We actually are at the opening or perhaps closing, depending on Senator Barrett's whim, on the bill itself now. Senator Barrett, you're recognized on LB 409 as amended.

SPEAKER BARRETT: Mr. President, I would move the advancement of LB 409, which is a very creative piece of legislation that this state needs more of.

SENATOR LANDIS: Thank you, that is the opening, the debate and the closing on the advancement of LB 409. Those in favor vote aye, those opposed vote no. The Clerk will record.

CLERK: 28 ayes, 0 nays, Mr. President, on advancement of LB 409.

SENATOR LANDIS: Does the Clerk have anything to read into the record for us?
