CLERK: 28 ayes, 0 nays, Mr. President, on adoption of the Committee on Committees report.

PRESIDENT: The report is adopted. Back to you, Mr. Clerk. We're ready for the introduction of new bills. Mr. Clerk.

CLERK: Mr. President, new bills. (Read LB 1-80 by title for the first time. See pages 44-61 of the Legislative Journal.)

PRESIDENT: If I could have your attention just a moment, please, we'll introduce a couple of guests. Over under the north balcony, our first doctor of the day for this year is Dr. Dale Michaels of Lincoln, Nebraska. He's from Senator Warner's district. He's here to take care of us on behalf of the Nebraska Academy of Family Physicians. So would you welcome Dr. Michaels. Would you please stand, Doctor. Thank you for

Enrollment and Review reports LB 190 to Select File; LB 35 to Select File with amendments; LB 36, Select File; LB 38, Select File with amendments; LB 158, Select File; LB 79, Select File; LB 53, Select File with amendments; LB 57, Select File and LB 123, Select File, those signed by Senator Lindsay as Chair, Enrollment and Review. (See pages 370-71 of the Legislative Journal for above announcements.)

Mr. President, the next amendment I have to LB 189 is offered by Senator Haberman. (Amendment appears on page 372 of the Legislative Journal.)

SPEAKER BARRETT: Senator Haberman, please.

SENATOR HABERMAN: Would you like to read the amendment, Mr. Clerk?

CLERK: (Read Haberman amendment.)

SENATOR HABERMAN: Mr. President, members of the body, the bill, LB 189, said, in essence, the chairperson and members shall be chosen in the same manner as chairpersons and members of the standing committees of the Legislature. That's fine. That's what we did. I agree with that. But now we reach the point that in 1991 should it or should it not be a standing committee? So let's examine the issue. If you will look on the work sheet dated January 20, 1989, there are 14 bills referred to General

Withem, any comment? Thank you. Any discussion? Seeing none, we will proceed to the vote. The question is the suspension of Rule 3, Section 13. Those in favor vote aye, opposed nay. Record, please.

CLERK: 0 ayes, 28 nays, Mr. President, on the motion to suspend Rule 3, Section 13.

SPEAKER BARRETT: Motion fails. Proceeding then to the suspension of Rule 3, Section 19. Senator Withem. Thank you. Any discussion? Proceeding then to the vote. The question is the suspension of Rule 3, Section 19. Those in favor vote aye, opposed nay. Have you all voted? Please record.

CLERK: 0 ayes, 30 nays, Mr. President, on the motion to suspend Rule 3, Section 19.

SPEAKER BARRETT: Motion fails. Anything on the desk, Mr. Clerk?

CLERK: Yes, Mr. President, I do. Mr. President, I have a motion from Senator Warner as Chair of the Credentials Committee. That will be read and laid over, Mr. President.

Mr. President, I have a series of gubernatorial appointments. Those will be referred to Reference. (See pages 395-97 of the Legislative Journal.)

Mr. President, hearing notices from the Transportation Committee, from the Banking Committee, from the General Affairs Committee, all signed by the respective Chairs.

Mr. President, your Committee on Enrollment and Review respectfully reports they have carefully examined and reviewed LB 60 and report the same to Select File; LB 126, Select File; LB 207 to Select File, and LB 189, Select File; and LB 51, all reported to Select File, Mr. President. (See pages 398-99 of the Legislative Journal.) That's all that I have at this time.

SPEAKER BARRETT: Thank you. Proceeding then to General File. LB 45. Mr. Clerk.

CLERK: Mr. President, LB 45 was a bill that was introduced by Senator Bernard-Stevens. (Read title.) The bill was introduced on January 5 of this year, referred to Natural Resources. It

was advanced to General File. I have no amendments to the bill, Mr. President.

SPEAKER BARRETT: The gentleman from the 42nd legislative district, Senator Bernard-Stevens.

SENATOR BERNARD-STEVENS: Thank you, Mr. President. Members of the body, I won't take much time. This bill was heard before the Natural Resources Committee. There was no opposition to it. This bill will not make a new law, in fact, it will take some of the existing laws off of the books so we will be helping along that matter. In essence, what we had is a few years ago you had fees established for intentionally stored water and also the incidentally stored underground water that has caused a lot of conflict, at least on the incidentally stored water. To this date, no requests have ever been made to levy fees by anyone. The Central Nebraska Public Power and Irrigation District passed a resolution themselves in favor of the resolution...or in favor of LB 45, so there is, in general, harmony to take away the fees but also eliminate much of the frustration felt by people that have had incidentally stored water. And that's exactly what this bill would do. It's 50 cents per acre and that would be removed. Thank you, Mr. President.

SPEAKER BARRETT: Thank you. Discussion on the bill. Senator Wesely.

SENATOR WESELY: Thank you. Thank you. Mr. Speaker, members, although it sounds like everybody is pretty happy with this piece of legislation, I think it would be helpful for Senator Bernard-Stevens or Senator Schmit, probably more likely, since he was around when we passed this, but try and remember this was part of a fairly controversial bill and, remember, we had some battles over this and I guess I wonder what became of it. I'm trying to recall exactly the context in which this issue was debated. You have kind of said that there was this problem and now there's not a problem but could you give us a little more history on that? Because either from you or Senator Schmit, I recall this as being a little more significant issue than you have just portrayed it as, at the time it was passed.

SENATOR BERNARD-STEVENS: Mr. Chairman, I would be glad to enlighten that a little bit. The McFarland bill we had the other day kind of scared me a little bit about taking too much time because you never know what's going to happen at some

point. And Senator Schmit will have a much better background than I will on this particular bill but what I have been able to establish on the history of the bill that there was a very, very complex water bill issue that was coming through and it did divide the body quite extensively. There was a dollar fee per acre for incidentally stored water in the bill and the committee took it and changed that to zero. And then in the context of the discussion on the floor, a compromise was reached at 50 cents of which, even at that, it was feared that the bill itself, because of other potential problems, would not pass, but the bill did pass with the 50 cent per acre in there. Since that time, Senator Wesely, people that have had, for example, in my area and really throughout the state that have had incidentally stored water, what's happened is the water table has risen in their areas through no dealings of their own, maybe it's seepage through a canal system, what have you, and there is a fee on the books that says that another entity can charge them 50 cents an acre for pumping of water that they didn't have anything to do with it being there in the first place and has caused a lot of controversy. When the ranchers and farmers have gone to the areas that...where the agencies or entities, if you wish, that would be able to charge the fee, the entities say, we do not want to charge the fee, we will never charge a fee, for the most part, so we were stuck with the idea of, okay, if people were upset that there might be a fee, let's go ahead and remove it. And all the areas that were affected by this came to a conclusion that this is, in fact, the way that we wanted to go. If, in the future, there would need to be a problem or somebody would need to file, then we would have to go back years and put a fee, but right now neither side really wants that particular fee in there. All the other fees that were a part of that bill, by the way, you are referring to will remain intact.

SENATOR WESELY: What I recall in carrying on...

SPEAKER BARRETT: Senator Wesely.

SENATOR WESELY: Thank you. Central Nebraska Public Power and Irrigation, I think, was the primary sponsor of this incidental fee question and I think it must have been about six or seven years ago. But, evidently, what's happened is what they thought was a circumstance that they needed this authority, they no longer feel that now or in the future that will be a necessity, so they're...and the confusion is now causing everybody involved just to decide not to even get into this issue. Is that right?

SENATOR BERNARD-STEVENS: I think there's a couple of things involved here but, number one, yes, the frustration on some of the farmers and the realization by Tri-County, for the most part, that they will not use the fee nor do they want to, they have simply come to the conclusion that we'll go ahead and get rid of it and it will kind of ease the tension between some of the two groups.

SENATOR WESELY: Yeah.

SENATOR BERNARD-STEVENS: I might also...Central Nebraska Public Power and Irrigation District did come this time and testify in favor of the bill.

SENATOR WESELY: Yes, as I recall, this really only affected your area of the state, that Platte Valley and on down a little ways.

SENATOR BERNARD-STEVENS: Actually, the incidental affects a few more portions than that throughout the state but particularly the reason I brought the bill up was for Keith, Lincoln and Dawson Counties and those areas where it was extremely effective. However, there are other areas where there have been bubbles under underground water that have incidentally stored water.

SENATOR WESELY: All right.

SENATOR BERNARD-STEVENS: This is not, by the way, if it's planned or intentional storage, those fees are all still within the system that we have.

SENATOR WESELY: Okay. Well I didn't mean to imply that incidental recharge doesn't occur anywhere else but just that the issue itself and the fee itself was focused primarily in the middle part of the state.

SENATOR BERNARD-STEVENS: That is correct.

SENATOR WESELY: Okay, thank you very much. Appreciate that explanation. If Senator Schmit had anymore to add, I would appreciate hearing from him on this but I think I understand where we're coming from.

SPEAKER BARRETT: Thank you. Any other discussion on the bill? Any closing statement, Senator Bernard-Stevens?

SENATOR BERNARD-STEVENS: Just that we advance the bill at this point, Mr. President.

SPEAKER BARRETT: Thank you. You have heard the motion to advance LB 45 to E & R Initial. Those in favor of that motion vote aye, opposed nay. Have you all voted? Record, please.

CLERK: 25 ayes, 0 nays, Mr. President, on the motion to advance LB 45.

SPEAKER BARRETT: LB 45 is advanced. LB 168.

CLERK: LB 168, Mr. President, introduced by Senator Schmit. (Read title.) The bill was introduced on January 5, referred to Natural Resources, advanced to General File. I have no amendments to the bill.

SPEAKER BARRETT: The Chair recognizes the Chairman of the Natural Resources Committee, Senator Schmit.

SENATOR SCHMIT: Mr. President and members, this bill eliminates language which authorizes the shooting of crows, hawks and wolves on reservations and sanctuaries. It's technical in nature. Actually, there haven't been many wolves in Nebraska for quite a few years and so the language wasn't really necessary. It boils down to the fact that it says you can't shoot crows on game reserves and there are not very many of those in the State of Nebraska. But the Game and Parks did have a series of these bills which they wanted introduced for the purpose of cleaning up language. It's almost a redundant bill but I took it out of courtesy to the Game and Parks Commission. I would be glad to answer any questions and if not, I would assume that the bill could be moved forward.

SPEAKER BARRETT: Thank you. For purposes of discussion, Senator Rod Johnson.

SENATOR R. JOHNSON: Mr. Speaker and members, I would have one question for Senator Schmit if he would yield.
