Committee, on this bill and I certainly appreciate the support of Senator Schmit and Senator Schellpeper as co-sponsors of the bill. Again, we are simply clarifying the definition of gross receipts under these statutes and specifically stating that access charges shall not be subject to a sales tax. New A bills, Mr. President. (Read LB 338A, LB 378A and LB 412A by title for the first time. See page 590 of the Legislative Journal.) And that is all that I have, Mr. President.

SPEAKER BARRETT: Thank you. The next bill, LB 459.

CLERK: 459, Mr. President, was offered by the Revenue Committee and signed by its members. (Title read.) The bill was introduced on January 13, referred to Revenue, advanced to General File. I have no amendments to the bill, Mr. President.

SPEAKER BARRETT: Thank you. To the Chairman of the Revenue Committee, Senator Hall.

SENATOR HALL: Thank you, Mr. President, members. This, Senator

Schmit, is another one of those technical bills, but I would have you note that this one is only 12 pages long and it does four things are. It was brought to us by the Revenue Committee and it makes changes in the income tax law, LB 773, that we passed in 1987. These are basically omissions that were left out of the draft of 773. None of them are of any type of substantial nature and if you would open your bill books to the committee statement, I think the summary purposes and changes is basically the best way to walk through what these four things. First, in Section 1, it repeals the language dealing with the liability of corporate officers which was unnecessary after the passage of LB 523 in 1987. Section 2, we changed the issue of individual retirement accounts which was spelled out specifically as IRAs and we changed that to include qualified retirement plans so that the application would be to all types of retirement plans. In Section 3 we take and include fiduciaries with corporations as institutions to be taxed under federal taxable income rather than adjusted gross income as is the case with individual taxpayers. This is how they have always been treated and the draft of 773, fiduciaries, were just left out. Section 4, it deals with the issue of joint and several liability and it clarifies that all individuals who file jointly are...have joint and several liability for the taxes due and it has an effective date of January 1, 1989. Senator Hannibal asked me on the floor prior to the bill coming up with regard to Section 4, the issue of joint and several liability, was that a substantial change, if any? No, it is not, as currently the practice and it has been the practice. It is just to clarify language that was in 773 but the department felt was not clearly spelled out and in order to just ensure that the practice remained the same it is included in LB 459. With that, Mr. President, I would yield to any questions if there are any.

SPEAKER BARRETT: Thank you. Discussion on 459. Apparently not, Senator Hall. Any closing statement?

SENATOR HALL: Mr. President, I would just urge advancement of the bill.

SPEAKER BARRETT: Thank you. The question is the advancement of LB 459 to E & R. Those in favor please vote aye, opposed nay. Please record.

CLERK: 29 ayes, 0 nays, Mr. President, on the advancement of 459.

SPEAKER BARRETT: LB 459 is advanced. LB 458.

CLERK: 458 offered by the Revenue Committee. (Title read.) The bill was introduced on January 13, Mr. President, referred to the Revenue Committee, advanced to General Committee. I do have Revenue Committee amendments pending.

SPEAKER BARRETT: To the committee amendments, Chairman Hall.

SENATOR HALL: Thank you, Mr. President and members. Again, this is a technical bill that was brought to the committee by the Revenue Department. This one is half as long as the last one, it is only six pages, and it deals with, again, the issue of income tax and how it is determined. There were a couple of omissions again that...with regard to 773 but these are much more technical and if you will bear with me I will try to explain them to the best of my ability. But the committee amendment was brought to us by John Cederberg who is a partner in Touche-Ross and who was quite actively involved in the development of 773. John was there at the birth of 773 and has continued to follow the progress of that legislation and the impact that it has had on his industry. He brought three different amendments to the committee, two of which the committee, through consultation with the department, determined that were not necessary at this time. They dealt with things such as foreign mutual funds that no one could determine if anyone in the State of Nebraska even had investments in there, but probably was a good point on his part. It's just that there was no need at this time to enact that into statute, at least that was the opinion of the Revenue Department as well as the opinion of the committee. But the one committee amendment that we did adopt with the blessings of the Revenue Committee dealt with the alternative minimum tax, federal alternative minimum tax proposal that would allow Nebraskans to use this in determining their alternative minimum tax and basically what it does in a nutshell, it avoids counting the state income taxes twice when you calculate the tax. It's a very long and drawn out process with regard to showing you that. It would take about four or five pages in a handout and Mr. Cederberg did have that, walked us through it and left us as confused as before he made the presentation, but it is a positive aspect for the taxpayers of Nebraska in that it does allow them the use of the federal minimum tax that we have not had in the past and it corrects a problem with regard to basically being taxed twice
