SPEAKER BARRETT: Any discussion on the adoption of the committee amendments? If not, those in favor of the adoption of the amendments to 418 please vote aye, opposed nay. On the committee amendments, have you all voted? Record, please.

CLERK: 27 ayes, 0 nays, Mr. President, on adoption of committee amendments.

SPEAKER BARRETT: The amendments are adopted. Senator Haberman.

SENATOR HABERMAN: Mr. President and members of the body, there was not any opposition to the bill, and as I stated before, all the bill does, it extends the length of the term of office for the Public Employees Retirement Board members from three to five years. I ask for the advancement of the bill, Mr. President.

PRESIDENT: Any discussion? Seeing none, there in favor of the advancement of 418 to E & R Initial vote aye, opposed nay. Record, please.

CLERK: 27 ayes, 0 nays, Mr. President, on the advancement of 418.

SPEAKER BARRETT: The bill is advanced. Anything for the record?

CLERK: Not at this time, Mr. President, no, thank you.

SPEAKER BARRETT: To the next bill, Mr. Clerk.

CLERK: LB 506 was introduced by Senator Haberman. (Read title.) The bill was introduced on January 18, referred to Retirement for public hearing, advanced to General File. I have committee amendments pending, Mr. President. (See page 636 of the Legislative Journal.)

SPEAKER BARRETT: (Gavel.) On the committee amendments, Senator Haberman.

SENATOR HABERMAN: Mr. President and members of the body, the committee amendment more clearly states that the judges and patrols retirement system be fully funded over a 25-year period or over the average future service of active members of each individual system, whichever comes first. From the time a patrol officer and a judge enter the retirement system and the

time that they retire, it may be less than 25 years. Therefore, the liability of improved benefits may not be fully paid for by the time of retirement. This change will help ensure that these funds are fully funded. I ask for the adoption of the amendment, Mr. President.

SPEAKER BARRETT: Thank you. Discussion on the committee amendments. Senator Nelson.

SENATOR NELSON: Senator Haberman, I am sorry I didn't get time for all of the details on the bill, but just one question if you would respond. I see any number of sections, you know, sometimes, are there other things in the bills that we don't realize at the time. Also I see a mention to school retirement funds, and you didn't mention this in your explanation of the amendments. Remember, last year we had a 3.6 unfunded liability, and with the proposals in LB 89, that also does concern me. How does this address school retirement funds, and I see that they were a supporter in the bill? Could you just explain that to me, please?

SPEAKER BARRETT: Senator Haberman, would you respond?

SENATOR HABERMAN: Senator Nelson, I have not explained the bill. I have not gone into any of those details which I intend to do when I get to the bill. I am talking, and was your question addressed to the amendment or to the bill?

SENATOR NELSON: To the amendments, sir, I see...

SENATOR HABERMAN: Will you start your question again, please.

SENATOR NELSON: Okay, I said that you explained to me the judges and the highway patrol. I just asked what the amendments did on the school retirement system.

SENATOR HABERMAN: There isn't any.

SENATOR NELSON: Okay, thank you.

SPEAKER BARRETT: Anything further? Any closing on the amendments, Senator Haberman?

SENATOR HABERMAN: I will waive closing.

SPEAKER BARRETT: Thank you. The question before the body is the adoption of the committee amendments to LB 506. Those in favor vote aye, opposed nay. Voting on the committee amendments. Please vote if you would care to vote.

SENATOR HABERMAN: Well, Mr. President, under the circumstances, and I hate to do this, I am going to have to ask for, please, I am going to have to ask for maybe, maybe...isn't there anybody else here to give me one more. There we got it.

SPEAKER BARRETT: Record, please.

CLERK: 26 ayes, 0 nays, Mr. President, on adoption of committee amendments.

SPEAKER BARRETT: The amendments are adopted. To the bill, Senator Haberman.

SENATOR HABERMAN: Mr. President, members of the body, my better sense says, just ask for advancement but I don't think that would be fair. The bill was introduced at the request of the Nebraska Retirement Systems. Now they have assured me and the committee that the changes are only technical changes which eliminate obsolete language or change the wording...don't run away, Tim, I am going to need you...so that the various retirement systems use common language. It brings them all into the same language. The changes clarify provisions relating to the county employees, judges, schools, state patrol, and state employees retirement systems. In all of the retirement plans, language was eliminated that defined a qualified domestic relations order that is spelled out in the current law and references it to the Internal Revenue Code, which pertains to divorce settlements. Language is added to the judges and patrol retirement systems which will allow the estate to receive a deceased patrol officers retirement fund in the event that there is no spouse or dependent children. There will be no fiscal impact to any of the systems or the state because of the changes in this proposed bill. Now I can go through here one by one by one and we will be on this tomorrow, so the only thing I can say is, trust me. With that, Mr. President, I ask for advancement of a technical bill, LB 506.

SPEAKER BARRETT: Thank you. Discussion? Senator Hefner, followed by Senator Hall.

SENATOR HABERMAN: The state employees did not testify in a neutral capacity.

SENATOR HALL: I am sorry, Senator Haberman. That is the way it was listed in the...

SENATOR HALL: Okay.

SENATOR HABERMAN: They testified neutral because it is their

That is eliminated by the committee amendments, and deletes \$1.5 million from the fiscal note. I would move for the adoption of the committee amendments.

SENATOR MOORE: (Response inaudible.)

PRESIDENT: Okay. The question is the adoption of the resolution. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

CLERK: 20 ayes, 0 nays, Mr. President, on adoption of the resolution.

PRESIDENT: The resolution is adopted. Now, ladies and gentlemen, if you'd take your seats, please, we'd begin Final Reading. (Gavel.) If you'll take your seats, we'll begin Final Reading, please. Mr. Clerk, LB 506, please.

CLERK: Mr. President, Senator, I have a motion on the desk. Senator Withem would move to return LB 506 to Select File for specific amendment.

PRESIDENT: Senator Withem, please.

SENATOR WITHEM: Yes, Mr. President, members of the body. I'm asking that this bill be brought back from Final Reading for purposes of attaching an amendment that is printed in the Journal on page 1502. I thank Senator Haberman for his cooperation in allowing us to at least consider this amendment. What this amendment would do would be...it would provide a change in the manner in which school employees, who are currently covered under the School Employees Retirement System, are treated when they go to work for the State Department of Education. Now, obviously, this does not apply to a huge, significant number of people in our state. It's isolated to a very small number of people. But there currently is a problem. Now, also keep in mind that the prime recruitment ground for employees in our State Department of Education are individuals who are currently employed in the Public School System. Currently, when they go from one system to another they have to change their retirement system from the School Employment Retirement System to the State Retirement System. It's not so much that one system is better than another, it's that they tend

to, if they're not vested yet in one system, they could lose those benefits that they have. If they are vested, the manner in which their benefits are finally concluded is based on their average salary for their last five years. Beings they are going to continue to work, and continuing to grow and advance into the school...the state system, that can negatively affect upon their benefits. The purpose of it is to make it not a penalty for an individual to transfer from one system...from the School Retirement System into the State Retirement System, so they aren't penalized when they leave working for the public schools and go to work for the department. What this amendment would do would be to allow the individuals to choose whichever retirement system they wish to be covered by, either the School Employees Retirement System or the State Retirement System. A fairly simple amendment. I'd ask that you move to return the bill to Select File for purposes of adopting this amendment.

PRESIDENT: Thank you. Senator Haberman, please, followed by Senator Abboud.

SENATOR HABERMAN: Mr. President, members of the body, if this item would have been presented to the committee before the bill was advanced to the floor, we would have attached it as a committee amendment. And I wholeheartedly support returning the bill, attaching the amendment. Thank you, Mr. President.

PRESIDENT: Thank you. Senator Abboud, then Senator Wesely. Senator Wesely, please.

SENATOR WESELY: Thank you, Mr. President, members. I apologize to Senator Withem. I followed most of your conversation. Would the...if he'd yield to some questions just about the...The State Employee Retirement System and the School Retirement System are completely different. One is a defined benefit, one is a defined contribution plan, so they are quite different. But I can see where trying to rectify differences is important. And I'm just wondering, Senator Withem, right now if you're moving out of a school into the Education Department are they...are you wanting to allow them to continue to be under the school retirement plan? Is that the intent of this amendment?

SENATOR WITHEM: Allow them the choice of remaining under the School Retirement System or going into the State Employees Retirement System, which ever they prefer.

SENATOR WESELY: They don't have that choice now. They just have to convert into the state plan, is that...

SENATOR WITHEM: My understanding that some exceptions have been made, but the statute does not technically allow for that choice to be made.

SENATOR WESELY: If they stay in the school plan, which is defined benefit plan with defined contributions, does that mean then that under this amendment they would have to follow exactly what everybody else in the School Retirement Plan would have to follow in terms of percent of their salary and the contribution by the state?

SENATOR WITHEM: Right.

SENATOR WESELY: Okay. Do you see any problem with the fact that as a state employee they would have a different contribution level for themselves in the state than other state employees would have under the state plan? Is that not a problem?

SENATOR WITHEM: I think for the limited number of people that are...were involved in this particular transfer, no I don't think it would be a problem.

SENATOR WESELY: We're talking a handful of people probably at most?

SENATOR WITHEM: Yeah, we really are.

SENATOR WESELY: Okay, it's just the juxtaposition. These are not compatible meshing plans, they are very different plans. But, you know, I guess my first reaction is I don't know why we can't be a little flexible. But I just want to get, for the record, exactly how we'd work that out. Appreciate that.

SENATOR WITHEM: Thank you.

PRESIDENT: Thank you. Senator Abboud, did you wish to speak now?

SENATOR ABOUD: No.

PRESIDENT: Okay. Senator Withem, did you wish to close on your

motion to return?

SENATOR WITHEM: I think both with Senator Haberman's comments, Senator Wesely's questions and my introduction, there appear to be no other questions, so I'll just close by asking to return the bill.
