Your Enrolling Clerk has presented to the Governor bills read on Final Reading this morning, Mr. President. (Journal page 565 shows LB 33 and LB 35 were presented to the Governor.) That's all that I have.

SPEAKER BARRETT: Thank you, sir. Proceeding then to LB 342.

CLERK: Mr. President, LB 342 was a bill introduced by the Health and Human Services Committee and signed by its members. (Read title.) The bill was introduced on January 11, referred to the Health Committee for hearing, advanced to General file. I do have committee amendments pending, Mr. President.

SPEAKER BARRETT: Committee amendments on 342, Senator Wesely.

SENATOR WESELY: Thank you, Mr. Speaker, and members, this bill was brought to us by the Health and Human Services Committee. It comes from a working group that was formed after the end of the last session, the Medical Association, the Health Department, the osteopaths of the state, to update osteopathic law in Nebraska. Osteopaths are a medical profession that has evolved over the years to be very similar in terms of training and preparation for practice as physicians are. It is a different philosophy but they frequently go to the same medical schools and have the same background. The committee amendments which are technical in nature simply clarify the references in the bill. The bill itself deals with updating the references to osteopaths. They will now be referred to as osteopathic physicians and osteopath physicians and surgeons, depending on the circumstance. That's the sum and substance of the bill and the committee amendments are needed to clarify some drafting errors. I would ask for the adoption of the amendments.

SPEAKER BARRETT: Thank you, sir. Any discussion on the adoption of the committee amendments? If not, those in favor of

about costs. It will also require for a public hearing. PRESIDENT: Senator Hartnett.

SENATOR HARTNETT: Mr. President and members of the body, I think I handed a handout to you and I think that simply states what the hill is. We want to add an emergency clause, or the committee wanted to add an emergency clause. If you look at the second page of it, is that we, last year, when Senator Lynch and myself had a bill we excluded that, it was struck in...this language that made these people qualify was stricken from the language so that is the reason for adding the emergency clause. Also, there is a change in the language which would allow...permit an individual who has lost the use of one or more limbs to receive a handicapped parking permit. This simply means that the city clerk would simply issue a parking...a handicap so they can park in a handicapped parking space in the thing. And also we have added the words "all or substantially all the use of one or more limbs". In the other bill it was extremities and we...looking at medical journals, and so forth, we discovered that "limbs" is used most. So, with that, I would like to have the introduction...or approval of the committee amendments.

PRESIDENT: Any further discussion? If not, the question is the adoption of the committee amendments. All those in favor vote aye, opposed nay. Record, Mr. Clerk, please.

CLERK: 25 ayes, 0 nays, Mr. President, on adoption of the committee amendments.

PRESIDENT: The committee amendments are adopted. Back to the advancement of the bill. Senator Hartnett, please.

SENATOR HARTNETT: Yes, I think the handout, I think we...inadvertently, the Legislature, myself and Senator Lynch, I think last year, struck this part of the bill and I think that I would just simply ask...unless there are some questions, and so forth, and I really appreciate the effort of Don...Senator Don Wesely in this area too that has the same interest. So I think that, with that, I would simply ask for the advancement of the bill. It simply corrects a mistake that we made last year. So, with that, I would ask for advancement of the bill.

PRESIDENT: Thank you. Senator Wesely, please.

SENATOR WESELY: Thank you. Mr. President and members, I do acknowledge Senator Hartnett's help on this issue and, Senator Lynch, who previously had the bill last year that corrected some problems with the handicapped parking plate issue. As you probably know, because many of you co-signed a bill, LB 150, it would have provided for two or more extremities lost to provide for this handicapped license plate. There is a Mr. Moore who, in Lincoln, came to me, actually a few years ago when we got that in in the first place and then inadvertently it got taken out through the bill last year and we were under LB 150 taking care of that problem. If you recall, he had lost both arms and was unable to handle the change to put in the parking meter and February 15, 1989 LB 214, 516

here he was getting parking tickets and it was an awful situation. Senator Hartnett took that concept one step farther and now we're providing if you have one or more extremity, where we were talking about two or more extremities, you would be able to get these sort of parking permits. And I don't have any problem with that. I think it takes care of that original problem that we were addressing and it expands the number of people that can be helped by this. Obviously, we're trying to help these individuals when they have a difficulty and they've lost an extremity to be able to access shopping or business or whatever they need. And so I do commend Senator Hartnett and the committee and look forward to seeing this bill pass so we can take care of this problem and meet that concern that we have had since the bill passed last year. And I would support the bill.

PRESIDENT: Senator Rogers, please.

SENATOR ROGERS: Mr. President and members, I also wish for the advancement of this bill. I have two constituents in my district that have no arms whatsoever. They will be real elated to see something like this passed. I...to make a comment, I thought it was real ridiculous that someone in the Motor Vehicle Department couldn't have given these people some temporary permits but they wouldn't do it so with this bill they're problem should be taken care of. Thank you.

We dealt with it. It just deals with the issue of what form that placard can take. I had...the bill was LB 240 that I introduced, and if you want to open your bill book, the amendment that I offer is identical to the underlying green copy of LB 240. It simply changes the provision for the type of placard that can be used to designate one is driving a vehicle that is eligible for a handicapped parking space. If you're familiar with what is used in many parking facilities when you buy a monthly pass to park in, say, for example, a lot either here in Lincoln or in Omaha and some other areas, they offer you a little cardboard hanging type of device that you hang from your rearview mirror. The attendants can go by, see whether or

not that car is eligible to be in that spot. All we do here through this amendment is allow for the handicapped designation to be placed in that same form, be used in that same manner. It allows for the individual to readily move that from car to car because the handicapped accessibility is not limited to the car, but it travels with the individual. So it makes it much more easier for those individuals to be able to stick that into a purse, into a coat pocket, be able to move it around. The current placard is one that is approximately 11 by 14 inches and this would allow for some ease for those individuals who need to be able to use the handicapped spaces that are available. T would urge the adoption of the amendment.

PRESIDENT: Thank you. Senator Hartnett, please.

SENATOR HARTNETT: Mr. President, members of the body, I think Senator Hall...we did vote, have both bills, 516 and 240, the same day.
