Would you folks please stand and be recognized. Thank you for visiting. We are glad to have you. Mr. Clerk, more bill introductions, please.

CLERK: Mr. President, first of all, your Committee on Urban Affairs, whose Chair is Senator Hartnett, to whom was referred LB 53, instructs me to report the same back to the Legislature with the recommendation that it be advanced to General File; LB 57 General File; LB 123 General File, all signed by Senator Hartnett as Chair of the committee.

SENATOR HEFNER PRESIDING

SENATOR HEFNER: Mr. Clerk, do you have some more bills to introduce?

ASSISTANT CLERK: Yes, I do, Mr. President. (LBs 558-593 read for the first time by title. See pages 273-81 of the Legislative Journal.)

SENATOR HEFNER: Do you want to read the bills into the record?

CLERK: Yes, Mr. President, thank you. (LBs 594-597 read for the first time by title. See page 281 of the Legislative Journal.)

Mr. President, in addition to those items, I have new resolutions. (Read a brief explanation of LRs 8-12. See

SPEAKER BARRETT: Thank you. The Chair recognizes Senator Baack.

SENATOR BAACK: Yes, Mr. Speaker and members, in an effort to be accommodating I'll just simply withdraw this and we'll deal with the issue of the return date, straight up front with Senator Warner's amendment. We'll just do that. I'll just withdraw this portion of the amendment.

SPEAKER BARRETT: Thank you, sir. It is withdrawn. To the next motion, Mr. Clerk.

CLERK: Mr. President, may I read some items?

SPEAKER BARRETT: Proceed.

CLERK: Senator Weiing has some amendments to LB 54A to be printed. Revenue Committee reports LB 566 to General File; LB 403, indefinitely postponed; LB 404, LB 599, LB 787, indefinitely postponed. New A bills. (Read LB 487A, and LB 488A by title for the first time.) Senator McFarland would like to print amendments to LB 437, Mr. President. (See pages 1324-25 of the Legislative Journal.)

The next amendment I have, Mr. President, to LB 340 is by Senator Baack. Senator, I have AM837 in front of me.

SENATOR BAACK: Yes, that's correct.

SPEAKER BARRETT: Senator Baack, please.

SENATOR BAACK: This is simply a clarifying amendment at the request of the Department of Roads, which sets out a definite procedure for the Department of Roads in case they're in the middle of a construction project and come across some unmarked remains. And it just sets forth a procedure that they will follow so that they can get it done as quickly as possible and

SENATOR LANDIS: Thank you, Mr. Clerk. Senator Wesely, to open on 722.

SENATOR WESELY: Yes, Senator Landis, members of the Legislature, 722 is a bill brought to me by the Commission on Law Enforcement. It's a bill coming out of a study that we did and actually a hearing in Senator Bernard-Stevens' district in North Platte dealing with crime reporting. We were concerned about drugs and youth problems dealing with alcoholism and drugs and one of the things we found was poor statistics in trying to analyze the problem because we have a voluntary reporting system. This makes it a mandatory system so we have a better grasp on what's happening with law and criminal activity in the State of Nebraska and I finally add that this is the only bill I had in Government Committee that came out alive. It must be a good piece of legislation. I'd ask for your support.

SENATOR LANDIS: Thank you, Senator Wesely. There are no lights on. Closing, Senator Wesely? Let's proceed then to a vote on LB 722. Those in favor vote aye, those opposed vote no. I should tell you, Senator Ashford, that Senator Kristensen threatens to leave and take Jennie Robak as hostage, destroying the quorum before your bill comes up. The Clerk will record. Senator Schellpeper, for what purpose do you rise?

SENATOR SCHELLPEPER: A point of personal privilege. I would move that we adjourn until Monday morning at 9:00 a.m.

SENATOR LANDIS: We need to record the vote from the last one, so will the Clerk read the record from the last vote.

ASSISTANT CLERK: Yes, there were 26 ayes, 0 nays, Mr. President, on the motion to advance the bill.

SENATOR LANDIS: We'll take a voice vote on this. Those in favor say aye. Those opposed no. We are not adjourned. Senator Ashford, and we'll have LB 566. Mr. Clerk, the history of the bill, please.

ASSISTANT CLERK: Mr. President, 566 was introduced by Senator Ashford. (Title read.) The bill was read for the first time January 18, was referred to the Revenue Committee which placed the bill on General File.

SENATOR LANDIS: Senator Ashford.

SENATOR ASHFORD: It's great to have so much support. I will read to you about LB 566. It's a short... In 1985 Governor Kerrey brought to the Legislature, LB 715, a bill to eliminate unnecessary sales tax exemptions. One provision was a repeal of the occasional sales tax provisions. And after the bill went into effect, the tax commissioner realized that a portion of these occasional sales were left out...they were still, in effect, were left out of the bill, and in an attempt to clarify the problem, the Revenue Committee in LB 715 set the date at January 1, 1986, for the effective date of the act when, in fact, the intent was to set the date at October 1, 1985. And in an effort to clear up the occasional sales that occurred between October 1 and January 1, LB 566 sets the effective date to October 1, 1985, which was the original intent of the committee. With that, I would move the advancement.

SENATOR LANDIS: Thank you, Senator Ashford. There is a light. Senator Haberman, followed by Senator Wesely. Senator Haberman.

SENATOR HABERMAN: Mr. President, members of the body, would Senator Ashford yield to a question?

SENATOR LANDIS: Senator Ashford, would you yield to a question?

SENATOR ASHFORD: Sure.

SENATOR HABERMAN: Senator Ashford, as I look at this yellow sheet and I look at LB 566 it says redefines the term occasional sale. I would like to have your word, Senator Ashford, that in that definition and in this bill, there is absolutely nothing that pertains to firearms.

SENATOR ASHFORD: Really? Oh, I see, that was the question. Absolutely nothing, unless it's an amendment. I don't think there is anything about firearms in this bill, Senator Haberman.

SENATOR HABERMAN: Thank you, Senator Ashford.

SENATOR LANDIS: Thank you, Senator Haberman. Senator Wesely.

SENATOR WESELY: Yes, Senator Ashford, the fiscal note talks about \$557,000 of sales tax assessments on the bill. Are you trying to just basically say there is some oversight and you're

trying to correct the dates, or what kind of...

SENATOR ASHFORD: What happened was the committee was, when this originally, when LB 516 came up in front of the Revenue Committee, Senator Johnson...or LB...I'm sorry, 715, it was represented to the committee that there were no occasional sales between October 1, 1985 and January 1, 1986 that would be covered by this change and then what happened now is the Department of Revenue has gone back and found some. And the original intent was that it would...those occasional sales would not be affected. Had that understanding been clear, the date, according to Vard Johnson in his letter to the committee, the date would have been placed at October 1, 1985.

SENATOR WESELY: Oh.

SENATOR ASHFORD: Rather than January 1, 1986. There was some confusion on the date and the department's intention in collecting occasional sales. It was their understanding, the committee's understanding that they would not collect on any occasional sales after October 1, 1985, and, in fact, the bill refers to January 1, 1986, as it was originally drafted.

SENATOR WESELY: So there is no revenue loss because it was never intended to happen.

SENATOR ASHFORD: It was never...there was never intended to be collected in the first place.

SENATOR WESELY: And so if we didn't do this, what do we do, go back on these people and ask them for money in '85?

SENATOR ASHFORD: Yes, we did, yeah.

SENATOR WESELY: Gee, okay, thank you.

SENATOR LANDIS: Senator Ashford, to close.

SENATOR ASHFORD: I'd move the advancement.

SENATOR LANDIS: I believe the cable television cameras still are on even at this late hour. Senator Ashford, to close.

SENATOR ASHFORD: Yeah, I would move the advancement of the bill.

Amendments to be printed from Senator Rod Johnson to LB 78; Senator Chambers to LB 399; Senator Chambers to LB 220 and Senator Hall to LB 371. (See pages 1416-21 of the Legislative Journal.) And that's all I have, Mr. President.

SENATOR LANDIS: Thank you, Mr. Clerk. The Chair recognizes the distinguished senator from northeast Nebraska, Frank Korshoj.

SENATOR KORSHOJ: Mr. Chairperson, I move that we adjourn until April 3rd at 9:00 a.m.

SENATOR LANDIS: You've heard the motion. Those in favor say aye. A machine vote has been called for. Those in favor vote aye, those opposed vote no. Somebody must have heard about a party. I've got a whole sheaf of bills. Just wait for a second and I'll go down to my office and get them and we can stay in session. The Clerk will record.

ASSISTANT CLERK: 23 ayes, 1 nay on the motion to adjourn, Mr. President.

SENATOR WESELY: Thank you. Senator Rogers, we have not discussed this amendment whatsoever. I did make a motion to amend a bill, and pull a bill out of committee, and I have withdrawn those with the intent of trying to...actually I was going to try and amend Senator McFarland's bill when it was on Select File so it wouldn't give you a problem with your piece of legislation. But, unfortunately, his bill didn't proceed and yours did. I'm not...I think it's a legitimate issue and it does cover both the act. It is a different purpose, but why can't we understand that there is a melting of these issues. If we're, on the one hand, trying to expand the credits and increase the credits, isn't it fair to ask that we can't consider, at least consider an amendment to increase the accountability and disclosure of those credits? I think it all ties in together, and I would ask your support to overrule the germaneness ruling of the Chair.

SPEAKER BARRETT: Thank you. The question is, shall the Chair be overruled? Those in favor vote aye, opposed nay. A majority of those present required to overrule. In this case the magic number is 21. Have you all voted? Have you all voted? Record, Mr. Clerk.

CLERK: 8 ayes, 15 nays, Mr. President, on the motion to overrule the Chair.

SPEAKER BARRETT: Motion fails.

CLERK: Mr. President, Senator Wesely would move to suspend the germaneness rule so as to permit consideration of AM1209.

PRESIDENT: Thank you, Dr. Lundell. We appreciate your message this morning. Roll call, please. Record, please.

PRESIDENT: Okay. We'll move on to LR 70.

CLERK: Mr. President, LR 70 has been offered by Senators Ashford and Moore. It's found on page 1476. (Read brief summary of resolution.)

PRESIDENT: Senator Ashford, please.

SENATOR ASHFORD: Thank you, Mr. President and members. Last year we passed legislation which authorized the profession of

PRESIDENT: Senator Lindsay, please.

SENATOR LINDSAY: Mr. President, I move that LB 566 as amended be advanced to E & R for Engrossment.

PRESIDENT: You have heard the motion. All in favor say aye. Opposed nay. It is advanced. LB 272A.

CLERK: Mr. President, 272A, I have no E & R amendments. I do have an amendment pending by Senators Landis, Schimek, Chambers, Warner, Wesely, Hall, Labedz, Crosby and Lynch.

PRESIDENT: Senator Landis, are you going to handle that? All right. (See amendment found on page 2537 of the Journal.)

SENATOR LANDIS: Mr. Speaker, members of the Legislature, this amendment, which appears in your Journal at 2537, is a \$33 million bill. It takes its appropriation over two years, about \$16.5 million in each of two years. It is for the reimbursement of depositors at American Savings, State Securities and Commonwealth. It's my hope that we will not burden the body with a lengthy debate and that we can dispense with this issue before twelve, noon. The case for these institutions has been well made, and I know that there are those who oppose them as well. In this period of time, that we call the crunch time, the Legislature ultimately sets priorities. And I ask you to look at the people to whom this state has turned with a welcome and supportive eye. They have included a great many people on the green sheet, lots of individuals in need, certainly, lots of institutions which want to expand their bricks and mortar, a lot of programs that want to expand their budget. I do not decry the people on the green sheet, they represent human need in many forms. But there is no place on that sheet that I can identify that the human need is as crying, as legitimate as the suffering of the people who have had their life savings defrauded from them over time through these financial institutions and through the negligent management, in my estimation, by the State of Nebraska. There can be no doubt, we are not under a court order, we are not obligated to pay this money under a court direction. This Legislature has repeatedly in the past chosen, however, to appropriate money where need existed without a court order. We've certainly done it when there was no chance of state liability. In the case, for example, of Joe Soukup, where several years ago with an individual who we had hospitalized and treated with experimental drugs, and basically continued them in an institutional lifestyle without proper authority, where the statute of limitations (inaudible) and Joe had no legal right to pursue the State of Nebraska for recourse, this Legislature voted recourse
