If savings in premiums can be made by including such properties under the policies of a municipality, that is so much for the better for taxpayers. At any rate, whatever the reason for an airport authority not securing insurance on their own, it is clear that when a municipality secures insurance for an airport authority, that its cost should be paid by that airport authority. This bill is necessary since it is important to protect the municipality and taxpayers of a municipality when an airport authority does not
