SPEAKER BARRETT: Is there discussion on the advancement of the A bill? If not, those in favor of the advancement of LB 44A, please vote aye, opposed nay. Please record.

CLERK: Mr. President, LB 637 was a bill introduced by Senator

Baack. (Read title.) The bill was introduced on January 19, referred to the Government Committee. The bill was advanced to General File.

SPEAKER BARRETT: Would you care to explain your bill, Senator Baack?

SENATOR BAACK: Yes, Mr. Speaker and members, the bill is a very simple one, not that it doesn't make a major change, but it's a very simple bill. What the bill does is it eliminates our existing provision that allows for payment of statutory individuals who are circulating statewide initiative referendum petitions. And the reason that this change is necessary is that the U.S. Supreme Court in Meyer v. Grant held that states may not prohibit such payment and the Nebraska statute differs a little bit from the one that was in the Meyer v. Grant but the Nebraska Supreme Court has also held that this provision in our law is unconstitutional. And I think that, result of these rulings and the fact that the U.S Supreme Court would probably rule Nebraska's statute unconstitutional, we simply need to remove this prohibition in our statutes to remove a cloud out there for people who are circulating They don't know whether it's legal or illegal and I petitions. think that it's been shown by the Supreme Court that this unconstitutional to do, to have this prohibition, so, therefore, ought to remove this cloud in our law. We ought to simply eliminate this right now. I think Senator Withem is going to have an amendment to this that calls for a little bit of regulation of these...of these circulators so that there is some reporting mechanisms in there so we do have some regulation. The Government Committee is also looking at this issue very closely and probably will be coming in with a bill that tries to deal somehow with payment of petition circulators and so that somehow we can have some regulation of the way that circulators are paid. And so we are looking at that. But I think right now we just simply need to remove this from our law because it unconstitutional. Thank you.

SPEAKER BARRETT: Thank you. An amendment on the desk.

CLERK: Mr. President, Senator Withem, you had an amendment on page...an earlier amendment, Senator, I understand you want to withdraw that one.

SENATOR WITHEM: I want to run AM0878, the one...

CLERK: Yes, sir.

SENATOR WITHEM: ...that was printed separately and withdraw the other one.

CLERK: Yes, sir.

SENATOR WITHEM: Okay.

CLERK: Mr. President, Senator Withem would move to amend. (The Withem amendment appears on page 1191 of the Legislative Journal.)

SPEAKER BARRETT: Senator Withem.

SENATOR WITHEM: First of all, I would stand to reiterate what I am one who philosophically am opposed Senator Baack said. very, very strongly to paying circulators for petitions but that's not the issue. I guess the only thing I would differ with what Senator Baack said, he said this bill makes a substantive change. The bill really puts the statutes in line with the change that the courts have already made for us and we have to pass the bill. But if we are going to have paid circulators, I think that there are some restrictions we need. filed two amendments, one of them probably a little more controversial than we want to deal with on consent calendar that deals with circumstances around which petitioner...a a circulator can be paid. That's the amendment I have withdrawn. The other one is another bill that had been introduced by the Government Committee. The committee...and I am a member of that we decided to just advance one bill and do our arguments and discussion about the petition process around this this particular bill was killed by the particular bill. So committee. It was a friendly kill motion as opposed to an unfriendly kill motion. It was a bill, LB 524, had absolutely no opposition. A large number of people, if you want to look in your bill books, did testify in favor of it. All it does is establish accountability and disclosure reporting procedures for petition campaigns. The rationale is that if this process is one that is available to people that can raise large sums of money, can hire circulators, put them out on the street, get petitions, get issues on the ballot, that we ought to have, citizens, the same access to knowledge about who these people are, where their funds are being raised, how they're spending

their money, who is contributing that we have to other campaigns. It establishes the reporting procedures then with accountability and disclosure statements, I think, basically the same type of procedures that any of us have to follow when we run for public office. So I would urge you to accept this amendment and will respond to any questions.

SPEAKER BARRETT: Thank you. Discussion on the Withem amendment. Senator Wesely.

SENATOR WESELY: Thank you, Mr. Speaker, and members, and I know time is running out. I would rise in support of the Withem amendment and also indicate my unfortunate recognition that we have lost the right to ban the payment of circulators of petitions. I just think that is absolutely wrong, runs counter to the concept and I wish...I don't know if there is any options we have other than the constitutional amendment. Evidently, we don't have any. Senator Baack, could you respond to that? Is there any options this Legislature has to get back at that issue?

SENATOR BAACK: The Government Committee is looking at a number of options and I had proposed a couple of ones but, you know, they're just...they're in the initial stages. We're looking at what some other states are doing to deal with this and some other states have some constitutional things they are doing dealing with payment of circulators. We're looking very seriously at those.

SENATOR WESELY: When we're talking about a constitutional problem we're not talking about a state constitutional but a national...

SENATUR BAACK: Yeah, the U.S. Supreme Court ruled that states simply do not have the right to prohibit payment.

SENATOR WESELY: Which really limits our options, obviously, so...

SENATOR BAACK: It does.

SENATOR WESELY: Senator Withem, could I ask one question of you?

SPEAKER BARRETT: Senator Withem.

SENATOR WESELY: When we had...this bill deals with petitions and the financial disclosure information, I'm trying to think of other...have you looked at other disclosures? I'm trying to think now, out of state, does this cover out of state contributors as well as in state? Because...

SENATOR WITHEM: I believe...I believe what the amendment does is it references Sections 49-1459 through 1462 that applies the same reporting requirements that you have to file, that I have to file. If we get a check...

SENATOR WESELY: Oh ...

SENATOR WITHEM: ...for \$200 from an out-of-state contributor, yeah, we have to report that. It applies, makes those same reporting procedure requirements apply to campaigns to put a ballot...a question on the ballot.

SENATOR WESELY: What about after it's on the ballot? For instance, on the 402 or I can't remember what that was called on the waste site.

SEN!.TOR WITHEM: After it's on the ballot, the first campaign statement shall be filed not later than 55 days before the deadline for filing petitions with the Secretary of State. Second, campaign statements shall be filed not later than the deadline for filing petitions. Final campaign statements shall be filed not later than 30 days after the deadline for filing. So there is these procedures set up for reports as the process goes on.

SENATOR WESELY: Okay.

SENATOR WITHEM: And if the filing...and if the deadlines...after you look at the deadlines and you think they need to be more reports, fewer reports, at different times, we can sure talk about that.

SENATOR WESELY: Okay, I would like to work with you on that. Thank you. I would support the amendment.

SENATOR DIERKS: Mr. Speaker and members of the body, we discussed this amendment a little bit yesterday so you have an idea of what we're talking about. This amendment requires voter approval by citizens of a county prior to the issuance of a license to site a facility. It seems a little bit strange to me that I have to stand here to justify this requirement, this requirement of local election, for specific reasons which I think are obvious, they're obviously consistent with Nebraska's traditional philosophy of local control, sovereignty of our citizens. More specifically, I believe the state made a pledge
