Mr. President, I have a report and a motion by the Appropriations Committee regarding the Nebraska Energy Settlement Fund. That report is filed pursuant to statute.

Mr. President, your Enrolling Clerk has presented to the Governor bills read on Final Reading this morning as of 10:00 a.m. (Re: LB 342, LB 114, LB 221.)

A new A bill, LB 183A by Senator Baack. (Read for the first time by title.) A new resolution, LR 37 by Senator Korshoj. (Read brief explanation.) That will be laid over, Mr. President. (See pages 857-58 of the Legislative Journal.) That is all that I have at this time, Mr. President.

SPEAKER BARRETT: Mr. Clerk, proceed to General File, LB 357.

CLERK: LB 357, Mr. President, introduced by Senators Nelson, Smith, Schellpeper, Coordsen. (Read title.) The bill was introduced on January 11, referred to the Education Committee. The bill was advanced to General File, Mr. President. The Legislature on February 8 considered the bill. At that time committee amendments were adopted. There was an amendment to the bill by Senator Nelson. That was adopted. Mr. President, Senator Withem then bracketed the motion until February 22. I do have amendments pending, Mr. President.

SPEAKER BARRETT: Senator Nelson, I wonder if perhaps we could go to you first for a very short refresher on the bill to bring us up to speed. Would you do that, please?

SENATOR NELSON: Thank you. I would be pleased to do so. As it was noted, LB 357 was bracketed when it was brought to us about a week ago, and we finally, I guess, got to it today. There were two main concerns. Actually, first, I will start and tell

opposed vote no. Well, we've been at this now for about a minute and a half. Clerk will record.

ASSISTANT CLERK: 25 ayes, 0 nays on the advancement of the bill, Mr. President.

SENATOR LANDIS: Thank you. The motion carries, the bill is advanced. LB 695 is next, although Senator Hannibal is not present. Senator Lamb, apparently, will be carrying the bill for Senator Hannibal. Mr. Clerk.

ASSISTANT CLERK: LB 695 was introduced by Senator Hannibal. (Read title.) The bill was read for the first time on the 19th of January, was referred to the Transportation Committee. They report the bill back to General File, Mr. President.

SENATOR LANDIS: Thank you, Mr. Clerk. Senator Lamb, to open on Senator Hannibal's LB 695.

SENATOR LAMB: Thank you, Mr. President and members. This is a bill that Senator Hannibal asked me to handle today. It did come through the Transportation Committee. It's a very simple bill that states that the...provides that travel trailers and recreational trailers with a gross loaded weight of 3 to 6500 pounds shall be equipped with brakes upon at least two wheels. Currently the statute provides that travel trailers and recreational vehicles having a gross loaded weight of 2,000 pounds or more shall be equipped with brakes upon each wheel. This is designed primarily for boat trailers. I understand that this brings us in line with other states, that this does not provide a safety hazard, that no one opposed the bill. And I would just ask, Mr. President, that the bill be advanced.

SENATOR LANDIS: Thank you, Senator Lamb. There are no lights on. Would you like to close?

SENATOR LAMB: Waive closing.

SENATOR LANDIS: With a waiving of closing, we'll proceed then to the vote on LB 695 to advance. Those in favor vote aye, those opposed vote no. Please return to your chair and vote either for or against the measure so that we may proceed with the rest of consent calendar. Clerk will record.

ASSISTANT CLERK: 25 ayes, 0 nays on the advancement of the

bill, Mr. President.

SENATOR LANDIS: Thank you, Mr. Clerk. The motion carries, the bill is advanced. Before we proceed to LB 392 and Senator Baack, I'd like to announce that Senator Nelson has a number of guests in the north balcony, 46 fourth graders from Stolley Park School in Grand Island and their teacher. Children, if you'd stand up, we'd like to recognize you and welcome you to the Nebraska Legislature. Thank you. With that, Mr. Clerk, 392.

ASSISTANT CLERK: Mr. President, LB 392 was introduced by Senator Baack. (Read title.) The bill was read for the first time on January 12, was referred to the Education Committee. They report the bill to General File, Mr. President.

SENATOR LABEDZ PRESIDING

SENATOR LABEDZ: Senator Baack.

SENATOR BAACK: Yes. Madam Chairman and members, LB 392 is a bill that is introduced to require if we're going to issue...as we issue future teacher certificates and administrator certificates it would require those people to complete at least three semester credits in special education. This does not necessarily require that a...that the college of education would provide for a separate course in special education, this requirement could be met by providing some instruction within the present course work dealing with special education. We find now that approximately 90 percent of all the school age children in Nebraska that are identified as handicapped, in one way or another, are educated in the regular classroom. And with this...as a result of this mainstreaming, we are finding that the regular classroom teachers are responsible for a lot of the education for these handicapped students. So what this bill does is it puts us in line with 33 other states that already require this. Our teachers now that are certificated in Nebraska, if they went to have a reciprocal agreement with a number of other states, would not be able to be certified in those states because they do not meet the requirement for special education certification. What it would do...What it does is it says that, if we're going to teach all these children in a regular classroom, then these teachers ought to have some awareness of the special problems that these handicapped students require and some of the special needs that they have in learning the basics that we have in the classroom. Mr. President, the next bill is LB 705. The first order of business are adoption of Enrollment and Review...consideration of Enrollment and Review amendments, Mr. President.

SPEAKER BARRETT: Senator Lindsay, please.

SENATOR LINDSAY: Mr. President, I move that the E & R amendments to LB 705 be adopted.

SPEAKER BARRETT: You heard the motion to adopt the E & R amendments. Those in favor say aye. Opposed no. Carried. They are adopted.

CLERK: Mr. President, Senator Moore would move to indefinitely postpone the bill. Senator Lindsay would have the option to lay the bill over, Mr. President.

SPEAKER BARRETT: Senator Lindsay, your wishes.

SENATOR LINDSAY: We will take it up.

SPEAKER BARRETT: Take the bill up, thank you. Senator Moore.

SENATOR MOORE: Mr. Speaker and members, as you all remember, LB 705 is the bill that basically has the state giving a gift of about \$200,000 to Joslyn Art Museum down in Omaha, and I'm going to ask Senator Hall a question as I want to say this I have got

SPEAKER BARRETT: Thank you. I'd like to take this opportunity to announce that we will move over LB 247 at this point, and also 588, I believe. Senator Chambers, are you within listening distance? I don't believe Senator Chambers is here, his office doesn't answer, and I did have a discussion with him recently about perhaps moving over this one for a day or so. If there is no objection, I'd like to address LB 710 at this point. Mr. Clerk.

CLERK: Mr. President, LB 710 was introduced by Senators Scofield, Lamb and Dierks. (Read.) The bill was introduced on January 19 of this year, referred to the Natural Resources Committee for public hearing. The bill was advanced to General File. Senator, would you like to offer your amendment now, or would you defer until you open on the bill?

SPEAKER BARRETT: Senator Scofield.

SENATOR SCOFIELD: Why don't I...I think if I can offer the amendment, I'll open at the same time, Mr. Clerk.

CLERK: Mr. President, Senator Scofield would move to amend her bill. (Scofield amendment appears on pages 1561-62 of the Legislative Journal.)

CLERK: Mr. President, if I might, one quick interruption, LB 213 and LB 695 were reported correctly engrossed. (See page 2575 of the Legislative Journal.)

Mr. President, the Legislature last considered LB 525 on May 17. At that time, Senator Withem had an amendment pending. The Legislature was considering that. Senator Scofield then moved to bracket the bill, Mr. President. That motion prevailed. Consequently, Senator Withem's amendment that is on page 2497 is now pending. Senator, this amendment would strike 18 million and insert 98 million.

SPEAKER BARRETT: Senator Withem.

SENATOR WITHEM: Yes, we will...let me talk about that just a second. This amendment was filed the other day when LB 84 was still property of the Legislature and was...the number \$98 million was in that bill so under the theory that a little state aid does a little bit of good, I filed this amendment that a lot of state aid would do a lot of good and see where people were coming from on that whole thing, and maybe it makes as much sense that there is \$98 million out in the budget as opposed to
